Dear Members of the Body,

The purpose of my comment is to voice my concerns about the appointment of Jason Hardin for the HRC. I believe that appointments for such a committee should be taken seriously and the person chosen should be above reproach.

I have had the opportunity to see first hand how Mr. Hardin conducts himself in public, on the debate stage for the Pasadena Mayoral run and his current social media presence. He has always been vocal about his incarceration from 3 years ago for domestic abuse and violence.

I have found that his conduct in public and on Social Media to very contrary. Both his public and social media presence reflects who he is and what to expect of his behavior, if in office. Disappointingly, I have seen behavior from Mr. Hardin that was inappropriate, abusive and completely unprofessional. These are the specifics as to why, I believe, Mr. Hardin does not have the temperament or the professionalism to hold such an office.

- Mr. Hardin has admitted to having a personal vendetta towards a current committee member. Over the months he has been belligerent, accusatory and divisive towards Victor Gordo. Regularly airing his grievances laced with profanity and insults. Some comments have been so egregious that moderators removed the posts.

- It was unacceptable how, 2 weeks ago, Mr. Hardin felt that it is appropriate to publicly disrespect our law enforcement. Mr. Hardin titled a public conversation "Fuck the Police" directed towards out our Pasadena Police Department. Then proceeded to accuse and stoke anger towards the department and the officers serving our community. The moderator for the FB Politics page also removed the abhorrent post.

- Mr. Hardin has shown that he lacks level-headedness to engage in a heated debate or disagreement, especially with those who have opposing views or adversarial criticism. He instead chooses to be disrespectful, profane, accusatory and dismissive.

I strongly believe that some committee positions should not be afforded to those with a history of violence. This applies, especially, for those who continue to show this type of unacceptable behavior. Our city deserves a person who will be capable of having a honest conversation and conduct themselves with integrity when subjects are brought up that they are not comfortable discussing. A person who builds a bridge not burns it down. An olive branch.

My concerns is if we appoint Mr. Hardin, with a background of violence who shows us that he is clearly unfit for a HRC position, what else are we going to overlook for future City positions? Will we be expected to afford the same to others with worse transgressions, conflicts of interests and backgrounds going forward? Our great

- 2) According to the City Attorney's Office, the arrest involved Hardin's live-in girlfriend. The charges indicate she had visible injuries and Hardin allegedly also injured an officer while resisting arrest, according to Rivera. The resisting arrest charge was dropped in the plea deal.
- 3) Hardin pleaded no contest to one misdemeanor charge of domestic battery with injury on May 11. The Pasadena City Attorney's office dropped two additional misdemeanor charges of criminal threats and resisting arrest in exchange for the plea, according to Will Rivera, chief assistant city prosecutor.
