I want to thank Mayor Tornek and the City Council for taking seriously the concerns of citizens who want an independent police auditor (IPA) with subpoena power. The tragic killing of Anthony McClain, only a couple of blocks from where Jill and I live, is another indication of the urgent need for a truly independent investigation of this and similar incidents The slickly produced critical incident report by PPD seems intended to exonerate police, not to impartially present the facts. It begs the question: why did the police shoot a man in the back who is running away? Why did they feel that he was such a public threat it was necessary to kill him? I urge you to approve an IPA as soon as possible, preferably one answerable to a city prosecutor to avoid conflict of interest. How can an attorney hired to defend the city from lawsuits also supervise an IPA who might support taking legal action in response to police misconduct? We need a truly independent IPA to assure the public of impartiality and fairness and to make certain that our police use a minimum of force, and only when absolutely necessary.
