I am a resident of District 6 and I am fed up with the systems that continue to disproportionately hurt and endanger my Black neighbors. I am glad that the city council is finally taking steps to hold our policing system to a higher standard.

I support the formation of a city- and police-independent civilian oversight board as a way to build accountability and trust between the Police Department and the public. As family ties or former employment in the PPD would create a conflict of interest, candidates having such ties should not be eligible to serve on the board. Further, there should be more than three board members who are not appointed by, and tied to council districts. Interactions between civilians and police are not divided equally over all communities or districts. Black and Latinx people are disproportionately impacted by the failures of our policing system in ways that were apparently not visible, or not a priority to other communities until now. As such, they need - and deserve - a louder voice on any board that would identify and address those failures.

Please vote YES on Vice Mayor Hampton's proposal to amend the city charter to allow a full-time Independent Police Auditor position with subpoena power. Thank you.
