With an average of three homeless folks per day dying on the street in LA, we can stop such tragic statistics in Pasadena before it happens again. I say again, because sometime between 1986-87 a man died of hypothermia on a Pasadena bus stop, motivating Joe Collette to help start the Bad Weather Shelter. I understand the challenges of COVID to keep the shelter open, but I believe we can and must do more. Please consider:

- 1. More Funds for motel vouchers beyond what the Housing Department is requesting
- 2. Expand Safe Haven to more churches, allow tents and suspend citations for makeshift shelters.
- 3. Make use of all vacant city-owned property, INCLUDING the reported 50 FEMA trailers at the Rose Bowl.
- 4. Permit Safe parking by allowing people to sleep in their cars overnight without citation and well as on church parking lots.

The city made tremendous efforts to work with our restaurant community to come up with creative, flexible solutions.
