As of January of this year, there were 527 homeless individuals in Pasadena and 4,479 homeless individuals throughout the San Gabriel Valley. And, these are the numbers pre-COVID. Currently there are just two winter shelters planned in the San Gabriel Valley, one with 15 beds in Hacienda Heights and one with 75 beds in La Puente. This still leaves thousands of people in need of shelter this winter in the San Gabriel Valley and hundreds of people in need in Pasadena. Please put yourself in the position of someone sleeping on the street this holiday season. Imagine the people spending their days and nights soaked in rain. There are solutions. Pasadena can allow tents and suspend citations of make shift shelters. Pasadena can fund motel vouchers. Pasadena can concert vacant city-owned property into temporary housing. Pasadena can work with LAHSA and Union Station to imagine a winter shelter here in Pasadena. And, Pasadena can create safe parking lots, or at the minimum not cite people who sleep in their cars.
