Dear Mayor Tornek and City Council Members,

As a resident of Northwest Pasadena, I've talked with many Black neighbors and friends who have experienced racial profiling such as Council member Hampton describes. I've been saddened and outraged by the deaths of Reginald Thomas and Kendrec McDade that occurred close to my home. I therefore urge you to support a police commission with real authority and subpoena power, as recommended in the June 2020 report of the U.S. Commission on Civil Rights, This report states that "Civilian Review Boards can be powerful tools in furtherance of police reform, but that to do so they must be vested with sufficient authority, subpoena power, and independence to have any effect." <https://www.usccr.gov/files/2020-06-19-USCCR-Supports-Justice-in-Policing-Act.pdf>. The experience of many cities show a police commission without real authority and subpoena power is useless and a waste of money.

Let the voters of our city decide on whether to approve a charter amendment to create a truly independent and effective police commission. The decision shouldn't be left up to elected officials, many of whom have received donations from the police union.

A police commission could be funded by implementing a program like CAHOOTs in Eugene, OR, that helps the mentally ill, homeless, domestic abuse victims, etc. in ways that are more cost effective and have better outcomes than sending in armed police. I heard about this program through Union Station and was very impressed. The police in Eugene, OR, love this program, and so do taxpayers since it saves money as well as lives. Reginald Thomas would probably still be alive if Pasadena had a program like CAHOOTs. Let's truly reform our police department so it works for all citizens of our city and sets an example for the rest of LA County!

My name is ----Julie McKune. My family lives in Victor Gordo's district. I am also a member of It's Us Now. I am alarmed by images of heavily armed police patrolling largely peaceful protests across the county – protests focused largely on cases of police abuse.

Councilmember Gordo was quoted as saying that “public safety is of utmost importance that has to be handled seriously and responsibly.” But he may be hard pressed to factually argue that large amounts of military grade equipment in the hands of police is a responsible way to keep the public safe. In 2019 researchers at Louisiana State University said that it is difficult to analyze the effectiveness of federal donations of equipment (known as the 1033 program) because “we don't have a very clear understanding what kinds of equipment actually are in the hands of these agencies.”

We do know that the Pasadena Police Department has received at least \$650,000 of federal military equipment from the 1033 program. My question to the council is: what else is there that we don't know about? As recently as June of this year, the city's Finance Department was reprimanded for its failure to properly audit accounting procedure at the Pasadena Police Department. Councilmember Gordo: how can you oversee the justification and use of equipment that may or may not exist? An independent auditor must be appointed to, among other things, oversee procurement of equipment, justification for, training on and policies on its use. A growing number of people are fast-losing confidence in the ability of government at all levels to keep them safe, healthy and secure, a country where justice for all prevails. Heavily armed, poorly trained police are no way to seriously and responsibly ensure public safety.
