The city spent \$400,000 on a no-bid contract for a police helicopter camera. Pasadena has an opportunity to model moving money from a large police budget to an investment in its community by adding city money to the rental fund.

Other questions/concerns:

- 1) The process drawn up in the Housing Department's report is labor intensive for the city's Housing Department, tenants, and even landlords.
- 2) Many long-term tenants are on month-to-month leases. Also, some properties include utilities in rent. What is the process for these tenants?
- 3) How is the city going to notify residents of the program? The city's notification system for recent tenant protections has been lacking—no mention of the COVID moratorium in ANY community mailers. None!! Please ensure wide notification from the city.
