Decisions on lifting Safer at Home orders and removing restrictions should be guided by health concerns, infection rates and resident safety specific to Pasadena but mindful of our entire region and its interconnectedness.

Decisions on opening businesses should include input from healthcare providers and public health officials. There is certainly a place for City staff as conveners, but real input has to come from business owners large and small, hotel and motel operators, tenants and landlords as well as institutions and event and venue operators. People who could suggest ways to mitigate economic impacts with rule waivers, regulatory adjustments or incentives.
