**CEREMONIAL MATTERS** 

Mayor Tornek requested that the meeting be adjourned in memory of those that have suffered due to death and illness caused by COVID-19 in Pasadena, the nation and around the world.

City Manager Mermell provided introductory comments, and Police Commander Jason Clawson presented a PowerPoint presentation on the item, including background information on the City's use of Automated License Plate Reader (ALPR); and responded to questions.

Councilmember Madison spoke on the need to access the information ALPR provides to solve and prevent crime. He also spoke on the need to adequately ensure that the information will not be misused, which is why the Public Safety Committee (PSC) recommended a limited two-year retention of the storage of data.

Councilmember Kennedy, Chair of the Public Safety Committee, provided information on the role the City's Community Police Oversight Commission would have in the matter; and provided a summary of the PSC's discussion on the item.

Councilmember Gordo expressed concerns with Vigilant Solutions ability to sell information gathered by ALPR to insurance agencies; and asked staff to ensure that the contract includes language to prevent data sharing to protect the integrity of the program and the community.

In response to Councilmember Kennedy's request for information, Michele Beal Bagneris City Attorney/City Prosecutor, stated that staff can seek to negotiate with Vigilant Solutions the privacy and limited use of the sharing of data collected to law enforcement agencies only.

City Manager Mermell provided introductory comments, and Dr. Kimberly Shriner with Huntington Hospital, provided a PowerPoint presentation on data related to COVID-19 throughout Los Angeles County and the City, including COVID-19 patients; and responded to questions. Dr. Ying-Ying Goh, Public Health Officer, provided information related to the number of COVID-19 cases and deaths, in the nation, state, county and City; information on the new State Health Officer orders framework, "Blueprint for a Safer Economy," risk factors related to Halloween, benefits of the flu vaccination, and responded to questions.

Following discussion, by consensus of the City Council, and on order of the Mayor, the information was received and filed.

- (2) Introduce an ordinance creating a Community Police Oversight Commission and Independent Police Auditor, and conduct first reading of the ordinance.

Michele Beal Bagneris City Attorney/City Prosecutor, provided introductory comments, and Javan Rad, Chief Assistant City Attorney, presented a PowerPoint presentation on the item, including amendments to the ordinance, and responded to auestions.

City Manager Mermell provided information on clerical staff that will report to the Community Police Oversight Commission (CPOC), and responded to questions.

Councilmember Wilson spoke in favor of providing CPOC members a stipend similar to what is provided to certain City commissioners; and asked that the City Council consider the option now or at a future City Council meeting.

Councilmember Gordo spoke in favor of a Management Analyst (MA) providing support to the Independent Police Auditor (IPA) and both, the MA and IPA jointly supporting the work of the CPOC.

City Clerk Jomsky reported that 4 letters expressing concerns related to the ordinance as drafted, and providing comments/suggestions were received from the following individuals:

He read aloud comments in support of an Independent Auditor and a transparent process on the make-up of the Community Police Oversight Commission, expressing concerns related to the ordinance as drafted, and providing suggestions from the following individuals:

Vice Mayor Hampton suggested that staff develop a process to appoint CPOC members, which includes individuals completing an application, an interview process by a community panel (made up of non-profits that have been engaged in civil rights and/or involved in police oversight advocacy), with the City Council able to appoint members from the recommended from the pool of applicants vetted by the community panel.

Mayor Tornek, member of the Public Safety Committee, summarized the Committee's discussion on the process of CPOC selection; and stated that the CPOC selection process will be by resolution and defined at future PSC and City Council meetings. He stated that it is his understanding that the term "non-profit community" referenced in the ordinance, includes community-based organizations.

Councilmember Masuda strongly advocated for 8 members of the CPOC to be nominated by each member of the City Council (one from each district and one at large by the Mayor), with the City Council to approve the nominations, as discussed in previous City Council meetings.

Councilmember Kennedy expressed concerns with excluding a CPOC applicant solely based on past employment (i.e. attorneys, police officers) and suggested applicants may be considered depending on length of time of past employment. He stated that he agrees that the non-profit community also includes community-based organizations.

Councilmember Gordo expressed concerns with excluding applicants who are police officers or have law enforcement backgrounds, as they may provide a different vantage point, insight, and world experience. He stated that he also agrees the non-profit community includes community-based organizations.

Councilmember Madison expressed concerns with the proposed ordinance, specifically the lack of description that the CPOC is an advisory commission. He spoke on the need for CPOC members to have training on confidentiality, attorney client privilege, and participate in the City's Citizen Police Academy. He also asked staff to clarify in the ordinance that each City Councilmember will make an appointment to the CPOC. Mr. Madison expressed concerns with Section 2.60.50, Absences and Vacancies that notes CPOC member with more than 3 consecutive absences from meetings may be removed and the City Council may declare the seat vacant, which he believes is not necessary. He also suggested that the City Council review all requests for subpoenas.

Councilmember McAustin spoke on the need for the ordinance to include a stronger statement of purpose for the CPOC that includes the CPOC reports primarily to the City Council; and that the CPOC is a community committee with oversight responsibility reporting to the City Council. In addition, she believes that the proposed

ordinance should be broad and the details related to the CPOC and IPA should be included in another document (i.e. resolution). She also advocated that the non-profit community appointees include the faith-based community/organizations. She expressed concerns with moving away from a transparency process; and spoke in favor of CPOC members made up of average individuals and spoke in opposition to the appointment of law enforcement employees (e.g. former police officers).

Councilmember Gordo stated that staff should review the rules and regulations of the City of Los Angeles' Civil Service Commission, and the Employee Relations Board to review their practices of subpoena requests, which are appealable to the Los Angeles City Council, and noted that the commissions have standings to go to court to defend their decisions. He stated that he believes the PSC and City Council should develop standards on the issuance of subpoenas.

Councilmember Wilson spoke in favor of simplifying the proposed ordinance and codifying the details related to the creation of the CPOC and IPA on a separate document, and in favor of developing a community panel to review applicants. He spoke in favor of considering applicants who served in law enforcement as CPOC members.

Vice Mayor Hampton spoke on the need to include unimpeded subpoena power to the IPA as part of the proposed ordinance; and spoke in opposition to the City Council reviewing the IPA's request for subpoenas. He also expressed concerns with police officers as CPOC members, which he believes may cause mistrust in the community.

Mayor Tornek summarized the City Council consensus that the term "non-profit community" organizations should be broaden to community-based organizations. In regards to Section 2.60.110, Purpose and functions, he recommends moving B. 1. "Review and make recommendations regarding the ongoing operations of the police department to the chief of police, city manager, and/or City Council" to section A; including a reference that there intends to be subpoena authority vested to the CPOC and IPA with details to be developed at a later date by resolution; and clearly define the appointment process (2.60.030: Membership — Appointment and terms.), such that each of the Councilmembers/Mayor shall nominate one member to serve as a CPOC member with details to be defined by resolution at a later date.

Michele Beal Bagneris City Attorney/City Prosecutor, confirmed that the City Council would like the CPOC model to emulate the City's traditional appointment process format, therefore, staff will make the following amendments to the ordinance:

- Remove under Section 2.60.030: Membership –
   Appointment and terms, Item A 1, the following verbiage,
   "...and each members shall reside in their respective district during their term"
- Under Section 2.60.030: Membership Appointment and terms, Item A 3, "non-profit community" will be replaced with "community-based organizations,"
- Under Section 2.60.110, Purpose and Functions, include Item B 1 with Item A to read as, "The purpose of the commission is to enhance, develop, and strengthen community-police relations, and review and make recommendations regarding the ongoing operations of the police department to the chief of police, city manager, and/or City Council"
- Under Section 2.60.110, Purpose and Functions, renumber Section B; and
- Under Section 2.610.120, Subpoenas, Section A, amended as, "Subpoenas issued by the Commission and/or the independent police auditor shall be subject to rules and procedures established by the City Council, by resolution."

In addition, Javan Rad, Chief Assistant City Attorney, reported the following clerical amendments will be made to the ordinance:

- Under Section 2.60.040, Qualifications, orientation, and training, Item C, include the word "currently" to read as, "Practicing attorneys who handle, or are members of firms or entities that currently handle..."
- Under 2.60.120 Subpoenas, Section A, a new item 6, to read as, "Be served in the same manner as subpoenas issued to nonparties in civil litigation under the California Code of Civil procedure to compel records and/or testimony."
- Under 2.60.120 Subpoenas, Section A, a new item 7, to read as, "Notify the served party that if the records are not produced or the testimony is not given, the subpoenaing party may apply to the City Council for an appropriate order or other remedy."
- Under 2.60.120 Subpoenas, Section B, remove the word "less" and replace with "more" to read as "within no more than five (5) calendar...."
- Under 2.60.120 Subpoenas, insert new Section C, "If the records are not produced or the testimony not given, the subpoenaing party may apply to the City Council for an appropriate order or other remedy." and

Under 2.60.030 - Membership - Appointment and terms, Item A, 2 to be amended to reflect that the Mayor shall nominate 1 member.
