CEREMONIAL MATTERS Mayor Tornek presented a proclamation declaring November 28, 2020 as "Small Business Saturday," in the City of Pasadena.

Mayor Tornek requested that the meeting be adjourned in memory of those that have suffered due to death and illness caused by COVID-19 in Pasadena, the nation and around the world.

<u>SPECIAL ITEM – COVID-19</u> COVID-19 UPDATE FROM CITY MANAGER AND PUBLIC HEALTH OFFICER

Steve Mermell, City Manager, provided introductory comments, and Dr. Ying Ying Goh, MD, Director of Public Health, and Dr. Matt Feaster, City Epidemiologist, reported on the COVID-19 pandemic, providing information on the number of cases and deaths, hospitalizations and ICU admissions occurring in Pasadena, as well as at state and national levels, with all responding to questions. Dr. Goh provided update on the State's limited Stay at Home Orders; and expressed concerns with the alarming rate of increased Covid-19 cases. Dr. Lori Morgan, President of Huntington Hospital, provided information related to COVID-19 patients at the hospital; and responded to questions.

Vice Mayor Hampton stated the following for the record, "That is also my hope, that we do not have to make a step that is detrimental to...as we had a ceremonial matter that was right before this... to our small businesses, not necessarily just to small businesses. But

also the people who work in these businesses, they need the jobs, they need work, they need to be able to continue to pay their mortgages, they need to continue to pay their rent. This I understand, you know it is very serious, but it is an economic...it's going to be an economic nightmare for the next three or four years and if the State is saying that you can still have outdoor dining...unless the State is telling us to close it, I would advise that the City of Pasadena continue, no matter what. At this point following the County is ... if the State says that we could do it [allow outdoor dining] that is what we should be doing. And if the State says we can't do it, well then OK, then that's the fight. We have our Health Department and I know that we've had this over and over and gone over this over and over again, but at this point unless you can track all...you know a significant amount of cases happening to people doing outdoor dining or in store shopping, you know Target or Walmart or small business. At the end of the day, what I see here happening is...this is an equity issue because people that are extremely wealthy are sitting and its fine for them because this is an economic boom for them. The Jeff Bezos' of the world...the Amazon's of the world, the Walmart's, the Target's. This is an economic boom for them, but for the rest of America, which is 47% as the Mayor mentioned employed by small businesses, are suffering. And everyone in government, no offense to Dr. Goh, and everybody and Steve, you guys are all getting a check. No matter we close down or not, the City [of Pasadena] is still paying people. That's not a shot at you. I'm just saving outside of the City, there are people that live in the City that make our City what it is, and if they cannot afford to live in our City, which they are already getting close to that because they are not able to work, then it's not Covid that has done this to us, it is government that his stifled people and forced them out of the City of Pasadena and closed businesses in the City of Pasadena. So unless the state is saving... I have to reiterate this... unless the state says that we need to close those businesses, we can't choose and pick because there is a surge. We have to let our businesses open and if you have to be more strict with our businesses and tell them, you know, they need to take a temperature every time somebody comes in, then do that. But we need to let our businesses open and they've invested a lot of money, a lot of money during Covid, and all of a sudden were going to tell them they have to close. And these people who don't know where they are going to get their next check from that live in our City. And now they have to go home and figure it out, potentially lose their homes. This is bigger...speaking of the deaths, imagine the mental...people will...I'm just saying...people will either continue to work and just say forget what was talked about at this point because the only right we have as Americans, is the right to work. That's a right and government does not have the right to tell me I can't work."

Councilmember Kennedy stated the following for the record, "Dr. Morgan did you say elective surgery are being continued? Share with us exactly what you stated." Mr. Kennedy spoke on the need to allow science and data to lead the City's actions; and asked the City Attorney to determine if the City Council has the authority to use Water and Power funds to provide some level of protective equipment to the public.

In response, Dr. Morgan replied that Huntington Hospital is within their capacity to manage the hospitals current patient volume, but if a surge becomes similar to the volume in March or July, the hospital will have to scale back in terms of surgeries.

Councilmember Madison spoke on the need for additional COVID-19 testing resources, and asked staff to provide information on the City's website related to COVID-19 testing locations. He spoke in favor of not imposing additional stricter regulations related to dining or any other segment of the City's economy; and requested that an emergency meeting of the City Council be scheduled prior to any decisions made related to imposing stricter regulations to the City's businesses. He also spoke on the need for the Health Department to be robust and aggressive, including provide funding for COVID-19 vaccinations to the public.

Councilmember Masuda asked staff to consider other options to help the restaurants, suggesting extending takeout hours.

Councilmember McAustin spoke on the need for the underserved community, which has been negatively affected the most by COVID-19, to be given some priority when it comes time to administer the COVID-19 vaccination.

Councilmember Wilson expressed concerns with the closing of City restaurants that would lead to individuals losing their jobs close to the holidays; and spoke on the need for creative thinking to keep restaurants open during the COVID-19 pandemic.

Councilmember Gordo requested that staff clarify the restaurant operating hours as there may be some confusion on that matter. He also asked staff to provide additional information on the percentage of current COVID-19 cases that are children under the age of 18 in the last week or two to determine data on the surge of COVID-19 cases. He asked staff to develop a COVID-19 vaccination distribution program taking into consideration the actions of the State and Los Angeles County related to the matter, suggested that staff provide an update to the Public Safety Committee. Councilmember Gordo requested that staff inform the Los Angeles County Board of Supervisors on the City's decision to assess data prior to closing restaurants in the City.

CONTRACT AWARD TO G TEAM LANDSCAPE CONSTRUCTION, INC., FOR LOWER ARROYO SECO HABITAT RESTORATION FOR AN AMOUNT NOT-TO-EXCEED \$484,998 Recommendation: It is recommended that the City Council:

(1) Find the contract proposed in the agenda report to be categorically exempt under the California Environmental Quality Act (CEQA) Guidelines in accordance with Title 14, Chapter 3, Article 19, Section 15301, Class 4 for minor alterations to land and Title 14, Chapter 3, Article 19, Section 15333, Class 33 for small habitat restoration projects; and

(2) Accept the bid dated, November 5, 2020, submitted by G Team Landscape Construction, Inc., in response to the Project Plans and Specifications for the Lower Arroyo Seco Habitat Restoration, reject all other bids received, and authorize the City Manager to enter into such contract for an amount not-to-exceed \$484,998 which includes the base contract amount of \$387,998 and a contingency of \$97,000 to provide for any necessary change orders. Councilmember Kennedy expressed concerns with the Arroyo Seco Habitat Restoration project, specifically the lack of removal of Eucalyptus and Canary Island trees as he believes the trees are not safe. He also requested that the vendor, G Team Landscape Construction, Inc., hire young residents of Northwest Pasadena to assist with work related to the contract.

In response to Councilmember Kennedy's request related to information on G Team Landscape Construction, Inc.'s principals, staff stated they would provide the City Council with a copy of the organization's Tax Payer Protection Act (TPA) form.

Vice Mayor Hampton echoed concerns related to the Arroyo Seco Habitat Restoration project, specifically the lack of removal of Eucalyptus and Canary Island trees, which he believes may cause damage to the area. Councilmember Kennedy spoke on the need to find resources (\$400,000-\$600,000, per unit) to build housing that is required in the City, and designated specifically for individuals who are categorized as "Extremely Low Income, Very Low Income, and Low Income."

Councilmember Gordo spoke on the need for the City Council to be bold as the City looks at future affordable housing opportunities in the City. He also spoke on the need for the City Council to appoint a commission to look at the complexity of affordable housing, made up of residents and professionals to help the City determine a legislative platform to advocate for additional affordable housing. He stated that the staff report is missing the retention of affordable

housing, and spoke on the need for the City Council and staff to address the issue of losing existing affordable housing stock.

Councilmember McAustin spoke on the need for the City Council and staff to continue to consider diversity related to affordable housing in the City and to also consider micro units.

Councilmember Wilson expressed concerns with the State's narrow view and approach to increase affordable housing by supersizing cities, and stated his preference that staff consider conversions, micro units, and land use conversions as methods to provide affordable housing in the City. He spoke in favor of a City commission that will be charged with focusing on the affordable housing issue.

Following discussion, by consensus of the City Council, and on order of the Mayor, the information was received and filed.

Vice Mayor Hampton recommended Mentoring and Partnership for Youth Development, Outward Bound Adventures, and Alkebulan Cultural Center organizations as participants in the Rose Program.
