The developer selection process lacks significant transparency and public involvement, which differs from other City selection processes like Heritage Square South which had a review committee, including community representatives.

Before approving staff's recommendations:

On the process:

- Provide written summaries for each proposed project and the credentials for each proposer.
- Provide the public with the selection criteria, scoring, weighting, and ranking of the proposals.
- Provide a summary and conclusions for all Economic Analyses performed; in particlar, Keyser Marston Associates' analysis.
- Provide the rationale for selecting the recommended developer.

On the ENA:

- List the obligations of the City and the Developer during the negotiation period.
- Provide that Affirmative Action and Local Contractor Participation Plans and/or requirements will be addressed during exclusive negotiations.
- Make public the proposed ENA document (without proprietary information) before its approval.

Without providing the information as outlined above, it appears that the City Council has preselected the Developer in Closed Session and this public process is a mere formality. The public's business should be done in public.

2. Is this property owned by Pasadena Water and Power? If so, has the recommended ENA been approved by the PWP Board for disposing of its property and have all other requirements been met?
