Thank you for the opportunity to comment on the proposal to build 3 homes on a wild, open hillside above my neighborhood. A storm drain runs through my family's property with rushing water and occasional mud and trash whenever rain falls on Inverness and nearby streets, down to the Arroyo Seco. Deer, bobcats, raccoons, opossum and other animals walk through our yard, up Linda Vista and into Cottonwood Canyon and St. Katherine's Canyon.

The proposed project will affect our neighborhood, and the potential loss of that open space concerns us. Open space is a priority in the master plan, maintaining beauty while supporting natural areas for wildlife corridors. I urge the council to require an EIR to advise of the impacts of hillside construction. If a sewer pipe has to be installed downhill through the open area to reach an existing main, what are the erosion impacts?

We respectfully request a full and complete "Environmental Impact Report" to review the following:

Hydrology: This area is drainage deficient and significant flooding, mudslides and damage continue to occur in this area.

To date mitigation is suboptimized. The city provided hill repairs and sandbags have not eliminated the impact of poor hillside drainage. We have experienced flooding and extensive damage to our property as well as compromised / dangerous road conditions on Inverness and Normandy. We have photographs that may be helpful in your review.

Other environmental / safety concerns include:

Fire safety: This area was impacted significantly by fires and recently the "Bobcat" fire that had the neighborhood in evacuation preparation for almost 3 weeks.

Construction and Traffic Management: Current projects in the area do not comply with regulations that have done damage to properties, roads, curbs and drainage.

Proposed development of St. Katherine raises the question: How will the community be protected from additional runoff since the property is located above a long-established neighborhood that experienced 19 water-related disasters during one 39-year period?

This unstable hillside area has a long history of landslides, mudslides, flooding, and collapses because it has no complete public storm drainage system. Over the years, collapses from the St. Katherine property have blocked Inverness Drive. During the rainy season, storm water and debris emanating from St. Katherine flow onto streets and private properties. Several years ago, the roadway of Inverness Drive collapsed at the "Z" switchback thereby blocking vehicle ingress and egress for months. A huge collapse affected homes on Inverness Drive and Crofton Way.

The proposed massive hilltop project with three mansions, outbuildings, pools, paved areas, and landscaping will increase runoff and heighten danger for properties and persons down slope. Staff are urged to scrutinize the proposal's lack of safe disposal of storm and landscaping runoff because it has the potential to cause serious property damage or personal injury to residents down slope. Hydrology and Geotechnical Reports are vital and should include data obtained during and after the rainy season.

As indicated in our LVAA letter, we strongly support the preparation of an Environmental Impact Report for the proposed project. This Project involves potentially significant environmental impacts which require analysis and potential mitigation. Among these is the Hydrology, drainage, and storm run-off situation in this part of Linda Vista.

Not all current staff or Councilmembers may know that this hillside area was developed with no storm drains -- a situation that would not occur today. As a result, this area has suffered years of terrible impacts and damage from poor drainage and storm run-off control. Pasadena helped by improving the catchment of run-off at the bottom of Inverness and adjacent public streets thereby directing the flow of run=pff into the Linda Vista Ave. storm drains, but significant problems remain higher up. Every area construction project, including this proposed one and ongoing construction on streets like Edgehill, adds directly and on a cumulative basis to these ongoing
