Re: COVID-19 and School Openings

On October 15th, the mayors of California's 13 largest cities signed a <u>letter</u> to Governor Gavin Newsom urging the state to consider reopening schools because they are "extremely concerned about the effects of prolonged distance learning and lack of access to in-person classroom resources on our children." The letter goes on to request "our state leaders to continue to be proactive, collaborative, and creative in finding pathways to providing critical education and services to our children in a manner that does not negatively impact the health of our students, teachers, staff and families."

Parents in Pasadena are urging our own Mayor Tornek and Public Health Director Dr. Goh to join these big city mayors in voicing the need to get kids back to school so they can get the in-person education and socialization they need to lessen the negative impact of these past seven months of lockdowns. Pediatricians and public health officials have said again and again that these lockdowns are a "grave injustice" and that keeping our schools closed will cause "irreparable damage" to our children. And now we are starting to see studies showing that schools are not in fact super-spreader facilities and that fears of infection spikes are being overblown.

Harvard T.H. Chan School of Public Health associate professor Joseph Allen <u>states</u> that the risk of COVID can be managed, but that "very few are talking about the risks of kids being out of school." Sadly, it has become apparent that our childrens' mental health is not being prioritized by city leaders. It is blatantly obvious that our kids' mental, academic, and physical health are deteriorating. Seeing kids of all ages struggle with the effects of social isolation requires that this council get involved and stand up for our children like the other big city mayors have already done. As parents, we can no longer stand idle to an issue that is severely impacting our kids and families. We Believe it is the moral obligation of school heads and local elected officials to protect our children's physical and mental health at this time. Our local <u>petition</u> has received 236 signatures to date, and more are being collected on a daily basis.

Pasadena has always been a stand-out city and now it is time to stand up for our kids. We cannot wait any longer to express our serious concern. We hope you will support sending a letter to Gavin Newsom stating that our kids cannot be on lockdown any longer. They are counting on you.

Dear Pasadena City Council Members,

Today, I once again implore you to open our schools. I sent a letter last month, but I believe it fell on deaf ears. We appreciate you opening up the school waiver process; however, it appears that only a few elite schools have been given the green light while those non-elites were denied. I have written to Dr. Goh several times over this past month begging her to work with all schools applying to find creative solutions that will allow them to open, but I do not believe this is happening. Applications are about a month old and still no solutions have been found. Is it not the job of the school waiver committee to help find solutions? Are we asking the schools to do this all on their own? Please don't let this just be lip service- please actually help schools to open and not hinder them opening.

The requirements for our waivers are much greater than what the CDC and the State of CA requires. Our children are suffering greatly, while students in the rest of the country and much of our state are thriving at in-school environments. Opioid overdoses are up 50%. Suicides are up 70%. At what time does the Public Health Officer consider mental health important? We are creating huge social/academic inequities and mental health issues. The Covid19 risk pales in comparison to the mental health risk for our children. Study after study proves that schools are not super-spreaders and Covid19 is not a huge risk for them.

The Covid19 numbers are still very low in Pasadena, as they have been for a very long time. As you may read, notable increases this past week are attributed to testing backlog and are not true increases. In all of LA County, there have only been 21 students diagnosed with Covid, and usually it's only 1 at the school (indicating transmission is not occurring at the schools but are occurring at home).

My son has been in preschool since August, and there has not been any issues- those children are thriving, as all children should be in school. My normally high-achieving daughter is doing virtual learning. She is in day 123 of online school and is struggling to stay engaged in her computer 3-4 hours each day. Her behavior has taken a deep decline, and she is acting out every day. She misses her peers and her teachers, and her love of learning is non-existent. This once vivacious little book word is not bored and disengaged. We may never get her back on track. Is this the future you want for our children? How can they do great things when we are failing them like this?

I am begging you to speak with mental health experts to see how Covid is impacting our community. Please let them have an equal say in the Covid conversation, as the mental health battle is something we have complete control over for our children. If we open our schools, we can solve this issue quickly and easily with very little risk.

Please, I beg you yet again, open more schools. Work with them to find creative solutions. End this mental health pandemic.
