

This public hearing was ordered to be held on April 26, 2021 at 4:30 pm by a unanimous vote of the City Council taken on April 19, 2021. Once established by vote of the Council, a public hearing must take place and can only be cancelled by another vote of the City Council.

City staff or the City Manager (or anyone else) do not have the legal power to cancel City Council hearings established by City Council vote.

Only during the hearing itself, sometimes acting on a request or a recommendation by the City Manager and acting on a motion and a 2nd, can a hearing be cancelled by vote of the City Council.

This agenda item which is legally defective, grossly unlawful and incompetently prepared is part of a longstanding pattern of serious misconduct by city staff relating to cannabis matters which has included flatly refusing to provide cannabis related documents relating to Integral to Councilmember Felicia Williams when she requested them in her role as Chair of the Planning Commission.

Because the City Clerk has produced an illegal and incompetently prepared public notice of a cancellation and stated the matter "will not be discussed" I demand that this Council find his actions to be improper and that this hearing be held forthwith after proper notice is given. At this point, thanks to the incompetence of the City Clerk, not only can't this hearing legally take place, you can't even take action to reschedule it on Monday.

This series of defiant and unlawful acts involving cannabis are not accidents.

Juliana is an energetic and enormously capable person with a long history of leadership in our community. It is impossible to imagine any motive for opposing her appointment, other than a cynical attempt to undermine this long overdue Commission by populating it with champions of the status quo.
