To the Honorable Mayor Victor Gordo and esteemed members of the Pasadena City Council:

I am writing to you today as a member of the Social Justice Committee of Pasadena Jewish Temple & Center, as a supporter of our friends, neighbors, sisters, and brothers of the NAACP Pasadena Branch, as a friend of All Saints Church, as duly ordained clergy in our city, and as a citizen of conscience to humbly request your consideration of Florence Annang and Juliana Serrano for appointment in the Citizens Police Oversight Commission.

In my years of study, teaching, and service, I have found no verse of our shared tradition that better captures the moral calling of the Jewish people: "You shall not oppress the stranger, and you know the heart of the stranger, for you were strangers in the land of Egypt." (Exodus 23:9) Our moral obligation to protect the dignity of all our neighbors, friend and stranger alike, is rooted in the empathy born of our historical experience. Not just once, but in many generations, we have known violence, degradation, and injustice in the name of law and order (implemented perversely at the time), and thus we are called in every generation to help the communities in which we reside to avoid even the slightest appearance of injustice.

That is why I strongly urge you to consider the appointment of these two worthy candidates, both of whom were unanimously recommended by the Public Safety Committee. Personally, as a member of the Jewish community of Pasadena, I have been humbled by the outpouring of love, support, and solidarity from both the NAACP and All Saints for our community at a time when Jews have experienced a surge of Antisemitic rhetoric and physical violence nationwide, making it clear to me that their chosen representatives have the safety and peace of all Pasadenans in mind and at heart.

Not only are Ms. Annang and Ms. Serrano worthy on their own merits, knowledgeable about their city and dedicated in their care of its citizens; their acceptance would also send a strong signal to our most vulnerable citizens that the leaders in Pasadena respect the diligence of the Public Safety Committee and truly serve all our citizens. To those who would reject these candidates on the grounds that their passion for their constituencies betrays bias, I would say that this cannot compare to the perception of bias created by their rejection.

I believe that justice and peace in our beloved city requires your careful consideration. I pray that God grant you the wisdom and courage to do what is right. I trust in your dedication to all citizens of Pasadena. And I thank you for your ongoing selfless service to our beloved city.

Dear Members of the City Council,

Please find below my previous correspondence to the Public Safety Committee, recommending Juliana Serrano for appointment to the Community Police Oversight Commission. I stand behind this recommendation and add my recommendation for Florence Annang to be appointed as the representative from the NAACP. These two candidates have been actively serving this community for several years and both have great insight and experience in relation to community-police relations. Our community would be greatly served by having their skills and expertise as part of the inaugural class of the CPOC.

I must also share my deep disappointment in the process for appointing the representatives for the seats reserved for Community Based Organizations. It appears that a process was not truly established or agreed upon, and therefore the community members nominated for these positions have been subject to ever changing requests from whichever body the process is currently in front of. That the unanimous recommendation of Ms. Serrano and Ms. Annang by the Public Safety Committee was thrown out by the City Council, while acknowledging their qualifications to serve, creates doubt and mistrust about the Council's intent to appoint the most uniquely qualified candidates for the commission. It does not go unnoticed that the handling of this situation and the ongoing process for the remaining five candidates has resulted in confusion and a lack of respect for these women, primarily women of color. The establishment of a credible CPOC is important for the life of Pasadena's residents and visitors, and for the comfort of all people who live, work and recreate in Pasadena.




