Mayor Gordo and Councilmembers:

The Pasadena Civic Center Coalition (CCC) submits the following comments on the above-referenced Agenda item 9.

The City lacks the authority to further extend the conditional use permits and variances that were
originally approved in August, 2016.

o 17.64.040.A.2: "A permit or approval shall be valid for 36 months from the effective date of approval. <u>It</u> shall expire and become void, except where an extension of time is approved in compliance with <u>Subsection C</u> below."

o 17.64.040.C.3.a: "The review authority that originally approved the permit may grant a oneextension from the expiration date of the initial approval upon making the findings in Subsection D (Findings). A second one-year extension may also be granted."

- The City's Municipal Code provides no authority for a *third* one-year extension. Because an additional extension would **not** be "in compliance with Subsection C" these approvals "shall expire and become void". <u>See</u> 17.64.040.A.2.
- Additionally, and in the alternative, required Findings 2 and 3 cannot be made, and, therefore, the provisions of 17.64.040.C.3 cannot be met.
 - The proposed Kimpton Hotel project and the original approvals no longer exist. Reliance on these two required Findings is illusory and ineffective.
 - As argued and asserted many times by the CCC, the "proposed project" does not comply with the Zoning Code and is inconsistent with the General Plan, the Central District Specific Plan, and the Zoning Map.
