My family and I love living in Pasadena, and we have been proud of the way the City has responded to the COVID-19 pandemic. From the rapid response in assisting our local businesses with outdoor dining options to the active distribution of vaccines to Pasadena residents, every step of the way the City has shown itself to be a leader in California and a truly great city to call home.

With the recent uptick in COVID-19 infections across LA County, we can understand the concerns and questions the City Council must consider. There is a fundamental problem with the idea of re-masking the public because it assumes that the majority of spread is happening in grocery stores, coffee shops, malls, restaurants, and bars. I am fairly certain we all now understand the spread is happening among the unvaxxed in homes and at intimate gatherings where no one is wearing masks. If this really is the case, this government indoor mask mandate under consideration will not have any real impact in controlling a respiratory virus. Dear City Council members,

I would like to voice my opposition to any further mask mandates for the following reasons:

- 1) Our public health officers are not elected officials and should not have power to enforce rules that infringe on our freedom and are not justified or backed by science.
- 2) There are many studies out there that support lifting mask mandates but one I will focus on is the recent study by JAMA which was a randomized clinical trial with experimental assessment of carbon dioxide content in inhaled air with or without face masks in healthy children. The review concluded that there was ample evidence for adverse effects of wearing such masks. It is an absolute shame that the AAP came out today recommending masks for children and ignoring the science that masks are harmful to children and furthers people's loss of confidence in our institutions.

I realize this is not about masks in schools today, but this is further proof that masks are not healthy.

- 3) By mandating masks when we have this vaccine, it gives a message that these vaccines are not effective. Those who choose to receive the vaccine are protected against more severe symptoms, hospitalizations and death and those who do not choose to receive it are not protected, according to the studies. If the reasoning to enforce mask mandates is to stop unvaccinated people from spreading the virus, you have the burden of proof to show that the vaccines stop the spread. There is not one study proving this and to say "we think it stops the spread" is simply not following the science, as there is not data available currently to show vaccines stop the spread. Wearing masks should be a personal choice. Those that are vaccinated are protected from more severe symptoms, hospitalizations and death.

The CDC has said that people who are fully vaccinated can safely forgo masks in public settings. Why would Pasadena not follow the CDC guidelines? By not doing so you erode faith in vaccines.

- 4) LA County and Hawaii are now the only places in the country that have mask mandates for vaccinated people. This is not the norm in the rest of the country. Also keep in mind the high vaccination rates in Pasadena.
