Social Justice is Environmental Justice; environmental justice has been the focus of my career. My 29 years of government service across the country has provided me a unique experience to work with a variety of diverse populations and geographies. Over the past 10 years, I have been specifically involved working to enrich the lives of Native Americans and Pacific Highlanders with focused attention on Hawaii, Guam, Commonwealth of Northern Marianas Islands and American Samoa. I have viewed first hand how improving a community's environment and surroundings (including but not limited to: affordable housing, workforce development, food security, environmental justice and economic development) have brought about enhancements not only in the community's well-being, but also in their ability to cohesively work together. I have experienced first-hand how improving a community's environment and surroundings can deliver opportunities, outlook and hope.

I have worked to establish and sunset many coalitions where the targets were met with success, such as the Metro Gateway Lead Prevention Program in East St. Louis, IL. By focusing on improving the community's environmental challenges created by the numerous lead smelters and lead-based paint, we improved the community's health, graduation percentages, reduction in crime, increased volunteerism, etc. All of this was possible because trust was established amongst all the entities at the table who brought their concerns and were heard. Together, the government, community, private sector and nonprofits worked to improve the community's health. My coalition building has broad experience from federal, state and local levels. I continue to work with the City of Los Angeles and local stakeholders to develop a collaborative approach to revitalize the Los Angeles River, which has led to difficult conversations around gentrification and inequities. I have also presented in front numerous City Council sharing recommendations, success stories and requesting support for a variety of initiatives.

11. How would you add value to the Community Police Oversight Commission?

I would add value through my leadership and broad perspective from viewing challenges from both the public and private sector. I have worked as a community relations coordinator for over 10 years across the Midwest states, where I succeeded in eliminating environmental injustices. I am a critical thinker with tactical experience building coalitions, listening, digesting and facilitating differing viewpoints. I am a sound decision-maker and have experience in structured and unstructured/ambiguous situations. As an ethnically diverse professional woman, I bring unique viewpoints to many situations. I am a proud resident of Pasadena, homeowner and local investor in Pasadena real estate.

As a resident, mother, investor and community member, I am committed to working with Pasadena's stakeholders to become a catalyst for innovation, improvemen and growth. If appointed to the Community Police Oversight Commission, I will work to improve and eliminate social divisions and inequities, and ultimately aid in creating an environment where all people regardless of race or color know they are valued, served and protected to the fullest extent of the law.

12. What do you see as the objectives and goals of the Community Police Oversight Commission?

Based on my research and conversations with stakeholders, I see the Commission's objective as providing oversight, counsel and advice. As Commission members, our goal would be to serve as a liaison and listen, research, absorb and effectively communicate the community's interests for public safety. Our goal would be to strengthen the community's relationship and trust with the police department and to help enhance policing programs.

13. How would you help achieve these objectives and goals?

My numerous successful years of government experience and community involvement have provided me the opportunity to work directly with the public, while absorbing feedback and developing actionable solutions to improve our services/programs. As a government worker, I have had the experience of being praised for helping others. I have also heard complaints from citizens who have disagreed with government policies and actions. I have participated in

numerous audits and have significant experience reviewing highly detailed public and confidential materials to help resolve community, state and federal government challenges. I would use my experience and skills to bring an objective, clear-eyed approach to the Commission's tasks in order to maintain the public trust of the citizens of Pasadena.
