(2) Make the Findings for Approval for the General Plan Map and Text Amendments, Specific Plan Amendment, and Zoning Code Map and Text Amendments;

(4) Adopt a resolution approving the recommended Lincoln Avenue Specific Plan (LASP); and

(5) Direct the City Attorney to prepare an ordinance for the Zoning Code and Text Amendments within 90 days consistent with the provisions set forth in the agenda report. (<u>Resolution Nos. 9875</u>, 9876)

PLANNING COMMISSION RECOMMENDATION: On June 23, 2021, the Planning Commission recommended that the City Council approve the proposed LASP, including the General Plan Map and Text Amendments, Zoning Code Map and Text Amendments, and the Addendum, as presented by staff, with the following recommended changes:

PUBLIC HEARING

1. Amend the General Plan Land Use Diagram to allow housing in the LASP-CG zone within the Lincoln North Subarea;

2. Prioritize streetscape enhancements within the Lincoln North Subarea, that improve pedestrian and bicycle safety and connections;

3. Revise existing and/or add a new implementation program to explore the creation of a Business Improvement District to help fund a parking management program that reduces or eliminates parking requirements for individual properties and identifies other parking supply opportunities in the LASP-CG zone within the Lincoln North Subarea;

4. Clarify the public open space requirements and consider renaming and/or including a definition in the LASP;

5. Revise requirements specific to the Kettle's Nursery site located at the intersection of Wyoming Street and Lincoln Avenue and convert them into guidelines to support the redevelopment of the site and encourage preservation of the existing one-story midcentury structure on the northwest portion of the site; and

6. Incorporate a goal and/or policy stating a preference to retain existing architectural style in the LASP-CG zone within the Lincoln North Subarea.

City Manager Mermell and David Reyes, Director of Planning and Community Development, provided introductory comments, and Anita Cerna, Senior Planner, presented a PowerPoint presentation on the item, with all responding to questions.

Mark Jomsky, City Clerk, opened the public hearing; reported that the public hearing notice was published in the <u>Pasadena Press</u> and the <u>Pasadena Journal</u> on October 28, 2021, November 4, 2021, and November 11, 2021; and that one letter in opposition to the staff recommendation was received by the City Clerk's Office, which was distributed to the City Council, posted on-line, and made part of the public record.

Mr. Reyes reported that there is a correction to the staff report, and clarified that staff is not recommending to change the General Plan designation of any parcels, but rather to align the maximum densities of the amended specific plan parcels with the General Plan densities.

Mark Jomsky, City Clerk, opened the public hearing; reported that the public hearing notice was published in the <u>Pasadena Press</u> on November 1, 2021and the <u>Chinese L.A. Daily News</u>, <u>La Opinion</u>, <u>Pasadena Press</u>, and the <u>Pasadena Journal</u> on November 4, 2021. He also reported that the City Clerk's Office received (as of the last Redistricting Task Force meeting on October 30, 2021) one letter in support of minimal change map with 10% deviation, one letter expressing concerns and advocating for specific Council Districts for the Central District, one letter providing general comments and 18 "Community of Interest" maps that were submitted by one individual, which were distributed to the City Council, posted online, and made part of the public hearing record.

City Clerk Jomsky and Vince Farhat, Chair of the Redistricting Task Force (RTF), presented a PowerPoint presentation on the item, and responded to questions. Mr. Farhat thanked City staff, redistricting consultants, City Clerk Jomsky, RTF members and the community for all their hard work, support and input related to the RTF meetings and process. Mr. Jomsky thanked Chair Farhat, Vice Chair Moreno, and the RTF members for all their work on the City's RTF process.

City Clerk Jomsky reported that there may be an error in the agenda report that will be corrected to reflect the correct shifts from District 6 to District 7 which includes: Del Mar Boulevard on the North, Los Robles Avenue on the West, California Boulevard on the South, and Madison Avenue on the East.

David Ely, representing National Demographics Corporation (Redistricting consultants), provided information on census block boundaries (in the area adjacent to the 210 Freeway), noted that these lines are accurate in terms of the census blocks, do not contain any populations, and that will be cleaned up when the final map is created and distributed to the public; and responded to questions.

The City Council thanked the Redistricting Task Force, the redistricting consultants, and City staff for the hard work and diligent efforts spent on the process.

Councilmembers Masuda and Madison spoke in support of the Minimal Change with 10% Deviation Plan map.

Councilmember Williams expressed concerns with the shift from District 7 to District 2, specifically with Oak Avenue and Roosevelt Avenue that are stop signs, unlike Craig Avenue that runs through without a stop sign that she believes connects communities. She stated that she does not believe a community is able to connect if you cannot cross the street.

Councilmember Kennedy spoke on what he believes was a the thorough RTF process including community input, and spoke in favor of the Task Force recommendation of the Minimal Change with 10% Deviation Plan map and Redistricting Plan.

Vice Mayor Wilson spoke in support of the redistricting line adjustment on Los Robles Boulevard and the Minimal Change with 10% Deviation Plan map.

Councilmember Rivas expressed concerns with the results of the 2020 census and the undercount of Pasadena residents in the northwest part of the City.
