Dear Licensee,

This Letter is to notify you that the license to operate the above referenced facility was revoked on **May 24, 2021**. The California Department of Public Health (CDPH), Center for Health Care Quality, Licensing and Certification Program, sent a License Revocation Letter (Non-Payment) to you on May 24, 2021, informing you that you had not complied with the statutory obligation to renew the license to the licensee's address on record. As a result of this non-payment, your license was revoked. Under Health and Safety Code, section 131071, you had 30 days from receipt of the License Revocation Letter to appeal the revocation. USPS tracking records show the letter was received on May 25, 2021. CDPH did not receive a request for an appeal by **June 25, 2021**, within 30 days of receipt. Therefore, the license for 1450 North Fair Oaks, LLC is revoked as of **May 24, 2021**.

CDPH issued a Temporary Suspension Order (TSO) to the facility on June 10, 2020. A hearing on the TSO is set to commence on August 24, 2021. In light of the revocation of the facility's license, CDPH is withdrawing the TSO and requesting the matter be taken off calendar as it is now moot.
