AUTHORIZATION TO ENTER INTO A CONTRACT WITH CELPLAN TECHNOLOGIES, INC., FOR THE PURCHASE AND INSTALLATION OF EXTERIOR SECURITY CAMERAS AT VILLA PARKE

Recommendation: It is recommended that the City Council:

- (1) Find that the proposed contract is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15061(b)(3); and
- (2) Authorize the City Manager to enter into a contract, as a result of a competitive selection process, as specified by Section 4.08.047 of the Pasadena Municipal Code, with CelPlan Technologies Inc., for the purchase and installation of security camera equipment in the park area of Villa Parke, inclusive of one year of maintenance and support for an amount not-to-exceed \$115,543, which includes a ten percent contingency. (Contract No. 32172)

Allison Henry, Pasadena resident, expressed concerns with security, lighting, and a lack of internet service at Villa Parke.

In response to Councilmember Hampton's inquiry, on when a discussion on park safety will be agendized, Mayor Gordo stated that the matter will be agendized at a future Public Safety Committee meeting.

In response to Councilmember Hampton's inquiry related to internet service at Villa Parke, Phillip Leclair, Chief Information Officer, stated that there is Wi-Fi available at Villa Parke in the exterior areas and buildings. He stated that he would reach out to the public speaker to review details on possible areas of Wi-Fi dead zones so that staff can do their best to increase the coverage and capacity.

Mark Jomsky, City Clerk, reported that three letters in support of the staff recommendation, and one letter expressing concerns and providing comments for additional security support and infrastructure, were received by the City Clerk's Office, distributed to the City Council, posted on-line, and made part of the public record.

OLD BUSINESS

PREDEVELOPMENT PLAN REVIEW OF A NEW 112-UNIT SENIOR AFFORDABLE HOUSING PROJECT AT 280 RAMONA ST / 279 EAST HOLLY STREET

Recommendation: This report is intended to provide information to the City Council; no action is required.

City Clerk Jomsky reported that six letters expressing gratitude and support for the proposed affordable housing project in the Civic Center were received by the City Clerk's Office, distributed to the City Council, posted on-line, and made part of the public record.

At the request of Councilmember Williams, Michele Beal Bagneris, City Attorney/City Prosecutor, provided information on the City Council's limitations on providing comments on Predevelopment Plan Review presentations; and responded to questions.

David Reyes, Director of Planning and Community Development, provided introductory comments, and Andre Sahakian, Senior Planner, presented a PowerPoint presentation on the item, and responded to questions.

Councilmember Kennedy thanked the applicant for the proposed project that will build 112 affordable units, and staff for assisting the applicant through the City's permitting process.

In response to Councilmember Kennedy's inquiry related to the developers considering expanding the naming convention for the proposed development, Kevin Chin representing National CORE (applicant), responded that they would consider naming the project "Thurgood Marshall."

Anthony Manousos, representing Making Housing and Community Happen, spoke in support of the proposed project.

Following public comment, on the order of the Mayor, and consensus of the City Council, the information was received and filed.

RECOMMENDATIONS FROM OFFICERS AND DEPARTMENTS

City Manager

CALIFORNIA BOULEVARD GRADE SEPARATION PROJECT UPDATE

Recommendation: It is recommended that the City Council:

- (1) Find this action is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15061(b)(3), Review for Exemption; and
- (2) Direct the City Manager to identify potential projects, to submit to Metro for consideration in lieu of the Metro L Line California Boulevard Grade Separation Project.

Laura Cornejo, Director of Transportation provided introductory comments, Joaquin Siques, Deputy Director of Transportation, presented a PowerPoint presentation on the item, and Steve Mermell, City Manager, provided supplementary information related to the staff's recommendation, with all responding to questions.

Councilmember Madison spoke in support of the staff recommendation, and stated that he believes grade separation would be great for the City if it were easily constructed and cost efficient.

Mayor Gordo spoke on the importance for City staff to meet with the Los Angeles County Metropolitan Transportation Authority (METRO) Board of Directors to advocate and ensure the funding of projects will be available to the City.

City Clerk Jomsky reported that one letter expressing disappointment with the potential cancellation of the grade separation project, and one letter in support of the staff recommendation, were received by the City Clerk's Office, distributed to the City Council, posted on-line, and made part of the public record.

Vice Mayor Wilson and Councilmembers Masuda and Hampton spoke on the importance of utilizing METRO's allocated Measure R Mobility Improvement Projects (MIP) funds that were awarded to Pasadena, and the need for the City Council to review the City's portfolio of proposed projects prior to the City submitting the list to METRO.

Councilmember Hampton advocated for the City to also consider using awarded funds to build sound walls along the 210 Freeway Corridor, particularly for communities of color that the California Department of Transportation (Caltrans) and METRO have made past promises to build the sound walls.

Councilmember Kennedy suggested that City Manager Mermell work with Cynthia Kurtz (soon to be acting City Manager), who was also involved in the discussions with METRO regarding Blue Line/Gold Line transit rail stations, to collaborate on the staff recommendation.

Following discussion, it was moved by Councilmember Madison, seconded by Vice Mayor Wilson, to approve the staff recommendation with direction to staff to return to the City Council with a portfolio of proposed projects prior to presenting the portfolio to METRO:

Recommendation: It is recommended that the City Council:

- (1) Find that the proposed amendments to the Development Agreement do not involve in physical changes to the environment and, if adopted, are therefore exempt from the requirements of CEQA pursuant to Section 15061(b)(3);
- (2) Direct the City Manager to continue to negotiate amendments to the Development Agreement pursuant to Pasadena Municipal Code (PMC) 17.66.080 (A), consistent with the topics identified in the report and as outlined in Attachment B of the agenda report; and direct the City Attorney to prepare an amended Development Agreement for City Council consideration at a subsequent meeting.

David Reyes, Director of Planning, presented a PowerPoint presentation on the item, and responded to questions.

Mayor Gordo and Councilmember Kennedy expressed disappointment and concerns with the Lincoln/Parsons Project in relation to the results and actuals of local hire and local contracting goals that were not met as set forth in the project's Development Agreement (DA).

Rob Cane, Executive Vice President with Lincoln Property Company, provided information on their actions to strengthen local hiring efforts, and contributions to the community; and stated that he is willing to commit to continued negotiating with the City on goals and efforts in terms of local hiring, local sourcing of materials and local contracting.

In response to Councilmember Kennedy's inquiry related to the clarity of the second phase of the project's DA negotiations, Michele Beal Bagneris, City Attorney/City Prosecutor, responded that she believes there is clarity with the understanding that there will be further negotiations and will defer to Mr. Reyes for additional information or clarification.

Councilmember Kennedy spoke on the need for local governments to issue apologies to the Japanese-Americans, Latino-Americans, and African-Americans who have lost property as a result of land taken by eminent domain. He also spoke on the need, under Mayor Gordo's leadership, for the developer and the City to agree on a Project Labor Agreement.

City Clerk Jomsky reported that five letters in support of the of the Lincoln/Parsons project, and expressing gratitude for local hire efforts, were received by the City Clerk's Office, distributed to the City Council, posted on-line, and made part of the public record.
