We, the Two-Stroke Engine Ad Hoc Committee (Committee) of the Environmental Advisory Commission (EAC), are delighted to learn the Council has received our dossier. It is the product of many months of careful research and discussion by our Committee. The Committee consisted of four commissioners—each from a different district of the City and bringing to the table a wide range of experience from professional backgrounds, including the sciences, law, and public policy. We are proud of our work, and we were delighted when so many members of the public appeared at the public forum where our information was distributed and debated.

The packet before you contains our great City's history of leaf blowers (a proxy for all two-stroke engines); a list of two-stroke engine bans and ordinances across all California counties (current through January 2020, when the Committee prepared the packet to be reviewed by the EAC); a review of the environmental, personal, and community hazards associated with two-stroke engines; and public comments spanning many years. We believe our work demonstrates not only an appetite for action, but also that rapidly changing technological advances make healthier and safer practices more affordable today than in past years.

We urge adoption of Recommendation #1, which is directly in line with the recommendation offered by the EAC on February 9, 2021 and would direct the City Attorney to draft a new ordinance. The proposed new ordinance would come back before Council for discussion and consideration of public comment. Ultimately, we hope the Council will expedite action to amend an ordinance that no longer serves the community well.

The time to act is now. Notably, approximately 20% of California counties are already enacting at least a partial ban on two-stroke engines (please review the packet). Therefore, others have already acted to address this problem, leaving Pasadena in the metaphorical and literal dust. Unfortunately, until now, Pasadena has acted neither as a leader nor a fast follower. But we can catch up.

We recommend you look at this problem through an equity lens, understanding that operators at small enterprises are disproportionately people of color and rely on this equipment for their livelihood. Therefore, we recommend the City provide outreach on the perils of two-stroke engine lawn equipment in English and Spanish (as outlined in Measure T-7.1 in Pasadena's Climate Action Plan). The City, which takes pride in being a leader in so many ways, should also lead by example and completely discontinue use of two-stroke engines (if applicable). We applaud the City for its purchase of electric leaf blowers in recent years, but more can be done, including requiring City contractors to utilize low-emissions landscaping equipment.

The EAC has fulfilled its responsibility by putting forth a good faith effort to gather and summarize the requisite information and recommend reasonable next steps.

The rest is up to you. City Council should undertake concrete action by directing the City Attorney to draw up an amended ordinance.

Dear Honorable Mayor Gordo, City Councilmembers, and City Staff,

I am a condo owner and resident of the Playhouse District neighborhood in Councilman Kennedy's district. My husband (Tony Segall) owns his office building on Marengo Ave. in Councilman Madison's district, and our grandchildren are growing up in Councilman Wilson's district. Our family loves Pasadena and we are proud of the City's reputation for its high quality of life.

Unfortunately, all our neighborhoods are blasted continuously by leaf blowers from well before the legal 8 a.m. start time to well into evening hours. In our increasingly dense city, where many live like I do near schools, churches, offices and stores that all use gardeners, with minimal setbacks, no lawns to buffer debris, emissions and noise, the ubiquitous use of leaf blowers makes for a very stressful and unhealthy environment.

I'm pleased that the gardening contractor who works at my condo complex has finally switched to electric blowers, but I continue to have to report code violations up and down my block when leaf blowers at the other MFR buildings and businesses in my neighborhood violate the ordinance. As hard as city staff works to stay on top of complaints, the system is deeply broken because City employees are powerless to cite a violator unless the conduct is personally observed by the code enforcement staff person. Most violators are gone before a code enforcer can show up (and many gardeners begin work hours before City staff start their work days).

I was honored to serve as a commissioner and vice chair of the City's Environmental Advisory Commission (EAC). I headed the ad hoc committee on two-stroke engine landscaping equipment. Our committee spent hundreds of hours researching the topic of leaf blowers in response to public comments received by the EAC and several hundred posts by Pasadena residents and business interests on social media sites such as NextDoor.com.

At the suggestion of former Mayor Tornek, our committee held a public forum to present our research and get input from stakeholders.

At the start of all this work, we asked that City staff resources be allocated to assist with this project, but we were turned down. The City Manager made clear there was little or no interest among councilmembers in seeing the subject of leaflblowers come before Council. As a result, the EAC was left to its own devices to figure out how to respond to the public's concerns about noise, pollution, human health impacts and greenhouse gas emissions.

The EAC decided to go ahead to do all our own research and investigation. As a private individual, I obtained some information from the City by submitting a request under the Public Records Act, and the resulting information helped our committee decide what further research might be useful to City Council.

I urge you to review the EAC's detailed packet of carefully-researched information, and to take action.

The time to act is now. California's governor just last week signed into law a law that will outlaw gas leaf blowers in 2024.

Pasadena should have acted sooner. But it's never too late to demonstrate leadership.

Dear Mayor Gordo and members of the Pasadena City Council,

As community-based organizations and stakeholders committed to improving health, sustainability, and quality of life in Pasadena, we appreciate the City's efforts to implement its adopted Climate Action Plan. However, more direct action is needed in the short term in order to combat the climate crisis, biodiversity loss, and air pollution in our community, including a strong local policy on the use of small off-road engines (SOREs).

Pasadena lies within an extreme non-attainment zone for air quality per US EPA; in other words, we live in one of the most polluted air basins in the United States. **Small off-road engines (SORE) emit high levels of air pollutants** -- including nitrogen oxides (NOx), reactive organic gases (ROG), and particulate matter (PM) -- **and are predicted to surpass emissions from light-duty passenger**

cars in 2021. According to the CA Air Resources Board (CARB), engines in this category are primarily used for lawn, garden, and other outdoor power equipment, with an estimated 16.7 million in use across California, versus 13.7 million light-duty passenger cars. CARB estimates that one hour of operation of a commercial leaf blower can emit as much ROG and NOx as driving 1,100 miles in a 2017 Toyota Camry. This level of pollution disproportionately impacts the health and safety of lower-income workers who use the largely unregulated, polluting gas models for hours on any given work day.

The need for additional controls

The California Air Resources Board (CARB) adopted emissions standards for small engines in 1990 and was the first agency in the world to control emissions from these engines. Due to the regulations put in place by CARB, small engines are 40-80% cleaner today than they were before the program began. In the early 2020s, however, total smog-forming emissions from small engines are projected to exceed those from passenger cars in the South Coast Air Basin because passenger car emissions will continue to decrease. By 2031, small engine emissions will be more than twice those from passenger cars.





Leaf blowers are also destructive for the habitat of butterflies, beetles, bees, moths and other creatures that make their homes and lay their eggs in leaves. There is a knock-on effect on our wild bird populations who depend on healthy insect populations for their survival. Both bird and insect populations are in steep decline. In addition to phasing out dirty gas blowers, Pasadena should also encourage residents to limit the use of leaf blowers to support local biodiversity. A local policy should limit the use of all leaf blowers to hardscapes only, and require that fallen leaves which are a crucial part of the foodweb not be blown off the property.

Over half of household lawn and garden equipment is already zero-emission, but commercial landscapers have historically had lower adoption rates of zero-emission equipment.

Equipment used for commercial purposes requires additional batteries and chargers, increasing the upfront costs of cleaner, healthier, zero-emission equipment. Fortunately local air quality districts such as SCAQMD already have programs in place to support commercial operators in making the transition. The <u>Electric Lawn and Garden Equipment Incentive Program</u> exchanges older, polluting gasoline- or diesel-powered commercial lawn and garden equipment for new zero emission, battery electric commercial grade equipment. The program allows participants to select from a variety of available makes and models of commercial-grade equipment, including handheld trimmers, chainsaws, pruners, backpack and handheld blowers and ride-on, stand-on, walk-behind and robotic lawn mowers. The 2021-22 state budget includes \$30 million in new funding to support such programs.

Pasadena has an opportunity to join others across the state in acting locally to accelerate the adoption of cleaner, quieter, battery-electric yard equipment. On September 1, 2021 our neighbors in the City of South Pasadena adopted a local policy that phases out the use of gas leaf

blowers, effective October 1, 2022. The City's policy is designed to be non-punitive to small business owners by holding the property owner or tenant, whichever person authorizes the use of a gas-powered leaf blower, responsible for violations of the ordinance. In 2021 the California State legislature also passed AB 1346, which was signed into law by Governor Newsom on October 8th. AB 1346 will ban the sale of new gas-powered leaf-blowers, lawnmowers, and other small off-road engines (SOREs) by 2024 or earlier if deemed feasible by the California Air Resources Board (CARB).

The undersigned urge the Pasadena City Council to join communities across California in adopting a local policy that:

- 1. phases out polluting gas yard equipment,
- 2. requires the use of zero emission yard equipment,
- 3. limits the use of leaf blowers to the hardscape and requires that leaves not be blown off the property, and
- 4. supports local small businesses in taking this step.
