Pasadena attracts many people because of its reputation for quality. As a small landlord for a single family home, I believe that a measure that creates an autonomous rental oversight body loaded with renters, with an unfair directive to limit the ability of landlords to stay current with the cpi and rents is inherently a poor solution.

I also believe it will cause many landlords such as me — who try to be fair, treat tenants well, and don't make a practice of imposing exorbitant regular increases — to withdraw our rentals from the market, actually worsening housing conditions. We are not a large company, we are hands-on and do all the work ourselves. We enjoy good relationships with all of the people who rent from us. With one exception.

We have one resident who has not paid one single dollar since March 2020 and he has no intention of paying anything. We have tried to evict him on two occasions in the past 2 1/2 years but each time we have been unable to proceed due to eviction moratorium restrictions.

We provide good housing and maintain our properties well and provide reasonable rents with long term residents. It is rare for anyone to move in under 5 years. A significant percentage of our residents have been in their home for over 10 years and we have had renters for as long as 36 years, so rent control has never been a necessity at our property.

As a Realtor, I understand that most small operators do not raise rents regularly or sufficiently. Maybe you are confusing the high rents and problem situations with the new corporate owners and corporate builders of the high rise complexes. That is a vastly different situation compared to those of us who have owned small old housing stock in the city.

Please continue your stance and oppose this measure. Please support those of us who have supported the city for decades providing good housing with happy long term residents this is our livelihood and business. When you start controlling the price of groceries and legal fees, you will know that this price control began with rent control. Please be level headed.
