## AGENDA ITEM #7: THE PURCHASE OF TWO GASOLINE-POWERED AMBULANCES

The League of Women Voters of the Pasadena Area requests that the Pasadena City Council direct the city staff to investigate the opportunities available to purchase electric ambulances before a decision is made about the city purchasing two fossil fuel powered ambulances. The urgent climate crisis that we are experiencing requires that we pursue all opportunities to reduce greenhouse gas emissions and thereby mitigate the damages of climate change. Since the proposed fossil fuel powered ambulances will not be available for 500 days, almost a year and a half, it is even more important that the city pursue electric options. The climate crisis will only become worse with time.

Dear City Council,

Thank you for giving me, a Pasadena resident, the opportunity to present my reaction when I read this proposal for gas-powered ambulances and hear that you may approve it.

I am mystified and saddened when I learn that all in your power may not be done to mitigate climate change, as indicated by your reluctance to purchase electrically powered ambulances for the fire department's fleet.

If most cities in the United States adopted policies to reduce emissions wherever possible, then just think about the amount of greenhouse gases in the atmosphere that would significantly decline. But if cities let obstacles get in their way--even when they are significant, as I understand you are rightfully concerned with--then the dire consequences of climate change will grow ever greater. For the protection of us, the citizens of Pasadena, we need to do everything possible not just to *adapt* to climate change catastrophes—a strategy that will deplete our coffers ever more every year—but also to lessen their severity through *mitigation*--which means dramatically reducing the use of fossil fuels.

Not only that, but Pasadena would be setting an example for other cities on electrification of their municipal fleets.

Finally, think of all the money that would be saved on maintenance, repairs, and gasoline over the years. Not to mention the financial costs of damage to people's health from fossil fuel pollution.

I believe I understand the seriousness of at least some of your misgivings, and I'm sure that you want what is best for the welfare of Pasadena. But the welfare of Pasadena means taking on the climate crisis, and I feel skeptical that there is no way that these electric ambulances could not be operated as safely as gas-powered vehicles and purchased expediently if we put our minds to it. Where there is a will, there's a way. Other cities have successfully carried out the purchase of electric ambulances. What's preventing us?

My request is for you to reject the purchase of gas-fueled municipal ambulances and research a responsible way to purchase electrically powered ones.
