Recommendation: It is recommended that the City Council:

(1) Adopt the Environmental Determination that the proposed project is exempt from environmental review pursuant to the guidelines of the California Environmental Quality Act (Public Resources Code §21080(b)(9); Administrative Code, Title 14, Chapter 3, §15308, Class 8, Actions by Regulations for the Protection of the Environment); and

(2) Direct the City Attorney to prepare an ordinance and return within 60 days amending the Pasadena Municipal Code by amending Title 8, Health and Safety Code requiring the electrification of buildings in certain specific categories.

Vice Mayor Wilson, Chair of the Municipal Services Committee (MSC), summarized the Committee's discussion and comments on the matter. He advocated for new Accessory Dwelling Units (ADU) to be included in the proposed electrification requirements.

Ronald Takiguchi, Building Official, provided information on other municipalities' electrification ordinances and associated saving costs on the proposed electrification requirements; David Reyes, Director of Planning and Community Development, provided information on the State's policy on the issue; and Interim City Manager Kurtz provided information on the proposed electrification schedule; with all responding to questions.

Councilmember Kennedy spoke in support of the staff recommendation, and advocated for staff to amend the applicability of electrification requirements to new multi-family residential buildings that have more than four units based upon the concerns of the community.

Councilmember Madison expressed concerns as to why staff agendized the report under Consent Calendar, as this matter is substantial and requires discussion and consideration. He also expressed concerns with the lack of MSC and Environmental Advisory Commission's input on the matter. He spoke in support of applying the proposed electrification requirements to all homes in the City; and asked staff to provide comparative data on the usage of natural gas versus electricity for residential and commercial, and what commercial gas usage (percentage) pertains to restaurants, to determine the City's carbon footprint. He asked that the City's Water and Power Department provide projections in terms of electricity demand that would occur following implementation of the proposed ordinance, as well as costs associated with heating and cooking for a family of four.

Councilmember Rivas spoke in support of the staff recommendation, however, advocated for the proposed electrification requirements to include new construction, single-family homes, new multi-family units, and new ADU's.

Vice Mayor Wilson stated that the MSC did not provided a formal recommendation because the proposed electrification of buildings ordinance was still being developed, and advocated for the proposed ordinance to be agendized at a future MSC meeting for further review and discussion.

Councilmember Masuda spoke in support of the staff recommendation.

Mayor Gordo advocated for the City Council to approve the staff recommendation with direction to staff to agendize the matter at a future MSC meeting for further review and discussion prior to the matter returning to City Council for consideration.

Following discussion, it was moved by Councilmember Kennedy, seconded by Councilmember Williams, to approve the staff recommendation, noting the direction to staff to agendize the proposed ordinance at a future MSC meeting for further review and discussion prior to it returning to City Council for first reading, as well as for staff to return within a year with proposals that would incorporate single-family homes and accessory dwelling units as part of the City's electrification ordinance requirements:

Mayor Gordo summarized the agenda report as part of his oral presentation, and responded to questions.

Councilmember Williams, member of the ad hoc committee, reported that as part of its consideration, the Committee reviewed the practices of other municipalities.

Councilmember Madison and Vice Mayor Wilson expressed concerns with the impacts that public comments on matters not on the agenda has in relegating and inhibiting public comment on matters on the Council's agenda that are publically noticed for discussion
