## **SPECIAL ITEM**

### **PRESENTATION BY JONATHAN E. SHERIN, M.D., DIRECTOR OF LOS ANGELES COUNTY DEPARTMENT OF MENTAL HEALTH, ON MENTAL HEALTH SERVICES AVAILABLE IN LOS ANGELES COUNTY AND THE CITY OF PASADENA**

Mayor Gordo provided introductory comments and introduced Dr. Sherin the County's Director of Mental Health.

Jonathan E. Sherin, M.D., Director Of Los Angeles County Department Of Mental Health, and Theion Perkins, Program Manager III, Los Angeles County Department of Mental Health, provided an oral presentation on mental health issues, as well as services/resources available to those in need of mental health support, and potential opportunities to collaborate with the City of Pasadena, and responded to questions.

Mayor Gordo spoke on the mental health crisis and the need for mental health care programs/services in Pasadena. He advocated for additional services to meet the needs of the community, supported a partnership with the Los Angeles County Department of Mental Health, as well as opportunities to collaborate with Huntington Hospital and the Pasadena Health Department noting the need to expand and augment mental health services for residents.

Mayor Gordo and Ms. Theon Perkins, Department of Mental Health (DMH), spoke on the mental health services provided to Pasadena Unified School District (PUSD) students by DMH through a direct contract with PUSD, stating that this may be a good model and platform for partnership with DMH.

Councilmember Hampton expressed his appreciation and thanks to Ms. Perkins for her work, spoke in support of the Mayor forming an Ad Hoc Committee to focus on mental health issues, and stated his interest in serving on such a committee.

Mayor Gordo stated he would work with Interim City Manager Kurtz, Dr. Sherin, and Ms. Perkins to determine next steps, including the possible establishment of a working group that would identify key issues (such as funding and collaboration opportunities). He encouraged members of the City Council to let him know if there are members interested in being appointed to such a working group.

The following individuals provided comments and/or concerns related to the mental health crisis, advocated for diverting funding from the Pasadena Police Department budget to support mental health outreach, resources and programs, spoke on violence as a public health issue, and suggested use of alternative intervention programs such as the Crisis Assistance Helping Out On The Streets (CAHOOTS):

Ms. Perkins provided details on a new crisis hotline phone number that will launch in July to help decriminalize mental health, and shared that DMH plans to increase their budget request and expand the Met Homeless Team by 11 additional teams.

**CONTINUED PUBLIC HEARING: ADOPTION OF FISCAL YEAR 2023 – 2027 CAPITAL IMPROVEMENT PROGRAM BUDGET Recommendation:** It is recommended that the City Council:

- (1) Find that the proposed actions are not "projects" as defined in the California Environmental Quality Act (CEQA), Public Resources Code Section 21065 and Section 15378(b)(4) and (5) of the State CEQA Guidelines and, as such, are not subject to environmental review; and
- (2) Adopt by resolution the City's Fiscal Year (FY) 2023 – 2027 Capital Improvement Program (CIP) Budget as summarized in Exhibit B contained in the resolution and any changes passed by a motion of the City Council at the May 2, 2022 meeting. (Resolution No. 9910)

**Advisory Commission Recommendations:**

Recreation and Parks Commission: On March 1, 2022, the Recreation and Parks Commission voted unanimously to support the Parks and

Landscaping and Arroyo Projects sections of the Recommended FY 2023 – 2027 CIP Budget.

**APPROVAL OF RELINQUISHMENT AGREEMENT BETWEEN THE  
STATE OF CALIFORNIA AND THE CITY OF PASADENA FOR THE  
RELINQUISHMENT OF THE STATE ROUTE 710 NORTHERN  
STUB BETWEEN UNION STREET AND COLUMBIA STREET**

**Recommendation:** It is recommended that the City Council:

- (1) Find that the Caltrans, as the lead agency, has prepared and circulated for public review environmental review documents concluding that the following proposed action is exempt from review pursuant to the California Environmental Quality Act (CEQA) Guidelines Section 15061 (b) (3) and the National Environmental Policy Act (NEPA) Section 771.117; and in its role as a responsible agency under CEQA/cooperating agency under NEPA, the City has reviewed and approves of the Categorical Exemption pursuant to Section 15061(b)(3), and the Categorical Exclusion pursuant to Section 771.117; and
- (2) Contingent upon Caltrans' adoption of the exemptions above, authorize the Interim City Manager to execute a Relinquishment Agreement between the State of California and the City of Pasadena for the Relinquishment of the State Route 710 between Union Street and Columbia Street, inclusive of any subsequent agreements relating to the transfer of this property from Caltrans to the City of Pasadena. 
