- Ceremonial Matters Mayor Gordo announced a proclamation declaring June 15, 2022 as "Elder Abuse Awareness Day" in Pasadena. Manuel Carmon, Deputy Director of Public Health, recognized the Pasadena Elderly and Dependent Adult Liaison (PEDAL) Committee for their work and commitment to elder abuse awareness, and thanked the City Council for recognizing this important issue.

CONSENT CALENDAR APPROVAL OF PASADENA ASSISTANCE FUND GRANT AWARDS FOR PROGRAM YEAR 2022

Recommendation: It is recommended that the City Council take the following actions:

(1) Find that the recommended action is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines per Section 15061(b)(3), the "Common Sense" provision that CEQA only applies to projects that may have an effect on the environment; and

(2) Approve the proposed award of Pasadena Assistance Fund program year (PY) 2022 grant funds in the total amount of \$50,000 to the Armory Center for the Arts and the Boys & Girls Club of Pasadena.

RESOLUTION TO APPLY FOR THE CALIFORNIA HOUSING FINANCE AGENCY ACCESSORY DWELLING UNIT GRANT PROGRAM

Recommendation: It is recommended that the City Council:

AUTHORIZATION TO ENTER INTO A CONTRACT WITH NTT AMERICA, INC., TO PROVIDE MICROSOFT TEAMS PHONE SYSTEM AND GENESYS CLOUD CONTACT CENTER IMPLEMENTATION INCLUDING A DIALING PLAN WITH TECHNICAL SUPPORT IN AN AMOUNT NOT-TO-EXCEED \$1,880,965 FOR FIVE YEARS

Recommendation: It is recommended that the City Council:

(1) Find that the proposed contract is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15061(b)(3); and

(2) Authorize the Interim City Manager to enter into a five-year contract, as a result of a competitive selection process, as specified by Section 4.08.047 of the Pasadena Municipal Code, with NTT America, Inc., to provide Microsoft Teams Phone System and Genesys Contact Center implementation including a dialing plan with 24/7 technical support for an amount not-to-exceed \$1,880,965, for five years, which includes a ten percent contingency on the base implementation cost only. Competitive Bidding is not required pursuant to the City Charter Section 1002(F), contracts for professional or unique services. (Contract No. 32296)

AUTHORIZATION TO ENTER INTO AN ANNUAL PURCHASE ORDER WITH THE CITY OF GLENDALE FOR MONITORING, MAINTENANCE, AND UPGRADES OF THE CITY'S RADIO SYSTEM BY MOTOROLA SOLUTIONS, INC.

Recommendation: It is recommended that the City Council:

(1) Find that the proposed contract is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15061(b)(3);

(2) Authorize the Interim City Manager to enter into an annual purchase order with the City of Glendale for the monitoring, maintenance, and upgrades of the City's radio system by Motorola

Solutions, Inc., in an amount not-to-exceed \$327,704 per year, or the grand total amount of \$1,802,119 for the six-year period beginning July 1, 2022 to June 30, 2028. Neither competitive bidding nor competitive selection are required pursuant to City Charter Section 1002(H), and Pasadena Municipal Code Section 4.08.049(A)(3), contracts with other governmental entities; and

(3) Authorize the City Manager to execute future annual purchase orders beginning July 1, 2028 for monitoring, maintenance, and upgrades to the City's radio system, for as long as the City is a member agency of the Interagency Communications Interoperability (ICI) system.

AUTHORIZATION TO ENTER INTO A CONTRACT WITH PRESIDIO NETWORKED SOLUTIONS GROUP, LLC TO IMPLEMENT A MOBILE WORKFORCE MANAGEMENT SOLUTION IN AN AMOUNT NOT-TO-EXCEED \$160,188

Recommendation: It is recommended that the City Council:

(1) Find that the proposed contract is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15061(b)(3); and

(2) Authorize the Interim City Manager to enter into a one-year contract, as a result of a competitive selection process, as specified by Section 4.08.047 of the Pasadena Municipal Code, with Presidio Networked Solutions Group, LLC for the implementation of a Mobile Workforce Management Solution in an amount not-to-exceed \$160,188, which includes a ten percent contingency. Competitive Bidding is not required pursuant to the City Charter Section 1002(F), contracts for professional or unique services. (Contract No. 32298)

PURCHASE ORDER AWARD TO TRIANGLE SPORTS, INC., FOR PROGRAM AND EVENT TROPHIES, MEDALS AND AWARDS NOT-TO-EXCEED \$117,909

Recommendation: It is recommended that the City Council:

(1) Find that the proposed action is not a "project" subject to the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15378(b)(2), and as such, no environmental review is required;

(2) Accept the bid dated December 22, 2021 submitted by Triangle Sports, Inc., to furnish trophies, medals and awards, and authorize the Interim City Manager to enter into a contract with Triangle Sports, Inc., in an amount not-to-exceed \$117,909 over a three-year period; and

(3) Authorize the City Manager to extend the purchase order for up to two additional one-year terms in the annual amount of \$39,303 at the sole discretion of the City Manager, for a maximum total contract length of five years and grand total contract amount not-to-exceed \$196,515, if all options are exercised.

AUTHORIZATION TO AMEND PURCHASE ORDER 1221661 WITH MAXIM HEALTH NURSING SERVICES HOLDINGS, INC., INCREASING THE NOT-TO-EXCEED AMOUNT BY \$100,000 FROM \$74,999 TO \$174,999 FOR NURSING SERVICES

Recommendation: It is recommended that the City Council:

(1) Find that the recommended action is not a project subject to the California Environmental Quality Act (CEQA) pursuant to Section 21065 of CEQA and Sections 15060(c)(2), 15060(c)(3), and 15378 of the State CEQA Guidelines, and as such, no environmental document pursuant to CEQA is required for the project;

(2) Authorize an amendment to Purchase Order 1221661 with Maxim Health Nursing Services Holdings, Inc., (Maxim Health), increasing the value of \$74,999 by \$100,000 to a revised not-to-exceed amount of \$174,999 for the duration of FY2022; and

CONTRACT AWARD TO NOHO CONSTRUCTORS FOR McKINLEY SCHOOL PICKLEBALL AND TENNIS COURTS PROJECT FOR AN AMOUNT NOT-TO-EXCEED \$217,625

Recommendation: It is recommended that the City Council:

(1) Find the contract proposed in the agenda report to be categorically exempt under the California Environmental Quality Act (CEQA) pursuant to Title 14, Chapter 3, Article 19, Section 15301, Class 1 – Existing Facilities, and that there are no features that distinguish this project from others in the exempt class, and therefore, there are no unusual circumstances;

(2) Authorize the Interim City Manager to enter into an Addendum to the Joint Use Facilities Agreement (No. 13,991-5) with Pasadena Unified School District for the improvements and use of the McKinley School Sports Courts; and (<u>Contract No. 13,991-20</u>)

(3) i) Accept the bid dated May 19, 2022, submitted by NoHo Constructors in response to the plans and specifications for the McKinley School Pickleball and Tennis Courts project, and ii) authorize the Interim City Manager to enter into a contract for an amount not-to-exceed \$217,625, which includes the base contract amount of \$174,100 and a contingency of \$43,525 to provide for any necessary change orders. (Contract No. 32294)

CONTRACT AWARD TO CYBERTECH CONSTRUCTION COMPANY, INC., FOR FIRE STATION 38 RENOVATION AND SEISMIC RETROFIT FOR AN AMOUNT NOT-TO-EXCEED \$1,608,721

Recommendation: It is recommended that the City Council:

(1) Find the contract proposed in the agenda report to be categorically exempt under the California Environmental Quality Act (CEQA) pursuant to Title 14, Chapter 3, Article 19, Section 15301, Class 1 – Existing Facilities, and there are no features that distinguish this project from others in the exempt class, and therefore, there are no unusual circumstances; and

(2) i) Accept the bid dated March 1, 2022, submitted by Cybertech Construction Company, Inc., in response to the plans and specifications for Fire Station 38 – Renovation and Seismic Retrofit project, ii) reject all other bids received, and iii) authorize the Interim City Manager to enter into a contract for an amount not-to-exceed \$1,608,721, which includes the base contract amount of \$1,398,888 and a contingency of \$209,833 to provide for any necessary change orders. (Contract No. 32295)

AUTHORIZATION TO ENTER INTO A THREE-YEAR CONTRACT WITH VITAL MEDICAL SERVICES, LLC TO PROVIDE NON-EMERGENCY MEDICAL SERVICES TO INMATES FOR AN AMOUNT NOT-TO-EXCEED \$832,000

Recommendation: It is recommended that the City Council:

(1) Find that the proposed contract is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15061(b)(3) (Common Sense Exemption);

(2) Authorize a three-year contract with Vital Medical Services, LLC for an amount not-to-exceed \$832,000, which includes a 10% contingency of \$76,000, to provide non-emergent medical services to inmates housed in the Pasadena City Jail. Competitive Bidding is not required pursuant to the City Charter Section 1002(F), contracts for professional or unique services; and

(3) To the extent this could be considered a separate procurement subject to the Competitive Selection Process, it is further recommended that the City Council grant the contract an exemption from the Competitive Selection Process pursuant to Pasadena Municipal Code Section 4.08.049(B), contracts for which the City's best interests are served. Recommendation: It is recommended that the City Council:

(2) Adopt a resolution approving the Fiscal Year (FY) 2023 General Fee Schedule. (Resolution No. 9917)

LEGISLATIVE POLICY COMMITTEE: AMENDMENT OF THE 2022 STATE LEGISLATIVE PLATFORM REGARDING MENTAL HEALTH AND BEHAVIORAL HEALTH

Recommendation: It is recommended that the City Council:

(1) Find that the proposed action is categorically not subject to the California Environmental Quality Act (CEQA) pursuant to Section 21065 of CEQA and Sections 15060(c)(2), 15060(c)(3), and 15378 of the State CEQA Guidelines, and as such, no environmental document pursuant to CEQA is required; and

(2) Amend the 2022 State Legislative Platform to include support for legislation which supports efforts to improve access to programs and services for mental and behavioral health, including frameworks that help people with mental health and substance use disorders get care and support.

Legislative Policy Committee Recommendation: At its May 24, 2022 meeting, the Legislative Policy Committee recommended the City Council approve the staff recommendation to amend the 2022 State Legislative Platform as described in the agenda report. The Committee also discussed adding similar language to the Federal Legislative Platform. Staff conferred with the City's Legislative Advocate and confirmed there are no active bills in Congress related to mental and behavioral health. Staff will continue to monitor Federal legislation, and will return to the Council with Federal Legislative Platform recommendations in the future.

CONTRACT AWARD TO ALL CITY MANAGEMENT SERVICES, INC., FOR CROSSING GUARD SERVICES AT SELECT PASADENA UNIFIED SCHOOL DISTRICT SITES

Recommendation: It is recommended that the City Council:

(1) Find that the proposed action is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15061(b)(3) the "Common Sense" rule that CEQA only applies to projects that may have an effect on the environment; and

Councilmember Hampton raised several questions regarding determining the locations for placing crossing guards and thanked staff for working with PUSD to promote school safety. In response, Brenda Harvey-Williams, Director of Parks, Recreation & Community Services (PRCS), stated the City works closely with PUSD and parents crossing guard placement, and confirmed that the proposed contract budget allows for additional crossing guards, if needed.

ECONOMIC DEVELOPMENT AND TECHNOLOGY COMMITTEE: UTILIZATION OF PUBLIC RIGHT-OF-WAY FOR OUTDOOR DINING

Economic Development and Technology Committee Recommendation: On June 1, 2022, staff presented this report to the City Council's Economic Development and Technology Committee (EDTech). EDTech supported the staff recommendations, but proposed changes to standardize and simplify the two base fees for all business improvements districts, at \$12.00 and at \$7.75 per square foot per year, for sidewalk/public alley and for on-street dining permit fees, respectively. Brian Wallace, representing the Playhouse Village, expressed concerns with the proposed sidewalk dining fees, citing various challenges experienced by restaurants, and requested waving fees for spaces that are used for public benefit such as public seating.

Following discussion, the Interim City Manager stated that staff will work with the Economic Development and Technology Committee and the various districts to further review where it might be appropriate to utilize the public right-of-way as outdoor seating and address the matter surrounding liability, maintenance, design, etc.

Arrian Torkian, Los Angeles resident, expressed concerns with the proposed ordinance amending Exhibit 2, Page 18, No. 8. "Unit Mix. For projects west of Hill Avenue with 50 dwelling units or more, inclusive of any density bonus, at least 20 percent of the total number of units shall have a minimum of 3 bedrooms", stating he believes the requirement will have an adverse impact and unintended consequences that would reduce the total number of affordable units included in a project, and urged the City Council to review this item and remove any unit mix restrictions within the updated Specific Plan.

Mark Jomsky, City Clerk, reported on correspondence regarding the Interim City Manager's Fiscal Year (FY) 2023 Recommended Operating Budget: one letter advocating for additional funding to the City Attorney Department to support the Community and Police Oversight Commission's training; seven letters advocating for additional funding for the Health Department for non-police violence intervention and prevention, and mental health support services; nine letters advocating for the City to provide additional funding to the Housing Department to provide low cost housing, rental assistance, interim shelters, and tenant protection services; three letters advocating for additional funding for Parks, Recreation and Community Services Department to for youth summer employment programs. summer camps, and Pasadena Veterans Dav programming; eight letters expressing concerns with the increase to the Pasadena Police Department's budget, advocating for accountability and transparency related to PPD's budget; seven letters advocating for additional funding for the Public Works Department for watering of public street trees; nineteen letters expressing concerns with the Rose Bowl Deficit and advocating for the City to not provide additional funding towards the Rose Bowl debt; three letters advocating for transparency and a complete analysis related to the Rose Bowl Operating Company's budget, and/or eliminating the cap on the Rose Bowl Admission Tax; twenty-three letters in support of Rose Bowl Stadium, advocating for the City to identify and consider implementing long-term funding sources to support the ongoing operating and maintenance expenses of the Rose Bowl: one letter in opposition to RBOC significantly altering the Rose Bowl Stadium, which is a National Historic Landmark; one letter advocating for the City to provide funding to the Transportation Department for non-carbon fueled transportation; fifteen letters advocating for the City to request additional funding for the "The Arroyo Link" (a proposal to create a multi-use path from downtown

Pasadena to the Arroyo Seco) as part of the Measure R Project list; and one letter expressing concerns with the City allocating funds to the Water & Power Department for the Arroyo Seco Canyon Project, with all correspondence received by the City Clerk's Office distributed to the City Council, posted on-line, and made part of the public record for this item.

Sonja Berndt, Pasadena resident, spoke on the underfunding of City departments that provide essential services and critical programs for the poorest residents of the City, and expressed concerns and opposition to the proposed Pasadena Police Department budget, as well as the City diverting money from the General Fund to pay Rose Bowl bond debt.

(2) Approve the Annual Action Plan, including the funding allocations set forth therein for Program Year 2022-2023 program activities under the Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), and HOME Investment Partnerships (HOME) programs, for submittal to the U.S. Department of Housing and Urban Development (HUD);

<u>PUBLIC HEARING</u>: DESIGNATION OF THE JOSEPHINE P. EVERETT HOUSE/SHAKESPEARE CLUB OF PASADENA AT 171 SOUTH GRAND AVENUE AS A HISTORIC MONUMENT

Recommendation: It is recommended that the City Council:

(1) Find that the designation of a historic resource is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15308, Class 8 of the CEQA Guidelines pertaining to Actions by Regulatory Agencies for Protection of the Environment and there are no features that distinguish this project from others in the exempt class, and therefore, there are no unusual circumstances;

(2) Find that the building at 171 South Grand Avenue meets Criterion 2 and 3 for designation as a Historic Monument pursuant to Pasadena Municipal Code (PMC) Section 17.62.040.C.1.c.(2) and (3) because it is associated with the life of a person who is significant to the history of the region and beyond, Josephine P. Everett, and is an exceptional representation of the work of an architect whose work is significant to the region, Marston & Maybury;

(3) Adopt a resolution approving a Declaration of Historic Monument Designation for 171 South Grand Avenue, Pasadena, California; (<u>Resolution No. 9918</u>)

(4) Authorize the Mayor to execute the Declaration of Historic Monument Designation for 171 South Grand Avenue, Pasadena, California (attached to the resolution); and

(5) Direct the City Clerk to record the declaration with the Los Angeles County Recorder.

Recommendation of the Historic Preservation Commission: At its regular meeting of March 15, 2022, the Historic Preservation Commission recommended that the City Council approve the designation of the Josephine P. Everett House/Shakespeare Club of Pasadena at 171 South Grand Avenue as a Historic Monument under Criteria 2 and 3 of PMC Section 17.62.040.

City Clerk Jomsky opened the public hearing; reported that 12 copies of the public hearing notice were posted and 275 copies of the public hearing notice were mailed on March 27, 2022. He also reported that one letter in support of the staff recommendation, was received by the City Clerk's Office, distributed to the City Council, posted on-line, and made part of the public record for this item.

Councilmember Madison expressed his thanks and gratitude to staff and the Shakespeare Club for brining this item forward and spoke in support of the designation of the Shakespeare Club of Pasadena as a Historic Monument.

Recommendation: It is recommended that the City Council:

(1) Find that the non-exclusive Solid Waste Collection Franchise System Ordinance is exempt from the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 15061(b)(3);

(2) After closure of the public hearing, grant renewal of a nonexclusive franchise to 20 existing franchises from the date of execution through June 30, 2023, with up to four, one-year renewal terms at the sole discretion of the City Manager, consistent with the Solid Waste Collection Franchise Ordinance. The franchisees shall have no vested or contract rights in any of the four additional, oneyear renewal terms;

(3) Direct the City Attorney to prepare the necessary ordinances for the approved applications and authorize the Interim City Manager to enter into the franchise agreements on or after the effective date of the ordinance approving such franchises; and

(4) Adopt a resolution setting the minimum levels and standards of liability insurance for non-exclusive solid waste collection franchises. (Resolution No. 9919)

OLD BUSINESS MUNICIPAL SERVICES COMMITTEE: PREPARATION OF AN ORDINANCE AMENDING CHAPTER 8 OF THE PASADENA MUNICIPAL CODE REQUIRING THE ELECTRIFICATION OF BUILDINGS IN CERTAIN SPECIFIC CATEGORIES

<u>Recommendation</u>: It is recommended that the City Council:

(1) Adopt the Environmental Determination that the proposed project is exempt from environmental review pursuant to the guidelines of the California Environmental Quality Act (CEQA) (Public Resources Code § 21080(b)(9); Administrative Code, Title 14, Chapter 3, § 15308, Class 8, Actions by Regulations for the Protection of the Environment);

(2) Direct the City Attorney to prepare an ordinance and return within 60 days amending the Pasadena Municipal Code by amending Title 8, Health and Safety Code requiring the electrification of buildings in certain specific categories; and

(3) Consider the proposed electrification requirements as recommended by staff in the agenda report, and direct staff to return to the City Council within one year of the effective date of an ordinance to review implementation and consider broadening the scope to include single-family residences, accessory dwelling units (ADU), and junior accessory dwelling units (JADU).

Environmental Advisory Commission (EAC) Recommendation: The proposed building electrification requirements were presented to the Environmental Advisory Commission (EAC) on May 10, 2022. The EAC supports the proposed ordinance, although they did recommend broadening the scope to include newly constructed single-family residences, accessory dwelling units (ADU) and junior accessory dwelling units (JADU).

As noted, the EAC is recommending that the requirements be expanded to include single-family and ADU's. This is not the staff recommendation at this time based on a few reasons. First, staff recognizes that multi-family and commercial projects are most often designed and constructed by industry professionals who are prepared for code changes such as these and have experience in designing and permitting to new code requirements. Staff would like to establish and monitor the process with this segment of projects before extending this to single-family and ADU projects that are most often permitted by a non-professional homeowner. Second, the City of Pasadena received a grant from the Southern California Association of Governments (SCAG) to assess the City's ADU permitting processes to remove barriers and to identify where improvements can be made to accelerate ADU production. To avoid any conflicts with this program, ADU's should be exempt from additional regulations until completion of the project, which is

anticipated to wrap up in the Fall of 2022. Lastly, in January 2023 the State Building Code will be amended to require that single-family construction be "electric ready" meaning it is constructed so that it can be converted to all-electric should this be a choice of the homeowner. This would set-up future single-family residences to be prepared for, and designed as, all-electric when the City's requirements go into place rather than requiring homeowners to redesign their projects in advance of these changes at a substantial cost and time delay.

Mark Jomsky, City Clerk, reported that the City Clerk's Office received fifteen letters (including one letter from sixteen individuals representing local organizations) in support of a comprehensive, allelectric building code for new construction; one letter in support of the staff recommendation; and one letter requesting information related to the impacts when comparing electricity to natural gas, noting concerns with possible black-outs and the City's ability to generate adequate electricity, with all correspondence distributed to the City Council, posted on-line, and made part of the public record for this item.

David Reyes, Director of Planning, provided introductory comments, and Ron Takiguchi, Building Official, and Guille Nunez, Management Analyst V, presented y6a PowerPoint presentation on the item, with all responding to questions.

Following discussion, David Reyes, Director of Planning, responded to questions related to requirements for outdoor gas barbeques/grills for new multi-family units, stating that staff will further review the matter and report back to the City Council on whether to broaden the scope to include single-family residences, accessory dwelling units (ADU's), and junior accessory dwelling units (JADU's), within oneyear of the effective date of the ordinance.

Councilmember Rivas thanked the members of the public that spoke on the importance of addressing the current climate emergency, noted her support to include new single-family residences, ADU's and JADU's as part of the ordinance requirements, and suggested staggering the timeline/effective date for residents as a way to minimize some of the ordinance's impacts on residents. Alternatively, if there was not support for this approach, she suggested that the City Council direct staff to report back sooner than one year with the requested analysis on single-family residence, ADU and JADU projects, with staff to analyze and review jurisdictions in Northern California that have implemented similar regulations.
Councilmember Kennedy expressed his support for a measured approach, allowing staff to complete the due diligence analysis, and direct any changes or alternative recommendations for review by the Environmental Advisory Commission (EAC), stating his support for the staff recommendation as presented.
It was moved by Councilmember Hampton, seconded by Councilmember Kennedy, to move the staff recommendation.
Following discussion, in response to questions related to outreach and education on the proposed electrification ordinance, the Interim City Manager stated that pending first reading of the ordinance tonight, staff will begin education and outreach immediately, as permitted by the ordinance.
Following discussion, Councilmember Hampton requested as part of the review on outdoor gas barbeques/grills to include an analysis on electrification vs. propane gas and natural gas for outdoor barbeques/grills.
Councilmember Rivas suggested a friendly amendment to the motion setting the implementation/effective date to occur within 30 days after publication of the ordinance.

Michael Williams, Pasadena resident, expressed concerns with the Pasadena Police Department and advocated for the termination of Pasadena Police Officers Dumaguindin and Serrano involved in the shooting of Anthony McClain, stating the officers violated multiple Pasadena policing polices.

Gabriel Lizardo, Pasadena resident, questioned why public comment time was being reduced to two minutes, and spoke on the June 7, 2022 election voter turnout, and expressed concerns that there were no vote centers/polling sites and/or drop boxes in Council District 2.

Alisha Lopez, representing Day One, spoke on DUI prevention efforts in partnership with Rethinking Alcohol and Other Drugs (RAD) Coalition; and thanked several Pasadena bars and restaurants for their participation in this educational effort to reduce drunk driving.

Sharon Washington, representing Harvest Rock Reformers Salt and Light, spoke in opposition to the resolution adopted by the Pasadena City Council in support of Planned Parenthood and abortion access, noting she represents almost 300 people who signed a petition for revocation of the adopted resolution.

Bert Newton, representing Making Housing and Community Happen, expressed concerns with the City's ability to meet required Regional Housing Needs Assessment (RHNA) goals, and urged the City Council to consider the issue of affordable housing on religious lands/facilities at the July 11, 2022 meeting.

Councilmember Madison congratulated Councilmembers Kennedy, Rivas, and Councilmember-elect Lyons for their successful election to the City Council; provided a recap on the retirement events honoring Daryl Dunn, CEO and General Manager at Rose Bowl Operating Company, noting he spoke on behalf of the City Council in congratulating Mr. Dunn for his many accomplishments and years of service.
