Dear Mayor Gordo and Pasadena City Council Members:

I am a 26-year resident of District 3 and a lifelong Pasadena resident. While I am not outwardly involved with City public policy issues on a day-to-day basis, I do closely watch what is going on in our cherished City and I participate from the background. By way of my interests and profession, issues that I stay closest to include housing, land use, economic & human capital development, and youth sports.

District 3 (and the entire City) was stunned by the unexpected passing of John Kennedy this past July. I am still in disbelief over his passing - John is irreplaceable and he was a "champion" for D3. 
