Vice Mayor Wilson spoke on the Transportation Department's reevaluation of the intersection on San Pasqual Street and Allen Avenue, and announced that he will conduct a neighborhood walk to see what other traffic safety improvements suggestions might be made to City staff.

Councilmember Hampton requested that the Public Safety Committee agendize a discussion on reducing the speed limit in residential neighborhoods and increasing enforcement. He expressed concerns with the process of the administrative review related to the officer involved shooting of Anthony McClain and requested confirmation that the Pasadena Police Officer's Administrative review policy will be presented to the City Council in January 2022.

## CONTRACT AWARD TO FS CONTRACTORS, INC., FOR CITYWIDE TREE PLANTING SERVICES FOR A GRAND TOTAL AMOUNT NOT-TO-EXCEED \$1,679,040 FOR UP TO SIX YEARS

**Recommendation:** It is recommended that the City Council: (1) Find the project (Citywide Tree Planting Services) to be categorically exempt under Section 21084(a) of the California Environmental Quality Act ("CEQA") in accordance with Article 19, Section 15301 (Class 1), Subsection (h) of the guidelines (maintenance of existing landscape); and

(2) Accept the bid dated October 5, 2021 submitted by FS Contractors, Inc., in response to project specifications for citywide tree planting; reject all other bids received; authorize the City Manager to enter into a four-year contract not-to- exceed \$1,119,360, which includes the base contract amount of \$1,017,600 and a contingency of \$101,760 to provide for any necessary change orders; and authorize the City Manager to extend the contract for up to two additional one-year terms not-to-exceed an annual amount of \$279,840 per year (including contingency amount of \$25,440), subject to the approval of the City Manager, for a maximum total contract amount of \$1,679,040 over a maximum contract length of six years inclusive of consumer price index increases. (Contract No. 32196)

In response to Vice Mayor Wilson's inquiry related to staff partnering with Pasadena Beautiful, Eric Mirzaian, Public Works Administrator, reported that Pasadena Beautiful Foundation and City staff work in conjunction to plant trees; and responded to questions. AUTHORIZE PURCHASE ORDER WITH REXEL USA, INC., TO FURNISH LAMPS, FIXTURES, BALLASTS AND OTHER LIGHTING ACCESSORIES FOR THE CITY IN A GRAND TOTAL AMOUNT NOT-TO-EXCEED \$370,000 FOR UP TO FIVE YEARS Recommendation: It is recommended that the City Council:

(1) Find that this action is exempt under the California Environmental Quality Act (CEQA) in accordance with Section 15061(b)(3), the General Rule that CEQA only applies to projects that may have an effect on the environment; and

(2) Accept the bid dated October 21, 2021, submitted by Rexel USA, Inc. (Rexel) to furnish lamps, fixtures, ballasts and other lighting accessories for the City; reject all other bids received; and authorize a purchase order with Rexel for an amount not-to-exceed \$222,000 over a three-year period with the option for two additional one-year extensions in the annual amount of \$74,000, at the discretion of the City Manager, for a maximum total contract length of five years and a grand total contract amount of \$370,000.

Recommendation: It is recommended that the City Council:

(1) Find that the proposed contract is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15061(b)(3); and

(2) Authorize the Interim City Manager to enter into a three-year contract, as a result of a competitive selection process, as specified by Section 4.08.047 of the Pasadena Municipal Code, with Golden Star Technology Inc., for the purchase and installation of video conferencing technology in multiple City locations for an amount not-to-exceed \$361,167, which includes a ten percent contingency. Phillip Leclair, Chief Information Officer, provided information on the technology to be installed on City equipment (i.e. laptops, desktop computers) allowing for the participation in Zoom meetings; and responded to questions.

## AUTHORIZATION TO AWARD CONTRACT TO BRINKS INCORPORATED FOR ARMORED CAR AND COURIER SERVICES NOT-TO-EXCEED \$300,000

Recommendation: It is recommended that the City Council:

(1) Find that the proposed action is not a project subject to the California Environmental Quality Act (CEQA) pursuant to Section 21065 of CEQA and Sections 15060(c)(2), 15060(c)(3), and 15378 of the State CEQA Guidelines and, as such, no environmental document pursuant to CEQA is required for the project; and

(2) Authorize the City Manager to enter into a contract with Brinks Incorporated as the result of a competitive selection process pursuant to Pasadena Municipal Code section 4.08.047 for three years in an amount not-to-exceed \$180,000, which includes the base contract amount of \$165,000 and a contingency of \$15,000 to provide for any necessary change orders at the discretion of the City Manager. The option for two additional one-year terms in an amount not-to-exceed \$120,000, which includes the base contract amount of \$110,000 and a contingency of \$10,000 to provide for any necessary change orders, for a total of \$300,000 for five-years. <u>City Manager</u>	<b>Recommendation:</b> It is recommended that the City Council: (1) Find that the Municipal Code Amendments are exempt from environmental review pursuant to provisions in Senate Bill 9 which explicitly state that an ordinance adopted by a local agency to implement provisions of SB 9 shall not be considered a project under Division 13 of the Public Resources Code (PRC) and State CEQA Guidelines Sections 15378 (not a project), 15301 (existing facilities) and 15303 (new construction/conversion of small structures);

(2) Adopt the Findings of Consistency with the General Plan (Attachment A to the agenda report); and

(3) Adopt an interim urgency ordinance for single-family (RS) zoned properties pertaining to development standards for the construction of multiple primary dwellings (duplexes) pursuant to Senate Bill 9.

**Recommendation of the Legislative Policy Committee:** The Legislative Policy Committee received an overview of Senate Bill 9 on September 28, 2021. Committee members expressed concern related to the potential impacts to the City's single-family neighborhood character and support for developing local regulations that comply with Senate Bill 9 in order to minimize possible impacts to affected neighborhoods.

**Recommendation of the Urban Forestry Advisory Commission** and Planning Commission: The Urban Forestry Advisory Commission (UFAC) and Planning Commission both held study sessions on November 10, 2021. UFAC members discussed concerns over the bill and impacts to the City's urban forest as a result. They suggested strengthening existing provisions of the Tree Protection Ordinance to ensure that preservation of existing trees remains a priority. The Planning Commission members discussed the issues at length and also expressed concern over the possible impacts to single-family neighborhoods and the context/character of the development patterns that exist. The Commission suggested that the following regulations be included:

- Retention of protected trees and mature trees to the maximum extent possible and supported the required planting of new trees;
- Consideration of requiring affordability requirements for the new units - this ranged from requiring all the new units to be affordable to applying the City's 20% inclusionary to SB 9 units;
- Consideration of an updated citywide historic survey and exemptions to the regulations for historic districts;
- · Investigation into a citywide historic overlay;
- Consideration of requiring open space to be calculated as a percentage of lot area, not including front yard requirements;
- Consideration of exempting parcels located within Specific Plan Areas; and
- Consideration of stronger owner-occupancy requirements

Interim City Manager Kurtz stated that the staff recommendation provides a method for the City to implement Senate Bill 9 (SB9) that is consistent with the City's rules. David Reyes, Director of Planning and Community Development, provided introductory comments, and Martin Potter, Planner, presented a PowerPoint presentation on the item, with all responding to questions. City Clerk Jomsky, reported that 43 letters in support of an interim urgency ordinance, and/or in opposition to SB9; two letters advocating for the creation of a Madison Heights Historic Landmark District; and one letter in support of SB9, were received by the City Clerk's Office, distributed to the City Council, posted on-line, and made part of the public record for the item.

Councilmember Madison expressed concerns with the language of the proposed ordinance, which he finds to be unnecessarily inflammatory. Specifically paragraphs two and three of the proposed ordinance (first and second "recitals"); page 3, second paragraph (fifth recital). He recommended removing the last sentence, "Pasadena is in the position of being forced to quickly address the numerous shortcomings of SB 9 through the adoption of such objective standards...," and page 3, fourth paragraph that includes language on SB9 that undermines the City's initiatives to have diverse housing. He believes the language may give the wrong impression to decision makers at the state level and elsewhere.

Michele Beal Bagneris, City Attorney/City Prosecutor, provided information on the proposed recitals that are helpful for the urgency determination findings referenced on page 3; and responded to questions.

Theresa Fuentes, Assistant City Attorney, recommended amending the second recital (page 1) and remove "However, the provisions of SB 9 are likely to undermine the many efforts that Pasadena and other likeminded progressive cities have undertaken in recent years to increase housing supply near transit as part of a more holistic community planning strategy, while maintaining the unique character of our established neighborhoods" and "SB 9 as enacted does not address the concerns of the City of Pasadena." In addition she also recommended editing the third recital (page 2) to include "Despite the City's expressed opposition, the City is seeking to comply with SB 9; and the fifth recital (page 3) amended as follows: WHEREAS, pursuant to SB 9, local agencies may adopt objective standards for the mandatory, ministerial lot splits and two-unit development projects so that the standards take effect before January 1, 2022. Pasadena must act quickly to address the numerous shortcomings of SB 9 through the adoption of such objective standards, as set forth in Exhibits 1-3."

Councilmembers Kennedy and Rivas spoke in favor of amending the ordinance to remove any adversarial or inflammatory language.

Per Councilmember Riva's request, Assistant City Attorney Fuentes summarized staff's recommended amendment to the ordinance as follows: keeping the language in the second recital that specifically addresses the City's concerns with impacts related to traffic, greenhouse gas emissions, air quality and other environmental factors; strike the reference to the league of California cities letter; In the fifth recital staff will seek to remove some of the inflammatory language.

Vice Mayor Wilson stated the following for the record, "I am disappointed that in terms of page 3, of the actions we've taken that we haven't moved more quickly on the congregational land. I actually had asked that we pick that back up in...I think it was about a year ago. So, I echo the community's desire to see what that would be. We really haven't had much conversation here at the City Council. I know you wanted to get the Housing Element update done first, but it has taken a long time and I think...I am hopeful there will be some capacity there as well." He asked staff to assist the proposed Madison Heights Landmark District with their landmark designation in a timely manner.
