A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASADENA AUTHORIZING THE SUBMITTAL OF AN APPLICATION TO THE CALIFORNIA HOUSING FINANCE AGENCY FOR FUNDING UNDER THE ADU GRANT PROGRAM, AND EXECUTION OF A STANDARD AGREEMENT IF APPROVED FOR SUCH FUNDING AND ANY AMENDMENTS THERETO; AND ANY RELATED DOCUMENTS NECESSARY TO PARTICIPATE IN THE ADU GRANT PROGRAM

WHEREAS, the City of Pasadena (the "City") wishes to apply for and receive reimbursement of funds through the ADU ("Accessory Dwelling Unit") Grant Program (the "Program");

WHEREAS, the California Housing Finance Agency (as "CalHFA") is chartered as the state's affordable housing lender; and

WHEREAS, the City implements an ongoing ADU loan program and wishes to submit an application with CalHFA to become a participating lender in the Program;

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Pasadena as follows:

Section 1. The City Council hereby approves the submission to CalHFA of an application to become a participating lender in the ADU Grant Program, which will allow reimbursement of up to forty-thousand dollars (\$40,000) for pre-development costs incurred by income-qualified homeowners who obtain a loan from the City to construct accessory dwelling units located in the City of Pasadena.

Section 2. If the application is approved, the City hereby agrees to submit for reimbursement eligible pre-development activities in the manner approved by CalHFA and in accordance with the ADU Lender Participation Agreement ("Standard Agreement"). The application in full is incorporated as part of the Standard Agreement. Any and all activities funded, information provided, and timelines represented in the application are enforceable through the Standard Agreement. The City acknowledges and agrees that it may be required to execute any and all other instruments necessary or required by CalHFA for participation as a lender in the ADU Grant Program.

Section 3. The City Council authorizes the City Manager to execute in the name of the City the application, the Standard Agreement, and any subsequent amendments or modifications thereto, as well as any other documents required by CalHFA for participation in the ADU Grant Program, and any amendments thereto.

Section 4. This Resolution shall take effect immediately upon its adoption.
