RECOMMENDATION: It is recommended that the City Council:

- (1) Find that the proposed action is exempt under the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15301 (Class 1- Existing Facilities) and that there are no features that distinguish this project from others in the exempt class, and therefore, there are no unusual circumstances;

CERTIFICATION OF SUFFICIENCY OF A CHARTER AMENDMENT INITIATIVE PETITION TO IMPOSE RENT CONTROL, CREATE A RENTAL HOUSING BOARD, AND ESTABLISH JUST CAUSE EVICTION CRITERIA IN PASADENA Recommendation: It is recommended that the City Council:

- (1) Find that the proposed actions are exempt from review pursuant to the California Environmental Quality Act ("CEQA") and in accordance with State CEQA Guidelines Section 15061(b)(3) (Common Sense Exemption);
- (2) Receive and accept the certification (Attachment A) of the sufficiency of a Charter Amendment Initiative Petition to Impose Rent Control, Create a Rental Housing Board, and Establish Just Cause Eviction Criteria in Pasadena, as confirmed by the examination and verification of signatures by the Los Angeles County Registrar-Recorder/County Clerk's Office;
- (3) If agreed, direct City staff to prepare a report on the impacts of the proposed initiative measure for presentation at the July 11, 2022 City Council meeting, or such other date as determined; and

INFORMATION ITEM

PREDEVELOPMENT PLAN REVIEW OF AN 81-UNIT MICRO-UNITS PROJECT AT 1501-1525 EAST WALNUT STREET

<u>Recommendation</u>: This report is intended to provide information to the City Council; no action is required.

David Reyes, Director of Planning and Community Development, provided introductory comments, and David Sinclair, Senior Planner, presented a PowerPoint presentation on the item, and all responded to questions.

Mayor Gordo and Vice Mayor Wilson expressed their support for the project and for creating diversity within the City's affordable housing stock.

Following a brief discussion, on order of the Mayor, and by consensus, the information was received and filed.

Mayor Gordo reported that on April 26, 2022, he traveled to Sacramento to meet with elected officials and agency staff members to discuss Senate Bill 9, and was reimbursed through City funds for airline travel expenses.

The following individuals spoke on the need to address accountability and transparency within the Pasadena Police Department; advocated for the termination of the Pasadena Police Officers (Dumaguindin, Serrano) involved in the shooting of Anthony McClain; expressed concerns with the Pasadena Police Department and the Department's community policing practices:

Michael Williams, Pasadena resident Kareena K, representing Black Lives Matter Los Angeles Janee Lenox, representing Black Lives Matter Los Angeles

Heavenly Hughes, representing My TRIBE Rise, invited the City Council to "Dena Juneteenth Celebration of Freedom 2022 on June 18, 2022"; expressed concerns and provided comments related to the Los Angeles County District Attorney's Office review of the officer involved shooting of Anthony McClain.

Jasmine Richards Abdullah, representing Black Lives Matter Pasadena, spoke on Eric Thomas, a Pasadena resident who was shot and killed on May 2nd, and requested that the Police Department release the body worn camera video of the officers who arrived at the scene, alleging the police officers did not timely administer aid to Mr. Thomas, and expressed concerns with the absence of grief counselors at the scene and in the community following the incident.

Following a brief discussion, the Mayor asked that information on the City's trauma response team and available resources be highlighted in the City Manager's newsletter, and requested that the City Manager connect with Mr. Thomas' family to provide them with information on available grief support services.
