CEREMONIAL MATTERS

PROCLAMATION IN RECOGNITION OF WOMEN'S HISTORY MONTH

Mayor Gordo presented a proclamation recognizing March 2022 as "Women's History Month," in the City of Pasadena. Beverly Morgan-Sandoz, Chair of the Commission on the Status of Women, and Ali Everett, Accessibility Coordinator, accepted the proclamation, provided information on Women's History Month honoring prominent woman of the past and present, and expressed appreciation to the Mayor, City Council and the community for the recognition.

PUBLIC HEARING

PUBLIC HEARING: EAST COLORADO SPECIFIC PLAN

Recommendation: It is recommended that the City Council:

- (1) Adopt the Addendum to the 2015 Pasadena General Plan Environmental Impact Report (EIR) along with the EIR, and find that the Addendum properly discloses only minor technical changes or additions to the EIR, and none of the conditions triggering a subsequent or supplemental EIR are present, as set forth in State CEQA Guidelines Section 15164:
- (2) Make the Findings for Approval for the General Plan Map Amendment, Specific Plan Amendment, and Zoning Code Map and Text Amendments:
- (3) Adopt a resolution approving the General Plan Map Amendment; (Resolution No. 9895)
- (4) Adopt a resolution approving the recommended East Colorado Specific Plan; and (Resolution No. 9896)

Direct the City Attorney to prepare an ordinance for the Zoning Code and Text Amendments within 90 days consistent with the provisions set forth in the agenda report.

PLANNING COMMISSION RECOMMENDATION:

On September 22, 2021, the Planning Commission unanimously recommended that the City Council approve the proposed East Colorado Specific Plan (ECSP), with the following recommended changes:

- Reduce minimum parking requirements in the College District and Gateway Subareas to 2 spaces per 1,000 square feet for certain uses, consistent with the updated Lincoln Avenue Specific Plan parking requirements;
- Revise street frontage land use requirements to allow residential uses along Green Street to maintain uniformity along the corridor:
- · Revise the land use table to allow drive-through uses in the Eastern Corridor Subarea with a conditional use permit and other limitations on the number and location of such uses;
- Revise the street setback requirement on Colorado Boulevard between Parkwood and Grand Oaks to 0-3' for 75% of the frontage; and
- Revise terminology in Policy 13.b. from "public open space" to "publicly accessible open space."

Staff refined the proposed ECSP that was presented to the Planning Commission to reflect feedback received. Refer to Attachment A in the agenda report for the recommended ECSP. The 2003 ECSP is also included as Attachment B of the agenda.

Mark Jomsky, City Clerk, opened the public hearing; reported that the

public hearing notice was published in the Pasadena Press and the Pasadena Journal on February 10, 2022, February 17, 2022, and February 24, 2022. He also reported that four letters in opposition to the staff recommendation, nine letters in support of the staff recommendation, and eleven letters providing comments on the matter were received by the City Clerk's Office, distributed to the City Council, posted on-line, and made part of the public hearing record.

David Reyes, Director of Planning and Community Development, provided introductory comments, and Anita Cerna, Principal Planner, presented a PowerPoint presentation on the item; and responded to questions.

Vice Mayor Wilson spoke on density issues and impacts occurring in the City due to increased development and housing units, and noted the need for additional park and recreation space for growing residential neighborhoods and population, and recommended that staff identify possible parklands/park space in the East Colorado Specific Plan (ECSP).

Councilmember Hampton connected and joined the meeting at 4:13 p.m.

Interim City Manager Cynthia Kurtz, provided information on an upcoming inventory report of city-owned land scheduled for presentation in March of 2022 to the Economic Development & Technology Committee that will focus on affordable housing, economic development, and open-space sites; and responded to questions.

Councilmember Williams made the following recommendations and comments:

- She recommended that staff conduct a "park needs assessment" for the ECSP, and determine how to fulfill those needs during specific plan buildout meetings;
- She asked staff to determine if the Mid-City Innovation District is able to increase the wet laboratory space to above forty-nine percent;
- She advocated for a citywide historic resource survey and to include survey inventory results as part of each specific plan, as well as incorporate Pasadena Heritage's suggestions to add historic resources to the ECSP;
- She proposed reducing the building heights in the Mid-City Innovation District, and reducing the maximum density for that area from 87 to 64 dwelling units per acre;
- She expressed concerns in relying on what she believes is an outdated General Plan as the basis for updating the City's specific plans, and suggested that staff update the General Plan in terms of density, how people move around the City, office space, and recognizing mixed-use zoning designations; and
- She expressed strong concerns with housing developments along the freeway, citing air quality issues.

Mayor Gordo recommended that staff consider increasing the delay period for demolition of properties located within a historic landmark districts to provide additional time and allow for the completion of the citywide historic resource survey.

Following discussion, Councilmember Williams spoke in support of the staff recommendation with the following amendments:

- Change allowed uses to include those for which landmarked historic buildings as shown on page 17 of the Specific Plan were originally designed, utilizing a Conditional Use Permit process:
- Reduce the proposed Mid-City Innovation District maximum residential density from 87 to 64; and
- Verify and include Pasadena Heritage's suggestions regarding the historic resources plan and add the historic resources list to the Specific Plan.

Mayor Gordo spoke in favor of the staff recommendation including the amendments recommended by Councilmember Williams, as he believes developers will benefit from the state density bonuses.

Councilmember Rivas stated that she does not support the reduction of the Mid-City Innovation District maximum residential density from 84 to 64, due to the need in housing in the City.

FORMATION OF THE CITY COUNCIL'S TASK FORCE ON EARLY CHILDHOOD DEVELOPMENT AND EARLY LEARNING

Recommendation of Mayor: It is recommended the City Council approve the formation of a Task Force on Early Childhood Development and Early Learning, as detailed in the agenda report.

Mayor Gordo summarized the agenda report as part of his oral presentation on the item, and responded to guestions. Mayor Gordo stated the following for the record, "These are not individuals that I went out and solicited. These are not my nominees. These are people who were identified by the working group that included Dr. Vignes. who are professionals."

Interim City Manager Cynthia Kurtz provided information on the demographics of the recommended appointees to the Task Force, and responded to questions.

Councilmember Kennedy requested the staff provide information on the demographics of children ages 0-5 years in Pasadena. He advocated for Pasadena's constituents to be well represented in the education bodies in the City.

PUBLIC HEARING: HISTORIC PRESERVATION ORDINANCE AMENDMENTS

Recommendation: It is recommended that the City Council:

- (1) Find that the proposed project is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15308, Class 8, of the CEQA guidelines pertaining to actions by regulatory agencies for the protection of the environment. The proposed amendments modify existing regulations that apply to the protection of historical resources;
- (2) Find that the proposed Zoning Code Text Amendments are in conformance with the goals, policies, and objectives of the General Plan;
- (3) Find that the proposed Zoning Code Text Amendments would not be detrimental to the public interest, health, safety, convenience, or general welfare of the City;
- (4) Approve the proposed Zoning Code Text Amendments to the Historic Preservation Ordinance as specified in the agenda report; and
- (5) Direct the City Attorney to prepare an ordinance within 60 days amending Title 17 of the Pasadena Municipal Code (Zoning Code), Chapter 17.62 (Historic Preservation) and Section 17.22.050.C (Restoration of a porte cochere).

HISTORIC PRESERVATION COMMISSION RECOMMENDATION:

The Historic Preservation Commission (HPC) conducted a public hearing on December 7, 2021 regarding these amendments and adopted the staff recommendation with the exception of two recommendations related to modifying the review of window replacements, along with the additional recommendation that historic resources surveys be expedited as soon as possible to identify eligible historic resources and districts.

PLANNING COMMISSION RECOMMENDATION:

On January 12, 2022, the Planning Commission held a public hearing to review the proposed amendments and adopted CEQA and Zoning Code Text Amendment findings with the following recommendations (with staff's responses):

- The City should notify property owners within landmark districts identified in future surveys that their properties are in potential landmark districts.
 As future surveys are conducted, staff will notify property
 - As future surveys are conducted, staff will notify property owners that their properties are in potential landmark districts and will provide information on the effects of landmark district designation.
- The City should pursue a city wide survey starting calendar year 2022.
 - Staff is currently exploring the scope and cost of a citywide survey and will be including a request for funding to begin the work in the FY2022 budget cycle if the work is directed by the City Council. Staff is also exploring additional funding opportunities such as CLG grants.

- To explore the possibility of extending the proposed 180-day delay period for proposed demolitions in eligible landmark districts by an additional 180 days if the neighborhood is actively pursuing landmark district designation and petition signatures.
 - Staff is in agreement with this recommendation and will propose a methodology for achieving this in the proposed ordinance.
- 4. Remove the proposed amendments regarding windows. The proposed amendments were to classify changes to two or more of an original window's design features, other than opening size, to a major project, which would trigger a Historic Resource Evaluation (HRE) for undesignated properties and HPC review for designated properties. Window changes affecting less than two of an original window's design features would not trigger a HRE for undesignated properties and would require staff review for designated properties.

Staff is not in agreement with this recommendation for the following reasons:

- The additional processing time associated with HREs and HPC reviews and the use of staff resources to process the applications;
- The HPC retains authority to call staff decisions for review should they have concern with a staff level decision

Mark Jomsky, City Clerk, opened the public hearing; reported that the public hearing notice was published in the <u>Pasadena Press</u> on February 14, 2022, February 17, 2022, and February 21, 2022; and, that four letters in support of the staff recommendation, and two letters expressing concerns related to preservation of historic resources, were received by the City Clerk's Office, distributed to the City Council, posted on-line, and made part of the public hearing record.

David Reyes, Director of Planning and Community Development, provided introductory comments, and Kevin Johnson, Principal Planner, presented a PowerPoint presentation on the item; and responded to questions.

Municipal Services Committee

CONSIDERATION OF PROHIBITING GAS-POWERED LEAF-BLOWING MACHINES

Recommendation: It is recommended that the City Council:

- (1) Find that the actions proposed in the agenda report are exempt from the California Environmental Quality Act (CEQA) in accordance with Section 15061(b)(3), the General Rule that CEQA only applies to projects that may have an effect on the environment; and
- (2) Direct the City Attorney to prepare an ordinance to amend Title 9 (Public Peace, Morals and Welfare), Chapter 9.37 (Leaf-Blowing Machines) of the Pasadena Municipal Code to prohibit the use of gaspowered leaf-blowing machines within Pasadena and related amendments.

Mark Jomsky, City Clerk, reported that twenty-five letters (with one letter representing twelve community organizations) in support, and one in opposition to the staff recommendation, were received by the City Clerk's Office, distributed to the City Council, posted online, and made part of the public record for the item.

David Reyes, Director of Planning and Community Development, provided introductory comments, and David Sinclair, Senior Planner, presented a PowerPoint presentation on the item; and responded to questions.

Councilmember Madison spoke in support of the staff recommendation, however, suggested that the matter be considered by the Environmental Advisory Commission.

Councilmember Hampton expressed concerns with Pasadena homeowners being held responsible for the leaf-blower violations and opposed having the City citing residents. He requested that the staff recommendation be amended so that citations and fines be directed to the landscape business owners who violate the City's leaf-blower restrictions.

Councilmember Rivas stated her preference that the City cite or fine property owners instead of landscape business owners.

Councilmember Kennedy recommended that in addition to citing/fining landscape business owners, staff should send a warning letter to the property owners who have retained landscape businesses that violate the City's leaf-blower ordinance.

Vice Mayor Wilson asked staff to track the number of complaints received on Sundays and holidays related to the use of leaf-blowers.

Councilmember Williams asked staff to report back to the City Council in 12 months providing information on complaints received related to leaf-blowers, including data on leaf-blowers used on holidays, and any documented issues related to the use of leaf-blowers on hardscape.

ORDINANCE - FIRST READING

Councilmember Madison asked staff to refer the matter to the Environmental Advisory Commission (EAC) for additional review and consideration.

Councilmember Hampton reiterated his concerns regarding lining compost bins with plastic bags, which he finds to be counterproductive to recycling; and asked staff to look at the City of Santa Monica's organic recycling program.

Interim City Manager Kurtz provided information on the status of the City of Santa Monica's organic recycling program, but noted that staff will review the work done in Santa Monica; and responded to questions.

Thanos Gauthier, Public Works Superintendent, summarized the EAC's discussion on organic recycling, and Tony Olmos, Director of Public Works, provided information on the proposed ordinance, with both responding to questions.

Christine Lenches-Hinkel, Pasadena resident, advocated for the City to amend its ordinance to allow Pasadena residents to self-haul/divert their food waste to community or neighborhood composting centers or self-compost.

Following discussion, the above ordinance was offered for first reading by Councilmember Madison, with direction to staff to forward the details of the proposed policy that will be used to implement the City's organic recycling program to the Environmental Advisory Commission and Municipal Services Committee to look at best practices:
