The regular meeting was convened and held virtually by videoconference/teleconference.

**OPENING:** Mayor Gordo called the regular meeting to order at 4:30 p.m.

**CEREMONIAL MATTERS** Mayor Gordo, Councilmembers Madison, Hampton, Masuda, and Williams spoke on the passing of Dr. Ross Selvidge, whose voluntary service included the Pasadena representative on the Burbank-Glendale-Pasadena Airport Authority, where he was first appointed in 2015 and served as Authority's President, Vice President and Secretary; member of the Planning Commission; member of the Rose Bowl Operating Company Board; and elected member to the Pasadena City College Trustee Board representing District 1. He was an advocate of the Pasadena Library system, and was an ardent community supporter in creating and later extending the voter-approved parcel tax that provides approximately 20% of the Pasadena library system's revenues. Mr. Selvidge served 27 years in the United States Navy, and was a long-time Pasadena resident that graduated

from John Muir High School, attended PCC (where he was a gymnast and earned degrees in Architecture and Systems Management), and earned his Ph.D. in Finance at the University of San Diego. The City Council expressed their condolences to Dr. Ross Selvidge's family and friends, and requested that the meeting be adjourned in his memory.

Interim Chief Clawson introduced and welcomed the new Sergeant-at-Arms, Sergeant Douglas Hamblin, and extended appreciation to Sergeant Joaquin Gurrola for his service.

Mayor Gordo presented a proclamation declaring October 2021 as "National Disability Employment Awareness Month" in Pasadena. Ali Everett, Accessibility Coordinator, spoke on this important issues, and introduced Andrea Jennings, Accessibility & Disability Commission Chair, who thanked the Mayor and City Council for the proclamation and recognition and spoke on this year's theme "Disability: Part of the Equity Equation." Isis McDonald, Civitan President and Sr. Director of Business and Employment Services at AbilityFirst, provided information on their annual Hire Up Pasadena Civitan Employer Recognition event, to be held on October 13, 2022 at Villa Esperanza Service Campus. It was noted that Civitan Pasadena will also present the Servant's Heart Award to Assemblymember Chris Holden for his support of individuals with intellectual and developmental disabilities.

Mayor Gordo presented a proclamation to Laura Rubio Cornejo, Director of Transportation, and members of Pasadena Complete Street Coalition and Day One, declaring October 2021 in Pasadena as "National Pedestrian Safety Month." Ms. Cornejo thanked the City Council for the recognition, and Day One and Pasadena Complete Streets Coalition for their partnership and collaboration. Ms. Cornejo invited the public to visit [www.WalktoberPasadena.org](http://www.WalktoberPasadena.org) and join in any of the Walktober events.

Councilmember Wilson spoke on the importance of pedestrian safety; and expressed his thanks and appreciation to City staff, Pasadena Complete Streets, and Day One.

### **AUTHORIZATION TO AMEND CONTRACT NO. 31830 WITH THE FID GROUP, DBA FRIENDS IN DEED FOR ADDITIONAL EMERGENCY SOLUTIONS GRANT PROGRAM FUNDING**

**Recommendation:** It is recommended that the City Council:

- (1) Find that the recommended actions are exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines per Section 15061(b)(3), the "common sense" provision that CEQA only applies to projects that may have an effect on the environment;
- (2) Authorize the City Manager to amend Contract No. 31830 with The FID Group, dba Friends In Deed, to increase the total contract value by \$25,000 through June 30, 2023 for a not-to-exceed amount of \$183,000 for emergency shelter services; (Contract No. 31830-4)
- (3) Authorize the City Manager to approve additional amendments to Contract No. 31830 such that, subject to additional funding, the total contract award may be increased by an additional \$25,000 for a not-to-exceed contract amount of \$208,000 and the contract term may be extended for up to one year through June 30, 2024; and
- (4) To the extent the amendments could be considered a separate procurement subject to the Competitive Selection Process, grant the contracts an exemption pursuant to Pasadena Municipal Code (PMC) Section 4.08.049(B), contracts for which the City's best interests are served. These transactions are exempt from competitive bidding per PMC Section 4.08.030 and City Charter Section 1002(F) based on contracts for professional or unique services.

**AUTHORIZATION TO AMEND CONTRACT NO. 21547 TO EXTEND SCHEDULE OF PERFORMANCE FOR INTERIOR REHABILITATION OF CENTENNIAL PLACE PROJECT**

**Recommendation:** It is recommended that the City Council:

- (1) Find that the recommended actions are exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines per Section 15061(b)(3), the "common sense" provision that CEQA only applies to projects that may have an effect on the environment; and

- (2) Authorize the Deferred Compensation Plan Administrator (Director of Finance) to extend the contract with Great-West Life & Annuity Insurance Company for three additional years, to provide Deferred Compensation Plan investment options, record keeping, and education services to plan participants; and

**Recommendation:** It is recommended that the City Council:

- (1) Find that the proposed action is not a project subject to the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 21065, 15060(c)(2), 15060(c)(3), and 15378, and as such, no environmental document pursuant to CEQA is required for the project;

(2) Accept the bid dated July 29, 2022, submitted by Al Asher & Sons, Inc., (“Asher”) in response to the Specifications for “Heavy Equipment Rental Services” for the Water and Power Department (“PWP”); authorize the City Manager or designee to enter into a Purchase Order (“PO”) with Asher for four years for an amount not-to-exceed \$400,000, whichever occurs first, with one optional extension of one-year for an amount not-to-exceed \$100,000, for a maximum PO amount not-to-exceed \$500,000; and

(3) Accept the bid dated July 18, 2022, submitted by Herc Rentals, Inc. (2) Accept the bid dated August 5, 2022, submitted by Hill Crane Service, Inc. (“Hill Crane”), in response to Specifications for Crane Services for Power Poles and Electrical Equipment for the Water and Power Department (“PWP”); reject all other bids received after contract execution; authorize the City Manager or designee to enter into a Purchase Order (“PO”) with Hill Crane for a period of three years or a maximum total amount not-to-exceed \$400,000, whichever occurs first.

**Recommendation:** It is recommended that the City Council:

(1) Find that the proposed action is not a project subject to the California Environmental Quality Act (“CEQA”) pursuant to Section 21065 of CEQA and State CEQA Guidelines Sections 15060(c)(2), 15060(c)(3), and 15378, and as such, no environmental document pursuant to CEQA is required for the project; and

(2) Accept the bid dated July 25, 2022, submitted by Control Air Enterprises, LLC (“Control Air”) in response to Specifications for Heating, Ventilation, and Air Conditioning (“HVAC”) Inspection and Maintenance Services for the Water and Power Department (“PWP”);

reject all other bids received after contract execution; authorize the City Manager or designee to enter into a contract with Control Air for an amount not-to-exceed \$360,000 or a period of four years, whichever occurs first, with the option for one additional extension of one year or an amount not-to-exceed \$90,000, whichever occurs first, at the discretion of the City Manager for a maximum contract length of five years or a total amount not-to-exceed \$450,000. **Recommendation:** It is recommended that the City Council:

- (1) Find that the proposed action is not a project subject to the California Environmental Quality Act ("CEQA") pursuant to Section 21065 of CEQA and Sections 15060(c)(2), 15060(c)(3), and 15378 of the State CEQA Guidelines, and as such, no environmental document pursuant to CEQA is required for the project; and

**PUBLIC HEARING**

**PUBLIC HEARING: DRAFT CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (2021-2022 PROGRAM YEAR) FOR PROJECTS FUNDED FROM COMMUNITY DEVELOPMENT BLOCK GRANT, EMERGENCY SOLUTIONS GRANT, AND HOME INVESTMENT PARTNERSHIP ACT**

**Recommendation:** It is recommended that upon close of the public hearing the City Council:

(1) Find that the recommended action is exempt from the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines per Section 15061(b)(3), the “common sense” provision that CEQA only applies to projects that may have a significant effect on the environment; and

(2) Approve the submission to the U.S. Department of Housing and Urban Development, of the Consolidated Annual Performance and Evaluation Report for projects funded in the 2021 Program Year under the Community Development Block Grant, Emergency Solutions Grant, and the HOME Investment Partnership Act programs which

assist low and moderate income individuals and families and address community development, affordable housing and homelessness needs.

Mark Jomsky, City Clerk, opened the public hearing; reported that the public hearing notice was published in the Pasadena Journal on September 29, 2022; and no correspondence was received by the City Clerk's Office on the matter.

William Huang, Director of Housing, provided a brief summary of the agenda item; and responded to questions.

Sonja Berndt, Pasadena resident, expressed concern that the proposed action does not address objectives for reducing and ending homelessness; and advocated for general fund and America Rescue Plan Act (ARPA) be used for interim housing in the City.

Jennifer O'Reilly-Jones, Program Coordinator III, responded to questions regarding the City's goals to address homeless matters, and provided additional information on the Homeless Overnight Shelter Program, weather-activated motel vouchers, and the Rapid Rehousing Programs.

In response to Councilmember Williams questions related to opportunities to expand sources of funding for the programs in the coming years, William Huang, Director of Housing, stated that the funding comes directly from HUD, while stating there are some opportunities on the homeless services side to apply for some additional funding opportunities, noting that the Department is in the process of exploring those opportunities.

Vice Mayor Wilson briefly commented on the Tiny Village Site Request for Information (RFI) process that is posted on the City's Plant Bids Website and anticipates further discussion on the matter.

**CONSIDERATION OF A RESOLUTION TO CONTINUE TO ALLOW THE CITY COUNCIL, ALL OF ITS SUBORDINATE BODIES, AND ALL OF ITS NON-PROFIT CORPORATION BOARDS AND THEIR SUBORDINATE BODIES, TO MEET REMOTELY PURSUANT TO THE BROWN ACT**

**Recommendation:** It is recommended that the City Council:

- (1) Find that the action in the agenda report is exempt from review pursuant to the California Environmental Quality Act (CEQA) in accordance with State CEQA Guidelines Section 15061(b)(3), the “common sense” exemption that CEQA only applies to projects that have the potential for causing a significant effect on the environment; and
- (2) Adopt A Resolution of the City Council of the City of Pasadena Authorizing Remote Teleconference Meetings of the City Council, all City subordinate bodies, and all City non-profit corporation Boards and their subordinate bodies, for the period October 3, 2022 through November 2, 2022. (Resolution No. 9953)

Mayor Gordo expressed his support for the City Council to resume in-person City Council meetings.

Councilmember Madison expressed his support to resume in-person meetings, but requested further information regarding opportunities for Councilmembers to continue to participate via video-conference technology (e.g. Zoom) when members are not be able to attend the meeting in-person (out of town, sick, etc.), noting that such participation would still comply with the Brown Act (post address on the agenda, allow public to participate at the remote location, etc.).

Councilmember Hampton and Vice Mayor Wilson requested additional information regarding to allow the public to participate both remotely and in-person, noting the additional accessibility remote meeting participation provides to working families, and community members with disabilities.

Following discussion, the City Council discussed options for hybrid meeting participation, which would allow the City Council and the public to attend meetings in the Council Chambers and others to attend virtually.

In response to the City Council comments regarding hybrid meetings, the City Manager, City Attorney and City Clerk spoke on potential challenges, further resources and staffing that may be needed to conduct hybrid meetings, and noted that Councilmembers would have to be in-person unless remote participation complied with the Brown Act, and.

Emanuel Najera, Pasadena resident, advocated for the City Council to meet in person, expressing that there is no justification for the City Council to continue meeting remotely.

Following discussion, the City Manager stated that staff would provide additional information to the City Council on October 24, 2022, on the feasibility for staff to support City Council meetings and/or the subordinate bodies of the City to allow public comment to be hybrid, addressing the overall cost, what additional resources and staff is needed to facilitate hybrid meetings, and information on the potential for the City Council to continue the use of a video-conference platform (e.g. Zoom), instead of the previous audio teleconference platform, when the occasion calls for a Councilmember to be out of town, sick, etc., but would like to participate in the meeting, and as stated, in compliance with the Brown Act provisions.
