CEREMONIAL MATTERS Mayor Gordo presented a proclamation recognizing October 16-22, 2022 as “National Friends of Libraries Week,” in the City of Pasadena. Tim McDonald, Interim Director of Library and Information Services, and Janice Segall, President of the Friends of the Pasadena Public Library, accepted the proclamation, acknowledged the work of the Friends of the Pasadena Public Library organization in supporting the City’s library system. Ms. Segall thanked the Mayor, City Council and Tim McDonald for recognizing the work of the Friends of the Library organization, and advocated for the passing of Measure L.

SPECIAL ITEMS **UPDATE BY FRANK MILLER, BURBANK-GLENDALE-PASADENA AIRPORT AUTHORITY, ON THE HOLLYWOOD BURBANK AIRPORT**

Frank Miller, Burbank-Glendale Airport Authority, presented a PowerPoint presentation providing an update on the project to build a to build a 14-gate 355,000 square foot replacement passenger terminal at the airport, and responded to questions.

PRESENTATION BY ASSEMBLYMEMBER CHRIS HOLDEN ON THE STATE OF THE STATE

Assemblymember Chris Holden welcomed Councilmember Jones and City Manager Márquez, and thanked Vice Mayor Wilson for his service to the City. He provided an overview of his work at the State Legislature, including as Chair of the Appropriations Committee, and

summarized the recent bills/laws adopted (infrastructure, funding schools and higher education, broadband infrastructure, and a clean transportation system); the Governor's 2022 State Budget (state infrastructure, transportation system, clean energy, housing goals, education, climate change, inflation relief, minimum wage, food banks, business tax credits, California Small Business Covid-19 Relief Grant program, homelessness, behavioral health challenges, neighborhood safety, and protections from impacts from wildfires and drought. Assemblymember Holden spoke on efforts to extend the Gold Line to Claremont and Montclair. He also highlighted several bills that he authored and coauthored (AB 257, Food facilities and employment; AB 1604, Civil service: the Upward Mobility Act of 2022; AB 2644, Custodial interrogation; AB 2773, Stops: notification by peace officers; AB 102, Pupil attendance at community colleges: College and Career Access Pathways partnership: county and offices of education; AB 2617, Pupil instructions: dual enrollment programs: competitive grants: College and Career Access Pathways partnership: best practices: communications and marketing strategy; AB 2446, Embodied carbon emissions: construction materials; and highlighted his support for AB 1740, Muratsuchi. Catalytic converters; and AB 1613, Irwin. Theft: jurisdiction).

Assemblymember Holden announced that the State Legislature and Governor included \$5,000,000 for the Central Library seismic retrofit project and \$3,000,000 for the Rose Bowl for improvements and maintenance issues as part of the State's adopted budget and presented two ceremonial checks to the City of Pasadena.

Mayor Gordo expressed thanks and appreciation to Assemblymember Holden; and highlighted AB 2723, Holden. Animals: microchips, noted the impact this issue had on one local resident, and thanked Assemblymember Holden for authoring the bill.

Vice Mayor Wilson expressed his thanks and appreciation to Assemblymember Holden; raised concerns regarding homelessness and addiction issues; spoke on the issue of homeless individuals using the transit system as a shelter, noting the resulting impact this has on ridership for many residents. The Vice Mayor also expressed concerns related to drought matters surrounding California and spoke on the urgency to address the State's water infrastructure problems now.

Councilmember Masuda thanked Assemblymember Holden for his support and commitment on the future of the Metro Gold Line extension to Claremont and Montclair, and eventually to Ontario.

PRESENTATION BY ARMINE SARGSYAN, OUTREACH ANALYST WITH THE COMMUNITY RELATIONS AND OUTREACH BRANCH, CALIFORNIA DEPARTMENT OF INSURANCE, ON SAFER FROM WILDFIRES FRAMEWORK

Armine Sargsyan, representing California Department of Insurance, presented a PowerPoint presentation on safer from wildfires framework.

On the order of the Mayor, and by consensus of the City Council, the above three informational items were received and filed.

**PUBLIC COMMENT ON
MATTERS NOT ON THE
AGENDA**

Luka Dowell, Pasadena resident, spoke on the Los Angeles City Council incident, spoke in support of Measure H and tenants' rights, noting the measure is fair for everyone, helps to avoid homelessness, and will be a positive impact on Pasadena.

Raul Ibanez, Pasadena resident, expressed disappointment with the lack of the Community Police Oversight Commission's (CPOC) inclusion in the selection process of the new Police Chief; stating that the City Council suggested the CPOC's involvement when the commission was formed, the City Manager's hands are not tied, and that the process of involving the CPOC is not prohibited under the City Charter. He expressed that failure to involve the CPOC and disclose procedural updates to the CPOC in regard to this hiring is a lack of due diligence and best practices; which may point to a lack of communication between the City Council and City Manager.

Allen Shay, Pasadena resident, spoke on the Anthony McClain officer involved shooting, noted that the District Attorney's (DA) report disputes the Pasadena Police's report in its original state, urged the City to avoid the corruption and lies similar to the Los Angeles City Council, and to pay attention to community voices.

Adriana Bautista, representing Black Lives Matter - Pasadena, provided comments related to the October 6, 2022, Community Police Oversight Committee (CPOC) meeting where the Independent Police Auditor (IPA) Richard Rosenthal, and guest speakers Inspector General (IG) Max Huntsman from The Los Angeles County Office of Inspector General and Assistant Inspector General (AIG) Django Sibley from The Office of the Inspector General for the Los Angeles Police Commission participated in the informational session on the process for conducting administrative reviews of critical incidents; and expressed disappointment that the CPOC has not been included in the Chief of Police hiring process.

Bert Newton, Pasadena resident, asked that as the City continues to plan the future of housing in Pasadena to consider the development of higher density neighborhoods, making affordable housing more feasible, reducing traffic, the City more walkable, and public transit more viable.

Recommendation: It is recommended that the City Council:

Recommendation: It is recommended that the City Council:

- (1) Find that the action in the agenda report is exempt under the California Environmental Quality Act (CEQA) in accordance with Section 15061(b)(3), the General Rule that CEQA only applies to projects that may have an effect on the environment; and

AUTHORIZATION TO AMEND CONTRACT NO. 31946 WITH AFFORDABLE GENERATOR SERVICES, INC., FOR A TOTAL AMOUNT NOT-TO-EXCEED \$622,750 FOR GENERATOR MAINTENANCE AND REPAIR SERVICES

Recommendation: It is recommended that the City Council:

(1) Find that the action in the agenda report is exempt under the California Environmental Quality Act (CEQA) in accordance with Section 15061(b)(3), the General Rule that CEQA only applies to projects that may have an effect on the environment;

(2) Authorize the City Manager to amend Contract No. 31946 with Affordable Generator Services, Inc. (AGS), by \$37,000 annually for generator maintenance and repair services; increasing the not-to-exceed amount to \$373,650 for the three-year term and increasing the not-to-exceed amount for the optional two one-year extensions to a revised amount of \$124,550 annually for a total not-to-exceed amount of \$622,750 for a five-year term if all options are exercised; and (Contract No. 31946-1)

(3) As this is not considered a separate procurement subject to the Competitive Bidding and Competitive Selection process, under City Charter Section 1002(F) grant the proposed exemption as the contract is for professional or unique services and grant the exemption under Pasadena Municipal Code (PMC) 4.08.049(B) as the contract is in the City's best interests are served.
