I'm writing to you regarding Agenda Item 19, the contract with Sapphire Solar.

The Paris Climate Agreement is an agreement between countries to limit GHG emissions to limit warming well below 2C and pursue efforts to limit warming to 1.5C [https://unfccc.int/process-and-meetings/the-paris-agreement/the-paris-agreement]. According to the IPCC SR5 report, the difference between 2C when compared to 1.5C is substantially more poverty, extreme heat, sea level rise, habitat loss, and drought. [https://www.ipcc.ch/sr15/]

Now quoting the Intergovernmental Panel on Climate Change (IPCC), an authoritative source on climate science,


"Global GHG emissions in 2030 associated with the implementation of Nationally Determined Contributions (NDCs) announced prior to COP26 would make it likely that warming will exceed 1.5°C during the 21st century. Likely limiting warming to below 2°C would then rely on a rapid acceleration of mitigation efforts after 2030. Policies implemented by the end of 2020 are projected to result in higher global GHG emissions than those implied by NDCs." and "This implies that mitigation after 2030 can no longer establish a pathway with less than 67% probability to exceed 1.5°C during the 21st century". [https://www.ipcc.ch/report/ar6/wg3/downloads/report/IPCC AR6 WGIII SPM.pdf]

"Reducing GHG emissions across the full energy sector requires major transitions, including a substantial reduction in overall fossil fuel use, the deployment of low-emission energy sources, switching to alternative energy carriers, and energy efficiency and conservation. The continued installation of unabated fossil fuel infrastructure will 'lock-in' GHG emissions." [https://www.ipcc.ch/report/ar6/wg3/downloads/report/IPCC\_AR6\_WGIII\_SPM.pdf]

"Without a strengthening of policies beyond those that are implemented by the end of 2020, GHG (greenhouse gas) emissions are projected to rise beyond 2025, leading to a median global warming of 3.2 [2.2 to 3.5] °C by 2100." [https://www.ipcc.ch/report/ar6/wg3/downloads/report/IPCC\_AR6\_WGIII\_SPM.pdf]

Now, referring to the following charts presented by the IPCC:

#### Global and regional risks for increasing levels of global warming



\* Mortality projections include demographic trends but do not include future efforts to improve air quality that reduce occur concentrations.

We can see that at 3.2C of warming there is a very high likelihood of unique and threatened systems, extreme weather events, distribution of impacts, and at least a high probability of global aggregate impacts and large scale singular events. Further, a very high likelihood of heat-related morbidity and mortality, and ozone-related mortality. [https://www.ipcc.ch/report/ar6/wg2/downloads/report/IPCC\_AR6\_WGII\_SummaryForPolicymakers.pdf]

#### **Examples of key risks of climate change to North America are:**

- "Climate-sensitive mental health outcomes, human mortality and morbidity due to increasing average temperature, weather and climate extremes, and compound climate hazards
- Risk of degradation of marine, coastal and terrestrial ecosystems, including loss of biodiversity, function, and protective services
- Risk to freshwater resources with consequences for ecosystems, reduced surface water availability for irrigated agriculture, other human uses, and degraded water quality
- Risk to food and nutritional security through changes in agriculture, livestock, hunting, fisheries, and aquaculture productivity and access
- Risks to well-being, livelihoods and economic activities from cascading and compounding climate hazards, including risks to coastal cities, settlements and infrastructure from sea level rise"

Thus, I am in support of the contract with Sapphire Solar as it will provide 17% of PWP's RPS portfolio and will bring us one step closer to 100% carbon free by 2030.

However, this does not yet go far enough. As quoted above, continuing to emit carbon dioxide through burning fossil fuels beyond 2030 will lead to significant disruptions in human health, food security, water security, our economy, and our planet.

In the words of the United Nations Secretary General, Antonio Guterres, "We need all hands on deck for faster, bolder climate action. A window of opportunity remains open, but only a narrow shaft of light remains... We are getting dangerously close to the point of no return. The global climate fight will be won or lost in this crucial decade — on our watch. One thing is certain: those that give up are sure to lose. So, let's fight together — and let's win."

This past week the Secretary General of the United Nations made the following statement at the COP 27 meeting in Cairo: "We are on a highway to climate hell with our foot still on the accelerator."

In Pasadena, the same applies except that we are also blindfolded.

Although we appreciate the Sapphire project, its daily infusion of 39 MWs of solar powered electricity, plus battery storage, is only a tranche of what we need, and neither the Council nor the public have the information necessary to know how we will get the balance.

This Council is blindfolded because it lacks information about the Integrated Resource Plan process, what scenarios will be modeled, what assumptions, what balance of local and remote generation, and what options exist for using money from the Inflation Reduction Act. We understand that PWP plans to eliminate Net Energy Metering, the major incentive for local rooftop solar. Is the Council looking to see how that will affect our plan to increase renewable power supply?

The public is blindfolded because the citizen body--the STAG, that is supposed to be our way of being engaged in our energy planning process--has been stalled for almost 2 months by politics.

Is this fiduciary body looking at where we are going? Or is it all a blur that we hope someone at PWP and outside consultants will put into focus as the future of our children whizzes by?

PASADENA 100 calls on this Council to take off the blindfold, require more information from PWP about the scenarios to be modeled, how they will use federal and state funding, and how distributed generation will help us make our transition to clean energy. Please regain public confidence by refusing to stall and stuff the STAG.

Distinguished Mayor and Council Members:

COP-27 is underway. The clear take-away message is rapid decarbonization or perish. Can we, in Pasadena, accomplish that?

Recent electric grid modeling (performed at significantly higher fidelity than the legacy models employed by utilities) shows that *lowest cost* grids will include utility scale solar *and* lots of rooftop solar (including battery storage)\*. An abundance of rooftop solar allows for more utility scale solar *without* the need for massive distribution system upgrades. In other words, rooftop solar provides utilities with the flexibility to manage peak loads without requiring expensive, seldom-used, fossil-fuel peaker-plants. A clean grid is still a reliable grid.

\*The modeling considers power distribution system as a multi-parametric system to be optimized (everything between the energy source and its point of use), rather than the legacy method of treating the grid as a single, undifferentiated "load". My name is Chris Peck. I live at

in Pasadena.

I would like to support the purchase of more solar power, to facilitate 100% renewable power in the PWP portfolio by 2030 or preferably sooner.

If Sapphire is the best contract available at the present time given purchase price and wheeling charges, etc, then I support that contract.

I would also like to suggest that the City invest in ground mounted, roof mounted, and parking canopy solar within the city limits to reach the balance of the 100% renewable goal.

Third party financing is available so that these projects can be achieved without direct City investment, and energy can generally be secured at lower rates to the City than would be paid for electricity delivered from outside the City via long range transmission lines.

Local generation will also add to reliability, especially is paired with battery or other storage.

I would also say that the City's fleets of vehicles should be transitioned to electric vehicles in the near future. Resale rates are great right now for the recently purchased gas powered fleet vehicles! Fuel costs will be eliminated with home-grown solar energy. The vehicles can also be charged during peak generation times, which can be offset from peak demand times of day, thereby reducing the peaks in demand relative to generation.

We are fortunate to live in a City with visionary people and institutions, such as CelTech, JPL, Idealab, Art Center, and others. We can and should lead the way with respect to engineering achievement and innovation. We should join the clean energy future quickly, so we can catch up with all the other jurisdictions in the world that are ahead of us in this respect. Solar is no longer cutting edge, but it is cheaper than fossil fuels in most scenarios and will lead us to a low carbon future and give the planet a chance to recover from the impacts of the industrial age.
