# Measure R Mobility Improvement Project (MIP) List – In lieu of California Boulevard Grade Separation

City Council September 19, 2022 Item 18





- It is recommended that City Council
  - Find that this proposed action is exempt from review pursuant to the California Environmental Quality Act (CEQA), pursuant to State CEQA Guidelines Section 15061 (b) (3); and
  - 2. Authorize the Mayor to submit a project list to Metro on behalf of the City of Pasadena requesting Measure R Mobility Improvement Project (MIP) funding for projects within the City of Pasadena in lieu of the Metro L Line Grade Separation at California Boulevard



# Municipal Services Committee

- On September 13, 2022, the Municipal Services Committee unanimously approved a motion to accept the staff recommendation
- Municipal Services Committee also directed staff to
  - Develop a work plan and identify potential funding sources for an Arroyo Link Feasibility Study
  - Develop a work plan to identify walkability enhancements and identify potential funding sources for the Metro L Line at-grade crossings of California Blvd, Del Mar Blvd as well as the Metro L Line Fillmore Station and Del Mar Station
  - DOT will present the work plans and funding options as part of the annual Capital Improvement Program development for FY 2024





# **Transportation Advisory Commission**

#### **Transportation Department**

On August 25, 2022, the Transportation Advisory
 Commission (TAC) recommended that the City Council
 approve the attached Measure R Mobility Improvement
 Project (MIP) list, for potential projects in lieu of the Metro
 L Line Grade Separation at California Boulevard.



- Measure R MIP Funding
  - > January 29, 2018 City Council Approved the Measure R MIP list
  - November 2018 and September 2019 Metro awarded \$230 M Funding for grade separation of California Blvd
- The Metro L Line Grade Separation at California Boulevard Project
  - October 25, 2021 City Council action to identify projects in lieu of the grade separation
- The Caltrans Relinquishment of the SR-710 Northern Stub to the City of Pasadena






# Ongoing Enhancements to California Blvd

- Advanced train preemption traffic signal control system
- Grid adaptive traffic control system (TCS)
- Upgrading video detection system along corridor
- Expanding the Adaptive TCS east to Lake Ave
- Surrounding Signal Network Improvements
  - > Adaptive TCS on Del Mar Blvd to Lake Ave
  - > Traffic Signal and Intelligent Transportation System Upgrades
    - Walnut St, Colorado Blvd, Green St, Union St, Hill Ave, Cordova St

# Updated Measure R MIP List

- Builds on the City Council approved Early Action Projects list
  - Addresses north-south travel demands
  - > Projects updated based on current conditions
- New set of multimodal projects developed
  - Consistent with the initial approved list
  - Consistent with City's Street Design Guide
  - > Addresses transit infrastructure, bicycle and pedestrian improvements
- SR 710 Northern Stub Near Term Projects

# **Project Prioritization**

#### **Transportation Department**

#### Safety

- > 8-10 points: Project components address safety through implementation of physical infrastructure with a crash reduction potential or reduction in crash severity
- > 4-7 points: Project components provide safety benefit as an indirect benefit, such as the ability to utilize data to modify operations to enhance safety
- > 0-3 points: Project has little to no direct safety benefits

#### Connectivity

- > 8-10 points: Project components provide multimodal connectivity where currently missing
- > 4-7 points: Project components provide greater efficiency to existing connectivity
- > 0-3 points: Project provides little or no connectivity benefits

#### Project Need

- > 8-10 points: Project directly addresses a documented need as identified through an existing plan or program
- > 4-7 points: Project indirectly addresses a documented need as identified through an existing plan or program
- > 0-3 points: Project has little or no benefits towards addressing needs

#### Proximity to SR 710 Corridor

- > 8-10 points: Project is directly on the SR 710 corridor or provides a direct connection to a Metro L Line station.
- > 4-7 points: Project is adjacent to the SR710 corridor or feeds into a network that provides a connection to the Metro L Line stations
- > 0-3 points: Project is not adjacent to the SR 710 corridor, nor does it have any connection to the Metro L Line stations.

#### Project Readiness/Implementation Timeline

- > 8-10 points: Project is ready for construction or final design can be completed is a short time frame, due to project size.
- > 4-7 points: Project is in the conceptual design stage and public outreach has been initiated. Additional outreach and design is required for development of final design. Final design may take longer due to size of the project.
- > 0-3 points: Project concepts require a significant amount of additional outreach or other factors may affect final design and construction.




