Dear City Council Members,

I am writing to address one agenda item and to provide general public comment to the council.

First, in regard to agenda item 16, I support the appointment of Brandon Lamar to the District 3 seat that John Kennedy's passing has left vacant. Brandon won 40% of the vote in District 3 in the last election, which shows that he has the support of nearly half the district's constituents. I think that Brandon brings valuable perspective to the council as a tenant who rents instead of owns a home and as a lifetime resident of Northwest Pasadena. I personally have seen Brandon show up at countless community events in the past three years in support of the Northwest community, and heard him speak eloquently about the issues the district faces, and I believe he is the best candidate the council could appoint to fill the seat.

Second, August 15th, the day of this council meeting, is the two year anniversary of the murder of Anthony McClain by Pasadena Police Officer Edwin Dumaguindin. The administrative review by the police department is ongoing two years later, which is an unacceptable amount of delay. It was deeply disappointing that the LA County DA did not press charges in this case, and it is now the responsibility of the city and police department to ensure that there is accountability for Officer Dumaguindin's actions. Below are the demands from the McClain family and the Pasadena community:

 We demand the immediate firing of the officers involved in the murder of Anthony McClain, Officers Mulrooney and Dumaguindin. The McClain family's financial settlement does not equate to accountability or justice. We lift up the McClain family's demands:

Kimberly Jenkins: "Sadly, the money being paid on behalf of the city will not bring my son's father back to life. We are still waiting for the officer who shot and killed him to be held accountable." (quoted in the LA Times)

Attorney Caree Harper, who represents the McClain family members: The family hopes citizens of Pasadena will demand that their Police Department commit to reforms to avoid a repeat of the shooting: Stop handcuffing mortally wounded suspects, stop shooting fleeing people in the back, increase the retroactive recording time for body cameras from 30 seconds to two minutes, and stop pulling over motorists for minor infractions. (quoted in the LA Times)

- We demand that the Pasadena City Council agendize the Anthony McClain case.
- We demand the City of Pasadena implement mandatory disciplinary action for police misconduct. Amend the City Charter if necessary.
- We demand fully transparent OIS (officer-involved shooting) investigations; all evidence released to the public within 24 hrs and available until the OIS investigation is complete.

Dear City Council Members,

While I am not a resident of District 3, I live quite close to its border with District 1, and am anxiously following the appointment process for the late Councilman Kennedy's seat.

Though about 60% of the households in our city rent their housing, none of the current city council are tenants. A vast swathe of the city is currently unrepresented in its governance. Therefore, I would urge the council to appoint someone who is both a tenant, and who has shown consistent and material support for tenant issues. In my view, that person is Brandon Lamar.

I met Brandon for the first time when I knocked on his door, as I have been doing every weekend for the last year while working on the rent control citizen's initiative. I noticed immediately that he was a kind, engaged, and thoughtful person. I have been happy to work with him on tenant issues in the past few months. Brandon has been on the ground, having conversations with district 3 residents throughout (and before) his election campaign, and I believe he has the pulse of the community and the ability to represent everyone in the district.

My husband and I moved to Pasadena from the neighborhood surrounding USC in 2013 the same year John Kennedy was elected to the City Council. I was astounded when I discussed an issue with John early on that he gave me his cell phone number to follow up if I wished to discuss further. Soon, I learned this was John's standard operating procedure as was attending Garfield Heights Neighborhood Association meetings, our annual block party and holding regular community meetings.

Last night, I attended a Town Hall to hear District 3 applicants respond to some excellent questions. In addition to his ideas and approaches, Brandon Lamar spoke about being boots on the ground, my words, not his, when events occur in Pasadena. This was evident when he joined a Moms Demand Action event and walk I attended on Marengo Avenue a few months ago. He spoke about his, unfortunate, first hand knowledge about gun violence. I've been moved by Brandon's experiences, his actions and his ideas.
