#### To whom it may concern,

It has come to my attention that one of the applicants, Justin Jones who is applying for the City Council District 3 vacant seat, recently moved to this district a little over a month ago. The voter registration from the 2022 Primary election is not showing him as a resident with the address he provided on his District 3 application. His address was shown in District 4 on El Nido St. where it was confirmed he was living, even after the passing of the late John J. Kennedy. It is suggested that he still resides at this location while utilizing a family member's address on Prescott Ave. (District 3).

I am bringing this to your attention because not only do I want this process to be fair, but after being a resident in District 3 for over thirty years, and raising a family here, I don't want anyone representing me who just moved to the district just to run for office. I don't believe there is honor or trustworthiness in that. If Mr. Jones were interested in District 3 before, he should've been more invested in our community and became a resident before all of this. All applicants should be required to show a utility bill as proof of residence.

It is also my understanding that Mr. Jones represented District 3 on the Human Relations Commission. In January 2020 he resigned from the commission and just two years later (May 2022), he was appointed to represent District 1 on the Environmental Commission. How is that even possible when he hasn't been a resident of either district? Being active in my community, I've never seen Mr. Jones present in the community or concerned about our issues.

We really have to do a better job in this process since it's really not the district's decision who represents us. The Mayor and City Council has an obligation to make sure the people who apply are representative of the district and not just here for personal gain.

I hope that this information is brought to the public so that the entire district is aware, so all of us can make sober decisions on who we want to represent us in our district.


#### (Information on Photos)
