RE: AGENDA ITEM 3. AUTHORIZE THE PURCHASE OF 15 PUBLIC TRANSIT VEHICLES INCLUDING THE FIRST ZERO EMISSION VEHICLE FOR PASADENA TRANSIT TO REPLACE AGING VEHICLES AND PROVIDE MORE CAPACITY

Per Agenda Item 3, the City proposes to purchase \$9 million of **fossil fuel fleet vehicles** with a useful life of 10-12 years, to be delivered in 2024:

- 9 larger capacity Xcelsior 35-foot Renewable Natural Gas (RNG) buses and
- 1 35-foot Battery Electric Bus (BEB) and chargers for Pasadena Transit and
- 2 Starcraft Allstar, Ford E450 25-foot Renewable Natural Gas shuttles for Pasadena Transit and
- **3** Sunset, Ram Promaster low-floor gas-powered vans for Pasadena Dial-A-Ride

This purchase is inconsistent with the Climate Emergency declared by the Pasadena City Council on January 30, 2023, stating that the City must reduce GHGs significantly by 2030 in order to maintain a livable earth. Apparently, some City Departments did not understand the City Council's *Climate Emergency Declaration*. The heading for the agenda item fails to mention that only one of the proposed vehicles is electric while 14 vehicles are gas powered. The proposed gas-powered vehicles would be in operation until 2034 or beyond and do not comply with the letter or spirit of the emergency declaration.

VOTE <u>NO</u>AGENDA ITEM 3. All electric fleet vehicles only.

Dear Councilmembers,

Buses powered by so-called Renewable Natural Gas are not the answer. RNG is chemically identical to methane, just produced in a different way.

You just passed a climate emergency resolution. Spending \$9 million on vehicles that pump greenhouse gases into the air is not consistent with believing that there is a climate emergency. These vehicles won't be delivered until 2024 and will last for at least 10 years.

Please ask more questions:

Where will the gas come from to fuel these buses?

Why can't the city purchase EV buses? If charging is the problem, how can we collaborate with neighboring cities to solve that problem?

Do we really need more big buses when we see so many empty buses driving through out streets?

What is the low NOX technology of these buses? Does it avoid the particulate matter problems associated with RNG?

Experts point out that RNG should only be used when there is no choice:

"Just like fossil gas, biogas and synthetic methane continue the use of methane, which causes the formation of nitrogen oxides (NOx) and other harmful air pollutants when burned.20 NOx pollution can lead to respiratory problems, from coughing and wheezing to decreased lung function, and can contribute to hospitalizations and even premature death.21 In other words, biogas and synthetic methane do not avoid the many health harms of fossil gas." Natural Resources Defense Council "Pipedream or Climate Solution."
