| REMOTE PARTICIPATION REQUEST | APPROVAL OF A REQUEST BY COUNCILMEMBER RIVAS TO PARTICIPATE REMOTELY DUE TO EMERGENCY CIRCUMSTANCES |
| | Mayor Gordo stated the following: "I received an email on Wednesday, April 12, 2023 from Councilmember Jess Rivas requesting that the City Council allow her to participate remotely for the special City Council meeting on Wednesday, April 19, 2023, due to emergency circumstance pursuant to Government Code Section 54953 [(F)(2)(A)(ii)], and that she is following her physicians order placing her off work for a medical condition that prevents her from attending in person." |
| | It was moved by Councilmember Lyon, seconded by Councilmember Madison, to approve the request by Councilmember Rivas to participate remotely in today's City Council |

Councilmember Rivas joined the meeting at 6:41 p.m.

Mayor Gordo read the following statement: "While I believe I am able to participate in this evening's meeting, consistent with my prior recusals on this matter and in order to ensure that the integrity of this important process, which we all want to be successful, is beyond reproach, out of abundance of caution, I will recuse myself from the appointment process of the [Pasadena] Rental Housing

meeting due to emergency circumstances as described in her communication to the City Council dated April 12, 2023, subject to the requirements of Government Code Section 54953. (Motion

unanimously approved) (Absent: Councilmember Rivas)

Board, because I own rental property in the City of Pasadena. Now let me be clear, I am seeking further advice from the FPPC in order to ask for clarity on future participation in the appointment process of the Rental Housing Board. But at this point in time, out of an abundance of caution, and to ensure that this process is beyond reproach and has the best chance to succeed, I will recuse myself and hand the gavel to Vice Mayor Williams."

Mayor Gordo recused himself and left the meeting at 6:44 p.m. APPOINTMENT OF SEVEN TENANT MEMBERS, ONE ALTERNATE TENANT MEMBER, FOUR AT-LARGE MEMBERS, AND ONE ALTERNATE AT-LARGE MEMBER TO THE PASADENA RENTAL HOUSING BOARD (PRHB) (City Clerk) Recommendation: It is recommended that the City Council:

(1) Find that the proposed actions are exempt from review pursuant to the California Environmental Quality Act ("CEQA") in accordance with State CEQA Guidelines § 15061(b)(3), the "common sense" provision that CEQA only applies to projects that may have a significant effect on the environment; and

(2) Approve the nominations and make initial appointments to the Pasadena Rental Housing Board in accordance with City Charter Sections 1811(c) and (d), as follows:

- Seven Tenant Members (one from each Council District)
 - Four Members to serve four-year terms
 - Three Members to serve two-year terms
- One Alternate Tenant Member (citywide) to serve a four-year term
- Four At-Large Members (citywide)
 - Two Members to serve four-year terms
 - Two Members to serve two-year terms
- One Alternate At-Large Member (citywide) to serve a four-year term

Vice Mayor Williams provided an overview of the meeting format and announced that public comment will be heard after the City Clerk's presentation.

Mark Jomsky, City Clerk, presented a PowerPoint presentation on the item, and responded to questions.

Councilmember Madison expressed concerns regarding appointing applicants to the PRHB that are active parties in a lawsuit that challenges the validity of Measure H, and asked that the City Attorney identify any applicants that are parties in that litigation.

Councilmember Hampton expressed appreciation to the City Clerk and staff for organizing the information; thanked the public and all the applicants who applied; and expressed the importance to him that the individuals appointed will view the issues collectively, as a whole, and not just view the issue from one side. In response to Councilmember Madison, City Attorney Bagneris provided the following Plaintiff names: Ahni Dodge, Simon Gibbons, Margaret Morgan, Danielle Moskowitz, and Tyler Werrin. She also named the Interveners: Michelle White, Ryan Bell, and Affordable Pasadena. She noted that the City Charter Article XVIII establishes the qualifications for appointment to the PRHB, stating there is no language in the Charter that states someone who is party to litigation, or who challenges the measure, is ineligible to serve.

Mark Jomsky, City Clerk, reported that the City Clerk's Office received twenty-seven letters expressing opposition to the City Council appointing all or some of the following applicants to the Pasadena Rental Housing Board: Penny Carter (1 letter), Ahni Dodge (15 letters), Simon Gibbons (23 letters), Tyler Werrin (21 letters), Daniel Gonzalez (3 letters), Terry Tornek (17 letters), Barbara Pitts (1 letter), Emanuel Najera (1 letter), Allison Henry (1 letter); and forty-seven letters in support of the City Council appointing all or some of the following applicants to the PRHB: Brandon Lamar (11 letters), Paulette Brown (2 letters), Peter Dreier (7 letters), Thea Orozco (5 letters), Arnold Siegel (5 letters), Ira West (7 letters), Aaron Markowitz (7 letters), James Edward Creely (2 letters), Adela Torres (2 letters), Simon Ybarra (1 letter), Rvan Bell (5 letters), Allison Henry (23 letters), Michelle White (5 letters), Robert Escobedo (5 letters), Gian McCoy (3 letters), Yaneli Soriano Santiago (2 letters), Katherine Hindman (1 letter), Penny Carter (1 letter), Ahni Dodge (2 letters), Simon Gibbons (2 letters), Tyler Werrin (2 letters), Diane Romero Chavez (1 letter), Deborah Dunlop (1 letter). In addition, one letter advocating for the City Council to appoint members to the PRHB that will act in good faith; one letter advocating for the City Council to not appoint any landlords to the PRHB; and three letters advocating for the City Council to consider appointing landlords to the PRHB in an equal manner to tenant applicants, and/or expressing concerns with short notice of the special meeting to the community; were received by the City Clerk's Office, with all correspondence distributed to the City Council, posted on-line, and made part of the public record.
