#### City Council Members,

My name is Shayne Smith. I am a resident of District 7. For context, I am a retired engineering consulting executive, familiar with the power planning process and the needs of municipal governments. I stand with Pasadena 100 - a coalition, comprised of many well-educated and well-intentioned citizens. Together with all of us, I urge you to support a plan for 100% carbon free electricity by 2030 and to not accept the PWP's current IRP as complete, or acceptable for Pasadena's future needs.

I have participated in many of the recent public information events, and have the following comments on PWP's recent submission to the MSC:

- 1. Per Resolution 9977, PWP's IRP fails to provide anything close to an "optimized" solution. The scenarios, at best, represent extreme assumptions that, in each case are unrealistic. We need to use what we have learned from these scenarios to build a real plan.
- 2. Re: Financial Impacts (starting on pg 10): We agree that a cost-of-service study is required to ascertain the real financial implications to rate payers, but optimization of the extreme scenarios is required. They each need to incorporate the many additional considerations identified by Pasadena 100 (documented elsewhere). Some additional questions/considerations:
  - 1. How do we eliminate the outstanding balance of the Glenarm bonds by 2030?
  - 2. Pasadena 100 has tried to estimate overall rate impacts resulting from the potential increases to energy charges associated with the current scenarios. PWP needs to do the same.
  - 3. The financial concerns expressed throughout pg 11-14 address future rate challenges, but provide very little in the way of solutions to mitigate these concerns. We are left wondering whether the PWP is adequately equipped to deal with these challenges, or if they even want to.
- 3. Comparative Benchmark Analysis: It's encouraging to see that the PWP is looking to other CA POU's for comparison. Both SMUD and LADWP appear to have done enough planning/analysis work to be able to define the % zero carbon goal achievable by their current plans. We only wish that PWP was capable of presenting quantifiable options to our City Council so that we can determine the incremental cost impacts of achieving 90% of our target, versus 95%, versus 100%. Instead, the PWP just wants the IRP audience to understand that "this is really hard".
- 4. Next Steps: PWP's IRP is far from "forward thinking and flexible". Are they recommending that any of scenarios can form the basis of our plans moving forward? Even Scenario 4 appears to ignore adverse gas pricing impacts and is mostly reliant on wind energy, as opposed to more realistic blend of renewables. On pg 16-17, we actually get the first elements of a REAL PLAN, presented as near-term activities, including 100MW of solar capacity and a total of 85MW of battery storage capacity. WHEN

- will these be undertaken? And THEN what? The additional actions presented in this section need to be progressed ASAP, not just considered. WE NEED A PLAN!!
- 5. Summary and Recommendation: The PWP has effectively outlined the barriers to progress, but provides no real solution for moving forward, effectively ignoring the City Council request to develop an optimized approach (with real options), and preferring to bask in its GHG reduction progress since 1990, back when our world was very much different than it is today.

As the founder of *Pasadena 100* (in 2016), here's my view on why Scenario 5 should be selected as PWP's preferred IRP portfolio.

PWP's debt obligation to Magnolia Power Plant will be retired in 2036. Presuming that PWP won't terminate Magnolia early (nor Glenarm - needed for resource adequacy), Scenarios 1-3\* can be dismissed as candidates for the preferred portfolio because both Magnolia and Glenarm are fossil-fuel sources of power. Thus only Scenarios 4 and 5\* remain.

Either PWP demonstrates ambition in addressing the climate emergency (as outlined in City Resolution 9977) or it doesn't — in which case it'll slouch along and comply with the state-mandated goal. Given the climate circumstances we're all aware of, Scenario 4 is not ambitious. Scenario 5 is ambitious and practical, while remaining affordable.

My comments below refer to PWP's memo to the Mayor and City Council dated November 6, 2023 (presented to the Municipal Services Committee on October 10, 2023) entitled "ADOPTION AND APPROVAL OF THE 2023 POWER INTEGRATED RESOURCE PLAN FOR THE WATER AND POWER DEPARTMENT".

Table I forecasts that GHG emissions will equal 100,924 tons of CO2 by 2031 for the Reference Case (Scenario 4). Compare this with Scenario 5's forecast emissions: 17,041 tons — a more ambitious number. A savings of 83,883 tons, roughly 17% of Scenario 4's total.

Table IV compares high-end cost estimates of ratepayers' utility bills. In this example, Scenario 4's monthly Energy Charge Portion of Customer Bill rises from \$70/month to \$102/month over 7-years (recall, this is the have-to-achieve, baseline case). Scenario 5's energy charge part of the monthly bill is predicted to rise from \$70 to \$143/month. That's an additional increase of \$143-\$102 = \$41/month more by the end of 2030. In other words, a year-on-year increase of only \$6/month with respect to Scenario 4's rate. That's not a lot of money in return for accomplishing something downright good in the world. (2024-2031 is 7-years; \$41/7 = \$6/mo.)

Under Scenario 5, over the next 7-years the ratepayer pays 4 cents more per ton of CO2 released for each ton of CO2 saved in 2031 (CO2 not released) in order to achieve Scenario 5's ambition (relative to the Reference Case). 1-ton of CO2 is approximately equal to the emissions from a gas-powered mid-sized car traveling 2500 miles. The gasoline alone for that 1-ton trip would cost about \$500.

(\$41/mo \* 12 mo/yr \* 7 yr / 83883 tons = 4 cents per ton of CO2.) (https://climate.mit.edu/ask-mit/how-much-ton-carbon-dioxide.) (2500 miles/22 mpg \* \$5 per gal = \$568 for the trip.)

Isn't 4 cents per ton of CO2-saved a cost that Pasadena can well afford in order to preserve its reputation as a climate leader? Muse on that while considering Resolution 9977. I urge the MSC members to recommend Scenario 5 as the preferred portfolio for PWP's 2023 Power IRP.

<sup>\*</sup>PWP's draft Power IRP outlines 5 scenarios: Scenarios 1-3 represent different portfolios for achieving 100% carbon-free energy by 2031; Scenario 4 is the Reference Case, achieving a state-mandated, 60% clean-energy portfolio by 2031; Scenario 5 modifies Scenario 4 by adding the EPA's Social Cost of Carbon to all its retail sales.

I will be at MSC tomorrow but may have to leave early, so I am writing to add my voice to the chorus calling for a commitment to 100% carbon free electrical power.

I understand that there are potential cost issues that <u>must</u> be considered, especially so lower income Pasadenans do not carry the brunt of addressing the climate change crisis.

However, I am concerned about PWP's communication. I understand they have not been clear about the difference between costs attributable to the transition to cleaner energy and costs attributable to the volatility of the cost of gas. As you know, gas is not addressed in this plan. I am also concerned that PWP has assumed that the entire cost of rooftop solar will be born by the ratepayers. As you know, this is not true. Property owners pay for most or all of the costs of rooftop solar.

I am also concerned about CM Williams' request to Pasadena 100 to drop their focus on the IRP and focus on the Climate Action Plan instead. This is an aspirational document that sits on a shelf and does not meaningfully affect Pasadena's policies.

I know there will need to be robust incentive programs for rooftop solar, and also programs to support low income residents. This will not be a free transition!

#### City Council Members,

My name is Joel Haber, I am a resident of district 2, and a scientist well acquainted with the processes leading to the crisis of climate change and the accelerating pace of extreme weather disasters and the rapidly rising cost of recovery and mitigation. It is clear that rapidly transitioning to carbon-free electricity is the lowest cost option for Pasadena Residents, both directly in electricity rates and indirectly from reducing the costs of fossilfuel induced climate change. This past year's volatile and rapid increase in electricity rates stemming from natural gas price increases serve as a reminder that fossil fuel prices are not stable, but also that our municipally owned utility is increasingly reliant upon a for-profit, monopoly gas company—Sempra, which along with Enron, not so long ago manipulated the gas market to inflate their profits and caused California's traumatic rolling blackouts.

"The Energy Commission also has specific and limited regulatory authority over the state's 44 publicly owned utilities", because it is understood that the public has direct influence over the policies and operations of these municipally owned utilities via their elected local representatives. Unfortunately, over the past 10 years I have become painfully aware of the methods used by PWP to frustrate public input urging reform of the utility's over-reliance on fossil fuel generated electricity. These methods include, but are not limited to, subdividing the public planning process to prevent comprehensive review of their operations or plans, "cooking the books" in the IRP process by using remarkably optimistic cost projections for fossil fuels while utilizing inflated, already out-of-date costs for renewable sources and battery storage, and by "running out the clock" by publicly disclosing all information at the last allowable moment to minimize the opportunity for the public to review and fact-check their information, and by submitting all reports requiring approval of city committees and of City Council at the last meeting possible before required submission to state regulatory authorities, again to prevent proper public review.

Nevertheless, PWP's previous two general managers, and other senior managers, always declared "but we work for the city, and we will do what City Council directs us to do." Now they have dropped even that pretense, by openly defying the City Council directive to develop as part of this IRP a plan to reach 100% carbon-free electricity by 2030, and not producing any plan.

I urge you not to accept this defiance of your directive to PWP, which is in accordance with how California's electric utility regulatory system is designed to work. I urge you to reassert the public's right to provide input and guidance to their utility via their elected representatives on City Council and by mandating reforms to the public consultation process.

I urge you to support a plan for 100% carbon free electricity by 2030, to reassert YOUR authority over this rouge utility.

Dear Chair Williams and Committee Members,

Thank you for the opportunity to provide input as you consider the Integrated Resources Plan for the Power Division of Pasadena Department of Water and Power. I was privileged to sit on the advisory committee of the IRP and provided my input.

The Pasadena Chamber if supportive of your staff and their work and the climate goals of the City of Pasadena.

I would like to reiterate a couple of points I made during those discussions at the STAG:

- 1. I believe it is in Pasadena's best interests to have as much electrical generation and storage as possible within the borders of Pasadena or nearby. Whether as a result of a catastrophic event or lack of generation available through the CALISO and the state electrical grid, at some point Pasadena will be faced with a shortage of electricity available. Understanding that reality, we should seek to control as much of our power as possible so that remains available regardless of circumstances or shortfalls in supply. The way to do that is to encourage local installation of solar and storage and provide for community solar projects undertaken by PWP.
- 2. Pasadena ratepayers should be considered. Our climate goals are important. We need to do what we can to have a positive impact (or a lesser negative impact) on greenhouse gas emissions and other pollutants. We also need to consider the costs to the ratepayers. Many of your customers live day to day, paycheck to paycheck. For them, an increase of even 40% in the cost of electricity (not to mention added costs of the Utility User Tax and more) could be the difference between staying in their home or becoming homeless.

For your larger companies, the increased costs will be passed on to customers or recouped through lower wages paid, fewer employees on the payroll or other measures required to maintain a balanced budget.

#### NO COMPLETE PLAN WAS SUBMITTED FOR ADOPTION AND APPROVAL.

Pasadena Water & Power (PWP) submitted a 20-page summary with their request for Adoption and Approval of the 2023 Integrated Resource Plan (IRP). Compare this brief 2023 Agenda Report to the complete 2018 IRP which was over 200 pages long with 96 exhibits: 2018-12-10 PWP 2018 Power IRP Attachment.pdf

It is unethical if not illegal for the Municipal Services Committee (MSC) to adopt and approve the summary submitted for the October 10, 2023 MSC meeting, *in lieu* of a complete draft of the City of Pasadena 2023 Integrated Resource Plan. MSC is being asked to "sign a blank check" by approving a summary list of scenarios without a full report and actual plan. These scenarios were preliminary exercises to gain initial data for decision making.

#### MONTHLY POWER COST ADJUSTMENTS INCREASED THE ENERGY CHARGE ON 2023 RETAIL ELECTRIC BILLS.

The Energy Charge ("Power Cost") is only part of the total electric bill which includes Transmission Charge, Distribution Charge, Monthly Customer Charge, Grid Access Charge, and Taxes.

The first monthly Power Cost Adjustment (PCA) was 2.5¢ per kWh (27%) effective March 1, 2023. For an average residential customer using 500 kWh per month, this resulted in a total bill increase of about \$14 for just one month followed by smaller monthly increases. As of September 2023, the same customer was paying about \$24 more per month than for the previous year, September 2022.

Assuming that PWP scenarios and data are correct, Table III on page 21 of the Agenda Report compares total bill increases for the same 500 kWh household as a <u>percent increase for the entire period</u> (7 years) from the present in 2023 to the future in 2030. This results in alarming double-digit increases ranging from 38% to 91%. However, if we calculate the percent increase for the same scenarios on an <u>annual basis</u>, they range from about <u>5% to 10%</u>.

The PWP Agenda Report to MSC exaggerates the cost of transitioning to carbon-free electric power. To make up for the increased cost of gas used to generate its electricity, PWP already increased the total electric bill for an average household by 18% in just 7 months. We can and we must make the change to clean power.

Dear Municipal Services Committee Members,

This message comes from a place of hope and support in the cornerstone of local communities and their ability to create positive change.

Fed SEC chair, Gensler, said the measures could "change the baseline" for long awaited federal law." Dear City Councilmembers,

I am a resident of District 1 and I'm stunned by the bold disrespect of our democratic process being demonstrated by PWP. They are asking you to vote in support of the draft IRP and yet a copy of that draft document has not been made public. Since when does any City Department request approval for a plan without providing at least a draft copy of that plan? DOT would certainly not ask for approval of a transportation plan without providing a copy. The Planning Department and Parks Department also would not attempt to request approval of a specific plan or a park project without providing the appropriate documentation. I feel that PWP is acting as though it is exempt from providing accurate information to the council, the public, and the groups tasked with advising the City about the IRP. This is unacceptable.

I ask that you direct PWP to provide a full draft IRP before the MSC can vote on a recommendation. I hope that as Councilmembers you insist on accurate information from PWP so that you can make an informed decision.

I am also very concerned about PWP's communication. I understand they have not been clear about the difference between costs attributable to the transition to cleaner energy and costs attributable to the volatility of the cost of gas. I am also concerned that PWP has assumed that the entire cost of rooftop solar will be borne by the ratepayers. As you know, this is not true. Property owners pay for most or all of the costs of rooftop solar.

I understand that there are potential cost issues that <u>must</u> be considered, especially so lower income Pasadenans do not carry the brunt of paying for the climate change crisis. But I do NOT believe that PWP is being honest with us and I'm asking you to hold them to account.

Thank you for the good work you are doing and for your support of 100% carbon free energy for Pasadena by 2030.

#### Greetings Councilmembers,

I'm Una Lee Jost, Pasadena resident District 4, PUSD parent leader, and member of the PTA, the nation's largest volunteer-led child advocacy association working to drive improvements in the education, health and well-being of all children and families.

In October 2022, 300 local residents, including high school students, <u>rallied</u> at the steps of City Hall calling for our City to transition to 100% Carbon Free Electricity by 2030.

I'm pleased the Pasadena City Council adopted Resolution 9977 in January since then, declaring a Climate Emergency and committing to achieve 100% Carbon Free Electricity by 2030, along with support of the PUSD Board of Education and PCC Board of Trustees.

However, just like what one of my law professors used to say back when I was in law school, the Constitution is only a piece of paper if no one enforces it.

The same with the Council's Resolution 9977.

As you may recall, Resolution 9977 includes the following Resolve clause:

"NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PASADENA AS FOLLOWS:

Section 1. The City Council hereby declares that climate change is an emergency that threatens the health and welfare of our city, region, state, nation, and the environment.

Section 2. The City commits to environmental stewardship and continued leadership in sustainability.

Section 3. The City Council hereby sets a policy goal to source 100% of Pasadena's electricity from carbon free sources by the end of 2030.

Section 4. The City Council hereby directs the City Manager to utilize the 2023 IRP process to plan multiple approaches to transition to the goal described in Section 3 and to optimize affordability, rate equity, stability, and reliability of electricity while achieving this goal.

Section 5. The City Council hereby directs the City Clerk to send a certified copy of this resolution to the Pasadena Water and Power General Manager."

In furtherance of Resolution 9977, it is VITAL the MSC Committee recommend a plan through the IRP process that actually gets us to our goal of 100% Carbon Free Electricity by 2030 - one that clearly states that Pasadena plans to achieve the goal stated in Resolution 9977 of carbon-free electricity by 2030, along w/ a timeline and milestones. Electric power production is responsible for more than 25% of greenhouse gas emissions in the US and our City of Pasadena owns our own utility company, so we have the power and responsibility to do so.

By doing so, the MSC Committee would also be in alignment with the State PTA's stated goals:

- In 2015, the PTA passed a "Climate Change is a Children's Issue" resolution explaining that our children are most vulnerable to the hazards of climate change.
- In 2020, the PTA reaffirmed its commitment passing a "Net Zero Emission Schools" resolution declaring that "children are among the populations most affected by climate change: a child born today will experience climate-related health impacts from infancy to old age experiencing significantly increased health risks due to extreme weather events, climate-sensitive infectious diseases, air pollution-related illness, and heat-related illnesses. The PTA thus called for our leaders to "plan for and implement greenhouse gas emission reductions at the rate required to safeguard the futures of our children and generations to come."

Climate scientists are in consensus we have a limited time window (2030 less than a decade away) to reduce carbon emissions to 40-60% below 2010 levels in order to avert climate catastrophe.

And that if the current trend of fossil fuel use continues beyond 2030, Pasadena's children will not only experience significantly increased risk of air pollution, but also water insecurity, food insecurity, infectious diseases, extreme heat, habitat loss, drought, and poverty WITHIN THEIR LIFETIMES.

In light of the danger to our families and communities, I'm most appreciative of Councilmember Madison's words on the <u>City of Pasadena's website</u>. In his words:

"Pasadena is now committed to achieving 100% carbon free electricity by 2030. As far as I'm concerned, this is a unanimous mandate from the City Council, not a lofty, aspirational policy goal. If challenges such as the affordability of the new energy sources arise, we must find solutions and stay true to our commitment to go carbon free. If we need to subsidize low-income families, I'm all for that. If we need to look at different approaches to our rate structure, I'm all for that, too. But we cannot abandon this commitment just because it turns out to be more costly. We have to do this.

"Climate change is truly an existential threat. We're Pasadena. If we can't do this, nobody can. We're the home of Caltech, JPL, the Carnegie Observatory, and the best minds in the country. We don't want to go along to get along. We want to be a leader. We want to far exceed the state's bare minimum requirements."

"Pasadena has been a leader in this space for a long time by adopting the UN Urban Environmental Accords in 2006, a Green Cities declaration, and an environmental charter. Those are important historical documents that demonstrate this Council's and the City's leadership on climate change action."

#### Councilmembers:

As you may recall, the stated mission of the Municipal Services Committee is set forth as follows: "The City of Pasadena is dedicated to delivering exemplary municipal services, responsive to our entire community and consistent with our history, culture and unique character."

As our leaders, I urge you to be responsive to our community and LEAD the way in protecting Pasadena's children - recommend a plan with a timeline and milestones that will actually enable our City to achieve the urgent goal of 100% Carbon Free Electricity by 2030. This is our time to rise to the occasion and use all the tools and resources at our disposal to help ensure a planet and future that Pasadena's children, and all children and youth deserve. Because WE ARE IN A CLIMATE EMERGENCY. Thank you.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASADENA, CALIFORNIA DECLARING A CLIMATE EMERGENCY AND SETTING A GOAL TO SOURCE 100% OF PASADENA'S ELECTRICITY FROM CARBON FREE SOURCES BY 2030

WHEREAS, on March 5, 2018, the City of Pasadena ("City") adopted a Climate Action Plan ("CAP) based on the Global Warming Solutions Act of 2006 ("AB 32") and focuses on five specific GHG reduction strategies: Energy Efficiency and Conservation; Sustainable Mobility and Land Use; Solid Waste Reduction; Water Conservation; and Urban Greening; and

WHEREAS, the CAP reinforces Pasadena's commitment to providing sources of renewable power and reducing GHG emissions by meeting or exceeding state required emissions reduction targets; and

WHEREAS, the City has already implemented a number of important actions to achieve CAP GHG reduction goals including but not limited to a commitment to procuring only low carbon generating resources and phasing out all fossil fuel contracts, and offering a 100 percent renewable Green Program rate option for customers; and

WHEREAS, the City has declared a water supply shortage and has enacted stringent water conservation policies and strategies to mitigate the effects of ongoing drought conditions; and

WHEREAS, the City actively promotes active transportation, public transit, and continues to demonstrate leadership in accelerating the adoption of Electric Vehicle ("EV") technology with Pasadena having one of the highest percentages of registered EVs in the nation; and

WHEREAS, the City has adopted ordinances to achieve long-term GHG reduction including a requirement to include electrification in new building designs, prohibiting the use of gas-powered leaf blowers, and prohibiting polystyrene food packaging in Pasadena; and

WHEREAS, the City continues to exceed CAP Urban Greening targets by restoring greenspace and planting new trees to improve carbon sequestration, reduce urban heat-island effect, and increase opportunities for active recreation; and

WHEREAS, the City has developed partnerships with community-based organizations for inclusive energy efficiency and water conservation programs and actively engages the community in conservation strategies; and

WHEREAS, the Pasadena Environmental Advisory Commission on January 17, 2023, the Pasadena Unified School District Board of Education on December 15, 2022, and the Pasadena City College Board of Trustees on January 18, 2023, each took action to support a goal of the City of Pasadena achieving 100% carbon free Energy by 2030 to address the climate emergency; which aligns with and supports previous actions of the Pasadena City Council when it adopted an Environmental Charter in 2005, endorsed the U.S. Mayors' Climate Protection Agreement and the United Nations Urban Environmental Accords, and launched a Green City Action Plan in 2006; and

WHEREAS, the City recently implemented a comprehensive GHG Inventory process to measure actual and forecasted emissions of municipal operations and the community to gauge the ongoing progress of the CAP; and

WHEREAS, California continues to pass successor legislation that expands on the goals of AB 32 and prioritizes climate change mitigation strategies; and

WHEREAS, in the 2022 Scoping Plan for Carbon Neutrality ("Scoping Plan"), the California Air Resources Board ("CARB") has set a recommended GHG emissions reduction target of 85 percent below 1990 levels by 2030 and carbon neutrality by 2045, and updates the Scoping Plan every five years with increasingly ambitious targets; and

WHEREAS, in Policy D-135.966, the American Medical Association has declared climate change as a "public health crisis that threatens the health and well-being of all individuals" and promises to advocate for policies that limit global warming, reduce GHG emissions, and support clean energy solutions; and

WHEREAS, according to the California Energy Commission, the percentage of California's energy that comes from renewable resources continues to increase as the state moves toward 100 percent clean energy; and

WHEREAS, proactive planning is required to ensure that GHG emissions reduction can be achieved while maintaining a power supply portfolio that meets customer needs, satisfies local and state reliability requirements, and minimizes electric rate impacts and volatility; and

WHEREAS, the City's role as a publicly owned utility is governed by local, state, and federal laws and regulations; multi-party agreements; and bond documents which direct and/or impact operating and investing decisions; and

WHEREAS, Pasadena Water and Power ("PWP") undergoes its Power Integrated Resource ("IRP") planning process every five years, which guides how Pasadena's electricity will be sourced for the next 20 years; and

WHEREAS, the City is committed to demonstrating aggressive action and ongoing leadership in combating climate change and has set GHG targets that will achieve carbon neutrality before 2045.

Section 2. The City commits to environmental stewardship and continued leadership in sustainability.

Section 3. The City Council hereby sets a policy goal to source 100% of Pasadena's electricity from carbon free sources by the end of 2030.

Section 4. The City Council hereby directs the City Manager to utilize the 2023 IRP process to plan multiple approaches to transition to the goal described in Section 3 and to optimize affordability, rate equity, stability, and reliability of electricity while achieving this goal.

Section 5. The City Council hereby directs the City Clerk to send a certified copy of this resolution to the Pasadena Water and Power General Manager.





- RESOLVED, That the California State PTA, its units, councils and districts urge school districts to support programs and strategies to make schools more climate-safe and energy efficient models to prepare children for climate changes already underway; and be it further
- RESOLVED, That the California State PTA, its unit, councils and districts urge school districts to serve as role models for practices that promote energy conservation, alternative energy sources, reducing dependency on automobile travel and encouraging sustainable practices; and be it further
- RESOLVED, That the California State PTA consider climate change a children's issue and urge its units, councils and districts to advocate for comprehensive local, state and national legislation to substantially reduce man-made contributions to climate change and to mitigate its impact on children's health; and be it further
- **RESOLVED,** That the California State PTA submit this resolution to the National PTA for consideration by the delegates at its convention.

#### **BACKGROUND SUMMARY**

According to thousands of peer-reviewed studies, the Earth's temperature is warming and the dominant reason is due to human activities. In California, climate change will cause more frequent and intense forest fires, more air pollution and deadly heat waves, a significant reduction in the snowpack and state water supplies, sea level rise and erosion along California's long coastline.

Today's children are already being impacted by climate change. Because of their physical, physiological, and cognitive vulnerability, children are more susceptible to adverse health effects from environmental hazards. As impacts of climate change worsen in the coming years, anticipated direct health consequences of climate change will include injury and death from extreme weather events and natural disasters, increases in climate-sensitive infectious diseases, increases in air pollution—related illness, and more heat-related, potentially fatal, illness. By rallying to protect and prepare our children today, we help the nation, the planet and future generations.

#### **NET ZERO EMISSION SCHOOLS**

Adopted by the Statewide Annual Meeting Delegates June 2020

WHEREAS,

Children are among the populations most affected by climate change: a child born today will experience climate-related health impacts from infancy and adolescence to adulthood and old age--including increased food insecurity and malnutrition, heightened transmission rates of infectious diseases, economic losses from extreme weather events, temperature rise and heatwaves, and negative health effects from heat, air pollution and wildfire smoke--and these impacts are already present and worsening; and

WHEREAS.

The Intergovernmental Panel on Climate Change estimates that human activities have already caused approximately 1.0°C of global warming above pre-industrial levels, and furthermore that global warming is likely to reach 1.5°C by as early as 2030 if it continues to increase at the current rate; and

WHEREAS,

Rapid reductions in greenhouse gas emissions across all sectors of our society--particularly CO2 emission reductions to 40-60% below 2010 levels by 2030, and net zero by 2050--are necessary in order to limit global warming to within 1.5°C and thereby significantly reduce the risks and impacts of climate change; and

WHEREAS,

School activities such as transporting students, heating buildings and water, and employee commuting contribute to climate change because they create greenhouse gas emissions; however, schools vary widely in terms of the resources, including funding, staffing and expertise that they have available to achieve net zero emissions; now, therefore, be it

RESOLVED.

That California State PTA and its units, councils and districts support legislation, regulations and/or other measures that would educate communities about the hazards to children and direct schools to inventory their current greenhouse gas emissions, then plan for and implement greenhouse gas emission reductions at the rate required (or faster) to limit global warming to within 1.5°C of average pre-industrial temperatures; and be it further

RESOLVED,

That California State PTA and its units, councils and districts support legislation, regulations and/or other measures to identify resources needed to address financial and other constraints that may hinder the planning and implementation of greenhouse gas emission reductions at schools throughout the state; and be it further

RESOLVED,

That California State PTA and its units, councils, and districts urge legislators and other decision-makers to invest in greenhouse gas emission reductions by schools; however, these investments should NOT be offset by, or at the expense of, reductions in state or local in K-12 education, higher education, nutrition, health care, or other programs that improve the lives and prospects of children and youth; and be it further

RESOLVED.

That California State PTA, its units, councils and districts, urge schools to ensure that greenhouse gas emission reduction measures undertaken at school sites serve to reduce the emissions of their broader communities where possible (for example, by making electric vehicle charging infrastructure installed in publicly accessible areas of school sites available for public use outside of school hours).

#### BACKGROUND SUMMARY

Our children are most vulnerable to the hazards of climate change. In 2015, California State PTA adopted a resolution entitled "Climate Change is a Children's Issue," that urged "school districts to support programs and strategies to make schools more climate-safe and energy efficient models."

Research published over the ensuing 5 years shows how urgently we must act. Most notable is the 2018 report of the Intergovernmental Panel on Climate Change, which projects with high confidence that the risks and impacts of climate change can be significantly reduced if, by 2030, global net CO<sub>2</sub> emissions from human activities decline by about 45% from 2010 levels, and then reach net zero by around 2050. Achieving emission reductions at this scale and speed requires participation from all sectors of our society. As institutions focused on improving the well-being of children, schools have a particular opportunity to participate in and even lead these efforts.

This resolution seeks to engage PTA members, and their communities, in a concerted effort to advocate for and encourage school efforts to reduce their greenhouse gas emissions at the rate required to safeguard the futures of our children and generations to come. California has existing laws, resources and guidance in place to help schools do this, and potential funding is also available. Program examples include the US Department of Education's Green Ribbon Schools program and the California Air Resource Board's "Cool California" website. Both facilitate local schools' ability to inventory their greenhouse gas emissions and then develop emission reduction plans that align with local circumstances and possibilities. Programs like these are a great starting point, but we must make faster and more widespread progress.

In practice, greenhouse gas emission reductions at schools are likely to come from two main areas. First, California's largest single category of greenhouse gas emissions is fossil fuel combustion to power on-road transportation (cars, buses and trucks). Schools contribute to such emissions both through transporting students (over 250 million school bus miles are traveled annually statewide) and through employee commuting by over 500,000 teachers and other employees. The second area is emissions from the buildings at over 10,000 schools statewide (typically through natural gas combustion for water heating and space heating). Many climate change mitigations involving buildings and transportation are viable today, and in many cases are more cost-effective than 'business as usual.'

#### Net Zero Emission Schools - continued

Finally, any realistic effort to address greenhouse gas emissions at schools throughout California must also provide the support needed to address the resource constraints - including funding, staffing, information and expertise - that many schools need to address in order to successfully plan and implement greenhouse gas emission reductions. Some schools have already made notable progress, and highlighting their successes and 'lessons learned' can help others who are at earlier stages in their journey to achieving net zero emissions.

Recommendations for Moving Forward TY OF TO MEEMA With PWP's Planning Process

## Observations/Conclusions From our Participation in the IRP Process

What conclusion does it appear that PWP hopes the City Council will reach after receiving the IRP memo? — that the City Council resolution to achieve 100% carbon-free power by 2030 is impractical and too expensive. We do not agree.

Instead of striving to develop a workable plan to align with the Council's mandate for carbon-free power, PWP has spent the city's time and money on an effort to justify NOT doing what the Council has asked them to do. Their analysis reflects an "all-or-nothing" approach that gold plates renewable investment requirements, disrespects the role that private/residential generators can play, ignores the rising cost of natural gas, and is seemingly unaware of what other US cities are doing to become carbon-free.

The scenarios that were examined in the IRP were structured to show the maximum infrastructure cost to achieve carbon-free power, under a set of extreme and unrealistic constraints. As STAG participants, we were not able to persuade PWP to examine scenarios that would more closely align with a workable plan, and more realistic electricity rate impacts.

For example, the IRP examined how heat waves and connectivity disruptions would impact each of the carbon-free scenarios, requiring an over-build of renewable resources. Yet disruptions in the gas supply to the Glenarm plant and prolonged gas prices, which might well last for years rather than a month and would demonstrate the cost and risk associated with continued reliance on fossil fuels, were ignored.

Another example is that PWP insists on treating the cost of installing rooftop solar on private property as if it is paid for by ratepayers, instead of by property owners. This inflates the cost of 2 of the 3 carbon free scenarios. PWP acknowledged this at STAG meetings and promised to clarify this point to the City Council and the public. But the current PWP memo *continues* to include these costs in those scenarios as if ratepayers will bear these costs.

After casting the carbon-free scenarios in an expensive light, PWP seems unwilling to examine how the operation of the Glenarm plant might be eliminated from their future plans.

As such, we are now convinced that PWP does not want to put forth a good-faith effort to respond to the City Council's policy goal. Where do we go from here?

#### Pasadena 100 Recommends 10 Steps to City Council

- 1. **Direct PWP to present a real plan by March 2024** that examines the most probable impacts on Pasadena's electricity rates. This will require public input and oversight. There are important factors that must be addressed [See Appendix A]. This work has not yet been done; the scenarios that were modeled were exercises not plans.
- 2. Mandate the curtailment of Glenarm operations with a planned closure timeframe ending in Dec. 2030. In the meantime, develop an operating regime that minimizes the use of Glenarm. Begin analysis of the best use of this property. Assure safety and freedom from risk of gas leaks to neighborhoods and Blair High School.
- 3. Mandate the immediate acquisition of a minimum of 100MW of battery storage. All scenarios require substantial storage be in place by 2025. The current 25MW procurement initiative is inadequate. Pilot new storage technologies including Long Duration Storage with federal IRA funding.
- 4. Commit to at least double rooftop solar by 2030 on residential, commercial, and municipal structures to add resilience and electricity supply. The scenarios show that we will likely a require massive amount in Pasadena. Achieve this through an education, marketing, and incentive campaign. Conduct an audit of city properties amenable to rooftop solar and set a good example. Pilot community solar in a business district and in a low-income district using federal IRA funds and private sector contributions. Businesses can achieve savings from community solar. Investments in these assets by private businesses and residents will mitigate PWP electricity rate increases and reduce load.
- 5. Revise time-of-use (TOU) electricity rates to make them effective demand reduction tools as well as a mechanism for people to reduce their bills. Make it easy for ratepayers to learn about TOU; Right now, TOU info is hard to find on the PWP website. And the TOU rates are not attractive. Our community must be educated about the true costs of power it's more expensive in the evening. Residents can help to reduce the amount of new infrastructure required to store renewable power and maintain resource adequacy. Changing our behaviour when we choose to charge EVs, run pool pumps/AC, etc. will mitigate rate increases.
- 6. **Mandate the cancelation of Magnolia by 2030**. Under no scenario should we continue to maintain a fossil-based contract.
- 7. Show true concern for Pasadena's low disadvantaged and unhoused communities by offering more than a token \$10/month rate discount, by implementing community solar and by integrating workforce development programs with our accelerated transition to clean electric power. Use federal funding dedicated to low-income communities.
- 8. **Ensure current PWP leadership is aligned with these efforts.** Successful change requires an aligned team let's make sure we have PWP leaders working for us that are committed to a carbon-free future for our city.
- 9. **Accountability, metrics for success and transparency** are essential. At least quarterly reporting to the EAC and the City Council should be mandated.
- 10. Affirm Resolution 9977 explicitly in the IRP. Commit to best efforts to achieve success.

## Appendix A: Considerations for a Realistic Plan to Meet Council Resolution for 100% Carbon-Free Power by 2030

#### Factors to be considered in the Plan:

- a) Extract maximum value from built assets and PPA agreements. This includes revenue generation from fulfillment of load and regulation contracts with CAISO. Pasadena battery storage assets will be highly valued.
- b) Consultation with other CA planning jurisdictions that are ahead of Pasadena. What are they learning about renewable/battery pairing? What are other lessons learned? Consultation with NREL and the entities devoted to using new energy technologies.
- c) Consultation with neighboring POU's to explore joint investment opportunities and interest. Explore ways grid interconnection can benefit. Evaluate collaboration in storage and DER and well as the economic value of these assets.
- d) Options for curtailment of Glenarm operations for all situations. Evaluate best land use.
- e) Consideration of consumer rate impacts. The percentage cost impact identified in the IRP would affect only a portion of the overall consumer rate. In the case of DER costs identified in the IRP, a large proportion of these may not affect electricity rates at all. Let's be very clear about rate impacts so we can make good decisions.
- f) Consideration of consumer rate impacts if gas prices remain higher for longer (e.g., 50% higher for a period of several years).
- g) Explore the optimum mix of renewables. The scenario assumptions produced mostly solar, mostly-wind outcomes. What is the optimal mix of resources to ensure price/performance resiliency? Why fuel cells?
- h) Further exploration of Goodrich upgrade options, timelines, benefits/costs. Why not accelerate so that we can import more renewably generated electricity if that is the most effective resource.
- i) How to make DER and Time of Use options for ratepayers easy for Pasadena residents and businesses to use. Employ User Experience discipline and focus groups.
- j) Develop more precise metrics on the acreage available for storage and DER.
- k) Find out the penalties (if any) for Magnolia termination by 2030. Collaborate with neighboring cities that may also wish to terminate.
