

RE: Agenda Item 2. Adoption and Approval of 2023 IRP

In the final slide for their presentation, PWP requests that City Council support the policy goal of 100% carbon-free by 2030 through utilization of the **Waypoint framework** supported by 2023 IRP Scenario 2 modeling results. Although PWP's Agenda Report dated December 4, 2023 devotes virtually half (3 out of 7 pages) to repetitive mentions of "Waypoint", neither the methodology nor its actual incorporation into the 2023 IRP are explained. There is vague reference to "Critical Path" but no attempt at critical path analysis aside from comments in *Item 1 ~ PWP 2023 Supply Chain Issues* regarding increased lead times for procurement and contracts.

PWP Slide 8 is identical to IRP Figure 209 Implementation Timeline. This table lists many proposed actions but fails to connect tasks which constitute "Critical Path" to achieve the stated goal of carbon-free by 2023: Distributed Energy Resources, Local Battery Storage and Community Solar. The following table is based on Figure 209, presenting these key tasks according to PWP's stated timeline.

PWP's leisurely implementation timeline does not reflect any urgency. In fact, it would likely result in PWP's failure to achieve significant goals by 2028 when nothing is scheduled.

Distributed Energy Resources (DERs) – Costs for Scenario 2 are inflated by false assumptions about rooftop solar which is paid for by private property owners. At the MSC Meeting October 10, a representative of Pasadena Unified School District stated that many PUSD roofs would be eligible for rooftop solar installation; this is not mentioned.

• Study Expansion and Identify Potential Projects are two parts of the same task which should be carried out in 2024 so that PWP would be ready to Seek Pilot Programs by 2025.

Local Battery Storage - Slides for MSC Item 1 identify Transformer Shortage as an Overall Major Risk with potential impact on Battery Energy Storage ("BESS") project. Scenario 2 includes a total of 665 MW of battery storage. Only 105 MW of battery storage are currently available: 85 MW to be added in 2023 and 20 MW to be added in 2027. Consultants E3 note PWP's reliance on Energy Storage, especially in Scenario 2 (see E3 Slide page 50). PWP should quickly acquire a minimum of 100MW of battery storage. All scenarios require that substantial storage be in place by 2025. The current 25MW procurement initiative is inadequate. Increase storage over the next 4-5 years, piloting new storage technologies including Long Duration Storage with federal IRA funding.

• Local Projects and Seek Additional Sites should both be completed in 2024 to account for supply chain issues that could affect additional projects and heavy reliance on energy storage to meet goals.

Community Solar - Slide13 for MSC Item 1. Includes Government Incentives: "The availability and extent of government incentives, subsidies or tax credits can impact the overall cost of renewable energy contracts. In some cases, these incentives can offset high upfront costs." However, there is virtually no mention of participation in the Inflation Reduction Act which could reduce costs. The 2023 IRP does not mention any active applications for federal grant programs although PWP filed a Notice of Intent to apply for Greenhouse Gas Reduction Funds. Also unmentioned are eligible areas for Justice40 Disadvantaged Community (DAC) funds in portions of Council Districts 1, 3 and 5.

• Evaluate Community Solar and Identify Potential Projects should be performed simultaneously in 2024 so that PWP is ready to implement a Community Solar Program in 2025.

PWP's ambivalence to meeting the goal of carbon-free electricity by 2030 as mandated by City Council Resolution 9977 is demonstrated in *Appendix 28: [DRAFT] Renewable Portfolio Standard Procurement Plan.* "Though the SB100 mandates require POUs to procure 60% of their retail needs through renewable power by 2030, PWP must strike a balance of meeting this need while being mindful of its cost, reliability and sustainability obligations and proprieties. Over or under procuring renewable energy in comparison to requirements come with risks and opportunities" (page 269 of 297).

Figure 4: PWP SB 100 Procurement Plan from 2023 IRP projects retail sales for Compliance Periods 4 (2021-24), 5 (2025-27) and 6 (2028-30). Projected Retail Sales for CP-4 are based on actual sales. With no explanation, the projected load forecast for CP-5 increases dramatically with an average annual increase of 18.3% for the three years between 2024 and 2027. The projected load forecast for CP-6 then drops to an average annual increase of only 1.5%, virtually flat for the three years between 2027 and 2030, again with no explanation.

My name is Sam Berndt.

At the October 17th MSC meeting, PWP was directed to come back with a plan to get to 2030, with a waypoint set up along the way.

Instead, what we see before us, is a plan to get to 55% carbon free by 2028, and a plan that will make it logistically infeasible to get to 2030.

According to the Waypoint Framework which follows Scenario 2 over the next 5 years, PWP will seek to acquire 300MW of carbon free resources. Then, in 2028, PWP will "reassess" the feasibility of the 2030 plan. At that time, they will see that to complete Scenario 2, they will need to acquire an additional 1,015 MW of carbon free resources in two years.

You do not need to be a power supply expert to know that backloading 3x the amount of resources to procure in ½ the amount of time is a plan that is not set up for success. If they wanted this to be successful, they would plan for 2030 and attempt to procure an equal amount of resources each year until then, not wait until the last minute to "suddenly realize" they didn't plan ahead.

What is ironic about this, is that PWP claims that this is the most ambitious plan, but in reality Scenario 2 has the second least amount of carbon free resources in 2028. [[[In fact, if PWP came back with the same plan they had last time, Scenario 4, in 2028 they would have 22% more carbon free resources than what they are proposing. Scenario 5, the scenario that takes into consideration the social cost of carbon has more than 2x the amount of carbon free resources by 2028]]]

Now, if you really want to see PWP's intentions, you would go to the very back of their submitted document and look at their Renewable Portfolio Standard Procurement Plan. In there, you will see that they only plan to meet the state mandates of 60% renewable by 2030, and 100% renewable by 2045.

PWP is playing us all for fools.

There is nowhere in the document that shows they are planning on getting to 100% carbon free by 2030.

The underlying flaw in all of this is that PWP set a plan for 2028, not for 2030. Setting a plan for 2030 would allow them to make all of the considerations necessary to actually achieve the goal.

I urge the MSC to send PWP back to the drawing board to redraft the Renewable Portfolio Standard Procurement Plan and create a plan in the IRP that will get us to 100% carbon free electricity by 2030.
