Mark Jomsky, City Clerk, reported that public comment is limited to items on this special meeting agenda.

OLD BUSINESS

ADOPTION OF THE REVISED 2022 EARLY CHILD DEVELOPMENT POLICY (To be heard at 4:30 p.m., or thereafter) Recommendation: It is recommended that the City Council:

- (1) Find that the proposed Revised Early Child Development Policy is not a "project" under the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15378;
- (2) Adopt the Revised 2022 Early Child Development Policy attached to the agenda report; and
- (3) Direct the City Manager to return during the first quarter of 2023 with recommendations for the implementation of key initial activities and areas of recommendation contained within the Revised 2022 Early Child Development Policy.

Dr. Vera Vignes, Chair of the Early Child Development & Early Learning Task Force, and Pat Bowie, consultant, provided a PowerPoint presentation on the agenda item, and responded to questions.

Councilmember Hampton expressed his thanks and appreciation to the Task Force for the report; stated his support for the "Welcome Baby" Campaign for families with newborns in Pasadena as a key initial activity; spoke on the importance of early child development and noted that he anticipates further discussion/exploration on creating a meaningful partnership with PUSD and possibly other independent schools to assist with the support of this program.

Councilmember Masuda spoke on the importance of early child development and expressed his support for the policy.

Mayor Gordo asked the City Manager to reach out to PUSD and request that they bring forward a report to the City Council on Measure I and J funding.

Councilmember Wilson stated his support for further exploration and collaboration with PUSD, and that he feels this is a great pilot program for the City and PUSD to collaborate on; requested further information and data on the "Birth to 5 years of age population", asking the Task Force to provide this to the Council; and thanked the Task Force for their work.

Mayor Gordo congratulated the Task Force for bringing forward a policy that is achievable, establishes milestones and measuring progress; suggested using heat maps by census tract to help better understand "Birth to 5 years of age population" demographic; spoke on Key Initial Activities No. 2, requesting that the Task Force consider including an advisory body that might provide feedback to the City Council on a more regular basis; and suggested as part of

the Early Development Instrument/Index (EDI) data collection, City staff should reach out to the Board of Supervisors Office and the Los Angeles County to further explore opportunities for measuring PUSD boundaries beyond the City's boundaries (e.g. Altadena), for more accurate reporting, noting that this is consistent with the City's effort to collaborate with PUSD.
