As Executive Director of Pasadena Audubon, I am reaching out to ask that you please support a 100% Carbon Free Power by 2030 goal championed by the Pasadena 100 coalition, and unanimously supported by the Pasadena Unified School District Board of Directors, Pasadena City College Board of Trustees, and Pasadena Environmental Advisory Commission. Pasadena Audubon is an active participant on this coalition.

You may wonder what connection there is between birds and clean, carbon-free power. Put simply, climate change represents the biggest current threat to bird populations. A quickly changing climate interferes with ecological relationships, for example, changing the moment when insect populations rise in the Arctic, where many of our local birds migrate to breed. If the insects are not present when the birds arrive en masse, they will not be able to feed their young. It is incumbent upon us to do all we can to limit these potentially catastrophic effects which will ripple through the natural world exacerbating the biodiversity loss crisis that we are already witnessing.

Only clean, carbon-free power will guarantee Pasadena does its part to address the climate emergency. Per the most recent public data, Pasadena remains almost 50% powered by coal, the dirtiest fossil fuel. Statewide the average is 3%. As a result of our use of so much dirty power Pasadena produces more than double the GHG emissions per kilowatt hour than the rest of the state.

I urge you to join our neighbors in Sierra Madre, South Pasadena, and elsewhere in adopting a goal of 100% Carbon Free Power by 2030, the goal championed by the Pasadena 100 coalition.
