It would be such a bad look for the City to take extreme and barbaric action instead of attempting non-lethal methods that wildlife experts say are the only effective approach. I also imagine there will be protests, can envision Rose Parade disruptions, etc., none of which the city needs.

Moreover, the cruelty of snares is incalculable. I can't even imagine the pain and fear of an animal after being trapped, and surely that panic is something they feel as acutely as any person would. We should peacefully co-exist with the wildlife we are lucky enough to live nearby and if any action is deemed necessary it should be centered on removing the attractants (trash, outdoor cats) that lure coyotes into neighborhoods.

Dear City Leaders,

As a filmmaker who has done documentaries related to this subject, I can tell you that trapping and killing coyotes is not only cruel and self-destructive at a time when we are in the midst of the 6th mass extinction of wildlife, it is also completely unnecessary. A coyote sighting is not a coyote problem.

There are many effective ways to make sure coyotes co-exist without any issues. I have documented how, for example, coyote rollers effectively prevent the animals from scaling a perimeter wall. And, of course, coyote-proof garbage cans and the removal of food, like fruit that's fallen from trees, etc., is crucial and baseline. It also has the added benefit of managing the rat population.

Trapping poses a real threat to the dogs who often run the the same areas and can be maimed. Children can also be running around and playing in the brush and can get their limbs caught in the traps. That presents the city with a potential legal problem as well.

Fundamentally, trapping and killing is, at best, a 19th century reaction to what is a 21st century situation. The people of Pasadena are sophisticated and evolved. They don't need to resort to primitive responses that are best tossed in the trash bin of history.
