AUTHORIZATION TO AMEND CONTRACT NO. 31342 WITH HERITAGE CLINIC TO EXTEND THE TERM AND INCREASE THE TOTAL NOT-TO-EXCEED AMOUNT BY \$1,031,000 AND ISSUE SIX PURCHASE ORDERS TO EXTEND EXISTING SERVICES TOTALING \$406,000 FOR THE TRANSITIONAL AGE YOUTH (TAY) LINK AND GERIATRIC EMPOWERMENT MODEL (GEM) LINK PROGRAMS (Health Dept.)

Recommendation: It is recommended that the City Council:

- (1) Find that the proposed action in the agenda report is not a project subject to the California Environmental Quality Act (CEQA) pursuant to Section 21065 of CEQA and Sections 15060(c)(2), 15060(c)(3), and 15378 of the State CEQA Guidelines, and as such, no environmental document pursuant to CEQA is required for the project;
- (2) Authorize the City Manager to amend Contract No. 31342 with Heritage Clinic Inc., to increase the not-to-exceed amount by \$1,031,000 from \$2,361,800 to a revised amount of \$3,392,800 and extend the term through December 31, 2024 for case management, housing navigation, and outreach services; (Contract No. 31342-4)

- (3) Authorize the City Manager to issue purchase orders to extend existing services with the following organizations through June 30, 2024:
 - a. Ace Construction and Maintenance Inc., for an additional amount not-to-exceed \$50,000 in Fiscal Year ("FY") 2024 for a grand total of \$105,400 for facility maintenance and repair services;
 - b. Acme Auto Leasing, LLC for an additional amount not-toexceed \$25,000 in FY2024 for a grand total of \$98,572 for vehicle leases:
 - c. LivHome Inc. (DBA Arosa), f or an additional amount not-to-exceed \$96,000 in FY2024 for a grand total of \$189,483 for homemaker services;
 - d. Select Patrol Agency Inc., for an additional amount not-toexceed \$82,000 in FY2024 for a grand total of \$337,527 for security services; and
 - e. William Scotsman Inc., for an additional amount not-toexceed \$75,000 in FY2024 for a grand total of \$140,445 for modular office trailer lease;
- (4) Authorize the City Manager to issue a purchase order with Bethel Missionary Baptist Church Inc., for an additional amount not-to-exceed \$78,000 in FY2024 for a grand total of \$133,000 for leased office space and to grant an exemption for competitive bidding pursuant to City Charter Section 1002(E)(Contracts relating to the acquisition of real property); and
- (5) To the extent these actions could be considered separate procurements subject to the Competitive Selection Process, it is recommended that the City Council grant exemptions pursuant to Pasadena Municipal Code (PMC) Section 4.08.049(B), contracts for which the City's best interests are served.

CONTRACT AWARD TO FLOCK GROUP INC., FOR THE LEASING AND INSTALLTION OF FIXED AUTOMATED LICENSE PLATE READER CAMERA SYSTEM FOR AN AMOUNT NOT-TO-EXCEED \$631,350 AND AMENDMENT TO THE FISCAL YEAR 2024 CAPITAL IMPROVEMENT PROGRAM BUDGET (Police Dept.)

Recommendation: It is recommended that the City Council:

- (1) Find that the project proposed in the agenda report is exempt under the California Environmental Quality Act (CEQA) Guidelines Section 15061(b)(3), the "Common-Sense" exemption that CEQA applies only to projects that may have an effect on the environment; (2) Accept the bid dated April 10, 2023, submitted by Flock Group Inc., in response to specifications for the leasing and installation of fixed automated license plate reader camera system in seventeen intersections; and authorize the City Manager to enter into a contract which includes the bid base price of \$326,350 and two one-year extensions for a not-to-exceed amount of \$631,350; and (Contract No. TBD)
- (3) Amend the Fiscal Year 2024 (FY24) Capital Improvement Program Budget by appropriating \$231,350 from the unappropriated fund balance in the Asset Forfeiture Fund 207 to the Installation of Automated License Plate Readers (75119) project to fully fund the lease purchase.

Mark Jomsky, City Clerk, reported that one letter in opposition to the staff recommendation was received by the City Clerk's Office, distributed to the City Council, posted on-line, and made part of the public record for this item.

Yadi, Pasadena resident, expressed concerns with the proposed contract award and urged the City Council and PPD to reduce

the retention period of records to protect those individuals seeking reproductive freedom.

Javier Aguilar, Acting Police Commander, briefly responded to questions from Councilmembers Rivas and Lyon, stating that any changes to the pilot program will be presented to the Public Safety Committee and City Council, confirmed data obtained in relation to this contract will not be shared to third parties outside of law enforcement that uses data in investigating crimes, and briefly noted the system's traceable audit trail capabilities.

It was moved by Councilmember Masuda, seconded by Vice Mayor Williams, to approve the staff recommendation. (<u>Motion unanimously approved</u>) (Absent: Councilmember Hampton)

REQUEST FOR DIRECTION TO RESPOND TO CONCERNS RELATED TO HUMAN-COYOTE INTERACTIONS (Public Health Dept.)

Recommendation: It is recommended that the City Council:

- (1) Find the proposed action in the agenda report is exempt from the California Environmental Quality Act (CEQA) in accordance with Section 15061(b)(3). The "Common-Sense" exemption states that CEQA only applies to projects that may have an effect on the environment; and
- (2) Provide direction on whether to initiate one of the identified options or an alternative option not presented in the agenda report.

Councilmember Madison spoke on the complexity of the issue. He urged everyone present to treat each other's opinions and concerns with respect, emphasizing the importance of finding effective solutions to enhance the understanding of the local coyote population, while also ensuring public safety.

Manual Carmona, Acting Director of Public Health, presented a PowerPoint presentation on the item and responded to questions.

Vice Mayor Williams stated her opposition to this matter appearing on the City Council agenda, noted her feelings towards coyote population control as animal cruelty, and stated she feels some of the options within the report are not consistent with the City's adopted Urban Wildlife Management Plan.

Councilmember Hampton arrived at 7:33 p.m.

Mayor Gordo, as Chair of the Public Safety Committee (PSC), summarized the Committee's discussion during the June 21, 2023 PSC meeting, which aimed to address the Committee's previous request for discussion that was made during the April 19, 2023 PSC meeting. The Committee recommended staff present their follow-up report to the full City Council due to the citywide implications.

Mark Jomsky, City Clerk, reported that for the Public Safety Committee meetings held on April 19, 2023 and June 21, 2023, the PSC received six letters advocating for the City to control coyote population and/or expressing concerns with the number of coyotes in the neighborhood; and two letters expressing concerns with the City adopting an Urban Wildlife Management Plan that could allow for the trapping and euthanizing of coyotes (4 Pasadena residents/4 residence not stated), which were distributed to the Committee, posted on-line, and made part of the public record for those items.

Additionally, City Clerk Jomsky reported that the City Clerk's Office received correspondence for the July 17, 2023 meeting as follows: 73 letters in opposition to and/or expressing concerns with the City adopting an Urban Wildlife Management Plan that allows the trapping and euthanizing of coyotes in the City; and 36 letters in support of Option # 3 of the staff recommendation and/or in opposition to trapping & euthanizing coyotes; four letters advocating for the City to trap and transport coyotes to alternate wildlife areas and/or supporting humane measures to reduce coyote interactions with people and pets; and two letters advocating for the City to trap and euthanize those coyotes that are considered problematic animals in the City (25 Pasadena residents; 21 Non-residents; 63 residence not stated; and 6 from Organizations), with all correspondence received having been distributed to the City Council, posted on-line, and made part of the public record for this item

Councilmember Lyon thanked Acting Director Carmona for the comprehensive report and the public speakers for their comments. He recognized that tonight's discussion has made it evident that this is a matter people genuinely care about. He emphasized the need to continue to empower residents through education and information on dealing with coyote interactions, and the need for continuing the conversation on the matter. Councilmember Lyon made a motion for staff to initiate Option 3, which includes the following recommended actions (outlined on page 8 of the agenda report):

- 1. Increase public outreach services.
- 2. Improve local coyote reporting systems.
- 3. Convene a panel of coyote experts to improve our collective understanding of effective approaches.
- 4. Hire a consultant to conduct a field study where community concerns are heightened.
- 5. Support residents to strengthen their properties against coyote intrusion.

Councilmember Madison voiced his support for Option 3; he emphasized that the purpose of the conversation was to address all community concerns regarding the increase in sightings of coyotes and the potential risks to the safety of the community, and stated that he believes the overall conversation was beneficial for everyone. He suggested that the City's Public Health Department form a liaison with California Fish and Wildlife agency on this issue. Furthermore, he stated that the personal and political attacks by members of the PETA organization were unnecessary and uncalled for.

Councilmember Hampton voiced his support for Option 3 and inquired about the impacts of neutering coyotes would have on their population.

Manuel Carmona, Acting Director of Public Health, stated he would further seek additional information from CA Fish and Wildlife regarding the effects of neutering coyotes, as well as questions related to natural predators for coyote. Vice Mayor Williams thanked the public speakers for their comments. She voiced her support for Option 3, and requested the maker of the motion amend the recommendation in a way that specifically addresses the impacts in the Arroyo, utilizing the Arroyos and Foothills Conservancy (AFC) data and expertise to develop solutions that are tailored to the Arroyo within the AFC study area and neighboring residence.

Councilmember Madison (as the seconder of the motion) stated he does not support Vice Mayor's request to amend the motion, as detailed above.

Manual Carmona, Acting Director of Public Health, acknowledged Vice Mayor Williams comments and stated that staff would be utilizing geographical analysis to identify areas of concerns. As the City and staff gain further understanding of the local coyote population, he expects that hotspots will become evident in the community based on complaints and concerns, which will in turn require and gain attention.

In response to Mayor Gordo comments on collaborating with the San Gabriel Valley Council of Governments' (SGVCOG) Coyote Management Task Force and other local agencies on the issue of coyotes and public safety, it was agreed that staff would initiate discussions and work with other local agencies, stakeholders, and cities on the issue of coyotes and wildlife safety.

It was moved by Councilmember Lyon, seconded by Councilmember Madison, to approve the staff recommendation and direct staff to implement Option No. 3 (incorporating the five recommendations on page 8 of the staff report, and as noted above), as well as direct City staff to initiate discussions and work with other local agencies, stakeholders, and cities on the issue of coyotes and wildlife safety. (Motion unanimously approved) (Absent: None)
