The 710 Stub task force needs to take the time to explore an iterative, integrated design process for the recapture of the freeway stub into the urban fabric. Typical public decision-making processes do not allow for the kind of creative, iterative process that good urban design requires, so it will be up to the task force to be an appropriate sounding board for City staff and consultants who will develop the plans, helping shape the design process in a way that is reflective of larger constituencies in the City.

The 710 stub recapture is a once-in-a-lifetime opportunity for the City of Pasadena. Many demands will be made upon what should go there. 
