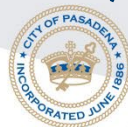

Working Group Appointees

At its Meeting of February 27th, the Council Appointed Members to the Working Group.

Given the citywide importance of the Working Group, the Council directed staff to identify potential gaps within the Group that could be filled by At-Large Members.



Working Group Roles

OFFICE OF THE CITY MANAGER

The Reconnecting Communities WG:

- The working group will provide input to the City Council on the vision, land use, massing, circulation, and other urban design aspects of the plan, as well as other key policy issues, including potential restorative justice efforts relating to the displacement caused by the proposed freeway expansion.



Reconnecting Communities

The composition of the working group should be diverse and *reflective of the entire City and may be appointed in consideration* of a background in Planning, Economic Development/Real Estate/Housing Development, Transportation, Historic Preservation, Engineering, Community Advocacy, or other related area of expertise.



Membership Composition

- Each Councilmember will appoint 1 member;
- The Mayor will appoint 2 members;
- The City Council as a body will appoint 4 at-large members (total of 13);
- Two of the 13 members shall be descendants of community members that were displaced due to freeway expansion; and

Membership Composition

The appointed members represent a broad cross-section of the community members. While the appointed members have a breadth of professional and volunteer experience, they broadly fall into a few categories:

- Community Advocacy/Engagement;
- Real Estate Development/Advisor;
- Housing Production/Affordable Housing;
- Architect; and
- City Governance



At-Large Considerations

OFFICE OF THE CITY MANAGER

Of the 9 appointed members:

- 6 have self-identified as male and 3 female;
- 4 have self-identified White/Caucasian, 3 as African American, 1 as Asian American, and 1 of Iranian descent;
- None of the 9 appointed members have identified as being displaced or a descendant of a displaced community member;
- None of the 9 appointed members self-identified as Latino/a, even though the City is home to a significant Latina/o population; and
- None of the current appointees are under the age of 50.

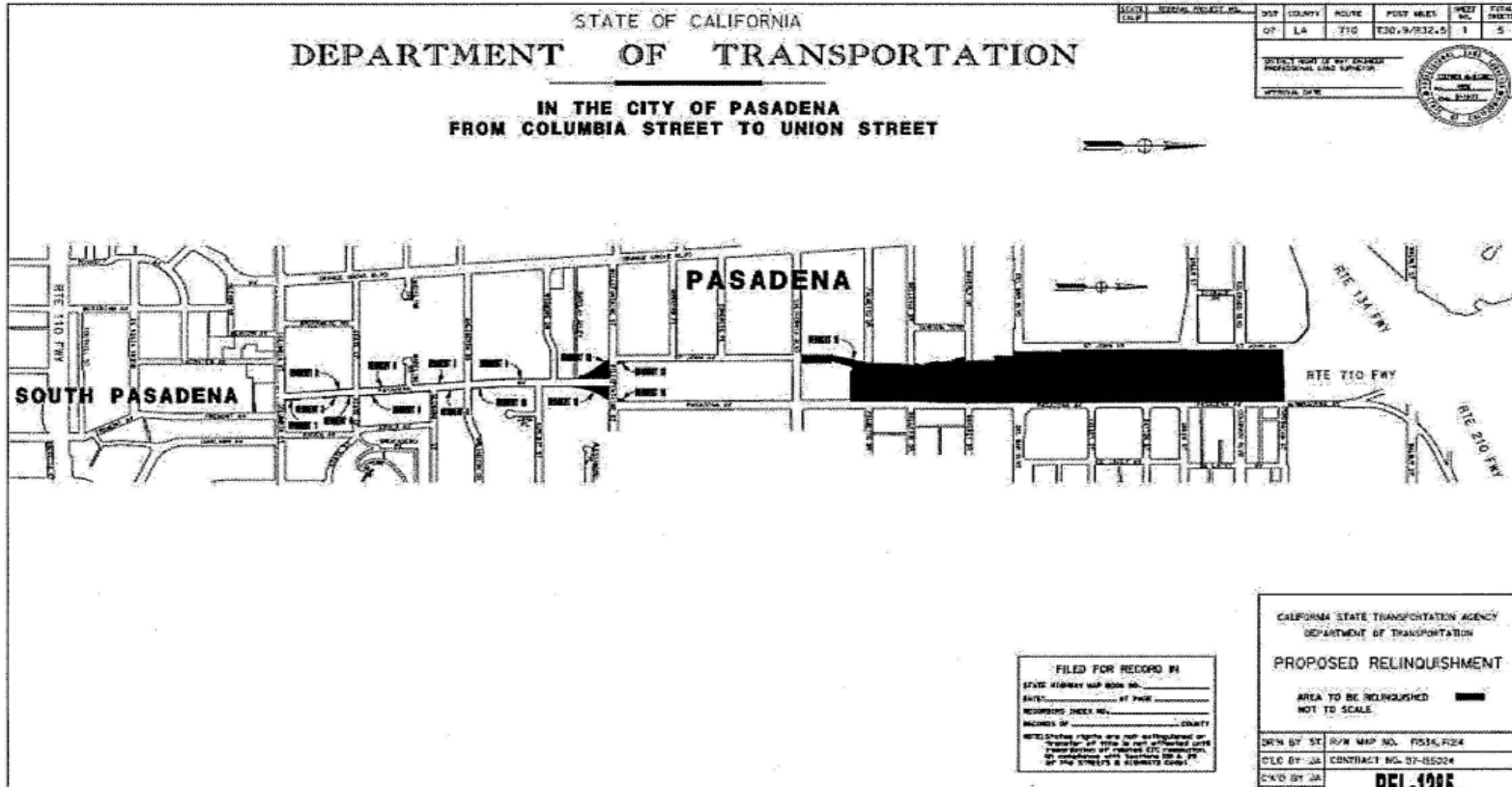
