CEREMONIAL MATTERS

Jens Weiden, Chief Executive Officer of the Rose Bowl, presented the Pasadena Unified School District with a \$5,000 check from the Rose Bowl Stadium & Legacy Foundation, and thanked the PUSD on their partnership at their annual Turkey Trot.

On behalf of PUSD, Michelle Richardson Bailey expressed her thanks and gratitude to the Rose Bowl and the Legacy Foundation for choosing PUSD as the recipient of the Turkey Trot's charitable donation. Mayor Gordo and Councilmember Madison expressed their appreciation to the Rose Bowl and Legacy Foundation for their great work.

Mayor Gordo presented a proclamation recognizing April 17, 2023 as "Arbor Day" in Pasadena, which was received by Tony Olmos, Director of Public Works, and Lola Osborne, Acting Director of Parks, Recreation, and Community Services. Mr. Olmos invited the Council and community to the City's Arbor Day Event scheduled for April 29, 2023 at Jefferson Recreation Center at 8:00 a.m.

Emina Darakjy, Street Tree Chairperson/Past President of Pasadena Beautiful, and Greg King, President of Pasadena Beautiful, announced that 28 Ficus trees have been planted recently on Green Street by the Pasadena Beautiful Foundation, and invited everyone to join in the Arbor Day Celebration.

Councilmember Hampton recognized City staff Kenneth Graham, Public Works Superintendent, and Michael King, Program Coordinator II, and expressed a special thanks to Emina Darakjy for her dedication to the City and for handpicking all the trees.

Councilmember Jones and Councilmember Hampton spoke on the passing of Jessica Springfield Valentine, long-time Pasadena resident, and active member of the community, and former City commissioner, and requested that the meeting be adjourned in her memory.

Mayor Gordo spoke in memory of Coach Enrique Reyes Cardenas, long-time Pasadena resident, and 29-year soccer coach at Villa Parke, and expressed condolences to his wife, children, and grandchildren, and requested that the meeting be adjourned in his memory as well.

Vice Mayor Williams and Councilmember Hampton, City-appointed members of the Burbank-Glendale-Pasadena Airport Authority, announced the Commission's unanimous selection of "The Icon" concept for the Terminal Replacement Project. Councilmember Madison expressed his gratitude to Vice Mayor Williams and Councilmember Hampton for their efforts and expressed his excitement for this milestone.

PUBLIC COMMENT ON MATTERS NOT ON THE AGENDA

Diane Reeves, Pasadena resident, urged the City of Pasadena to consider constructing a Sports Complex in the City, especially in advance to the 2028 Olympic Games, and recognized the many professional athletes that have come from Pasadena High Schools.

Mayor Gordo asked staff and the Finance Committee to further explore the potential for identifying infrastructure dollars for such an effort in advance of the 2028 Olympic.

Allan Shay, Pasadena resident, reiterated his request that the City Council review and discuss how the City is utilizing bodycam and other video sources as part of the investigative process for critical incidents, such as in the Anthony McClain case, and advocated for police accountability.

Olden Denham, Pasadena resident, spoke on the need for justice for Anthony McClain, as well as the need for accountability and transparency within the Pasadena Police Department (PPD).

Anonymous, residence not stated, thanked the PPD's Strategic Mental Health Division for their assistance when she called for help about her stranded vehicle.

J.D. Wood, representing Sports Facilities Companies, provided information on the business behind constructing sports facilities, and acknowledged his partnership with Ms. Reeves.

The following individuals spoke on the climate crisis and the synthesis report of the Intergovernmental Panel on Climate Change (IPCC) Sixth Assessment Report; and advocated for Pasadena to support Senate Bill (SB) 252 to mandate California Public Employees Retirement System (CalPERS) and the California State Teachers Retirement System (CalSTRS) refrain from investing in fossil fuel companies by 2030.

Cheryl Auger, Pasadena resident Susan Dembowski, Pasadena resident Melissa, Alhambra resident

Heavenly Hughes, representing My TRIBE Rise, congratulated Councilmember Rivas on the birth of her son, invited everyone to the 3rd Annual Dena Juneteenth Celebration on June 17, 2023; advocated for justice for Anthony McClain, and for the leaders of Pasadena to listen to the voices of the people.

Bert Newton, thanked the City Council for the consideration and care in appointing the Rental Board and urged the Council to not appoint Ahni Dodge, Simon Gibbons, and Tyler Werrin, who were plaintiffs in the lawsuit against Measure H.

In response to the public comment, Councilmember Madison, Chair of the Legislative Policy Committee, stated the Committee will review SB 252 and report back to the Council.

Michele Bagneris, City Attorney/City Prosecutor, made a brief announcement, that the Office of Independent Review (OIR) report regarding the Anthony McClain shooting has been completed, and that the City intends to release the report this week, which will include responses from the Pasadena Police Department.

ACCEPTANCE AND APPROVAL OF DONATION FROM PASADENA AMERICAN LITTLE LEAGUE TO BUILD A BATTING CAGE AT VICTORY PARK (Parks Recreation & Community Service Dept.)

Recommendation: It is recommended that the City Council:

- (1) Find that the project in the agenda report has been determined to be exempt from environmental review pursuant to the guidelines of the California Environmental Quality City Act (CEQA), Public Resources Code 21080(b)(9); Administrative Code, Title 14, Chapter 3, 15301 (Existing Facilities), and there are no features that distinguish this project from others in the exempt class; therefore, there are no unusual circumstances. Section 15301 exempts projects which involves negligible or no expansion use:
- (2) Accept a donation from Pasadena American Little League (PALL) to build batting cage at Victory Park; and
- (3) Authorize the City Manager to enter into a labor and material contract with Pasadena American Little League to construct a batting cage adjacent to Diamond 2 at Victory Park. (Contract No. 23,839)

Mayor Gordo congratulated and thanked Pasadena American Little League for their contribution to build a new batting cage.

Vice Mayor Williams asked the City Manger to review the policy and process in place for accepting donations from private and non-profit entities.

- (1) Find that the proposed action of naming a City park not a "project" as defined in the California Environmental Quality Act (CEQA), Public Resources Code Section 21065 and Section 15378(b)(4) and (5) of the State CEQA Guidelines, and as such, is not subject to environmental review; and
- (2) Approve that the new park located at 1410 Wierfield Drive be named "Annandale Canyon Nature Preserve" and the associated trail be named "Yayaaytnga Trail."
