Most of my professional career has been spent on organizing and civic engagement. I have spent years speaking to residents and educating them on laws/policies in Los Angeles. At my current job, I analyze bills and support policies that fall under my organization's focus areas. I have a background working with diverse populations and informing them that they play a role in decision-making. Here in Pasadena, I spent months educating residents in both Spanish and English on the proposed Charter Amendment around Rent Control. The perspective I bring is this ground-level resident experience and reacting to policies/laws.

7. What objectives and goals should the Charter Study Task Force consider?

The Charter Study Task Force should consider the goals of Public Engagement, Stakeholder Engagement, and Transparency. Public Engagement is the main priority, soliciting input from residents, local organizations, and stakeholders. The city is accountable and able to work because of residents; we need to prioritize them in the charter study process. The Task Force should be open to publicly suggested topics for its scope that thev could recommend to the city council. Stakeholder engagement, working closely with city officials, legal experts, local organizations, and advocacy groups. Seek their input and expertise to ensure a well-rounded perspective on the charter study. Lastly, maintain high transparency, keep the public informed, and ensure decisions are made openly.

8. In your opinion, what is the importance of the scope and charge of the Charter Study Task Force, as approved and assigned by the City Council?

The Task Force will review possible charter amendments, this should be conducted through thorough research, and gathering relevant data to inform the charter study will be critical for this work. One item on the current scope could take months to discuss, and they are topics that could see significant change for residents and how the city works. Reviewing the existing charter will be necessary, as abiding by legal requirements, looking at best practices from other municipalities, and input from city experts. The task force's work is to lead this conversation and help the city council/voters make informed decisions.

9. How would you help to achieve the Charter Study Task Force's objectives and goals while adhering to the City Council's approved Scope and Charge?

In my professional career, I have worked in 3 different state coalitions working towards transformational social equity models and systems to service the BIPOC communities. While in my sorority, we went through a similar charter process. I supported the national Greek organization through objectives and goals that had lingering effects on the organization and thus voted for by its members. Based on my past experiences and work during Measure H – Rent Control Campaign, I find that I bring a voice to my community and those with similar experiences and backgrounds to me. I will hold myself accountable to continuously assess the task force's activities to ensure they align with the approved Scope and Charge while being adaptable and responsive to this city's changing circumstances and needs.
